- 1. Did Mr Murray complete a Meeting Disclosure Form for the meeting held with Minister Haylen on 4 April 2023?
- 2. Please provide a copy of the form.
- 3. Please provide copies of any emails or text messages relating to the meeting between Mr Murray and Minister Haylen on 4 April 2023.
- 4. What role did you play in developing the scenario for the assessment process?
- 5. Did you discuss this scenario with Mr Murray?
- 6. Who is the more senior minister, Minister Graham or Minister Haylen?
- 7. To which ministers is Transport for NSW responsible?
- 8. Did you pay for a ticket for Mr Llew Gartrell, General Manager, Government Relations, Stockland, to attend an election fund raising event for Minister Haylen?
- 9. Please provide a list of the Minister for Transport's appointments from 9 am to 5.45 pm on Thursday 31 August 2023.
- 10. On what date did you telephone Mr Murray and leave a message for him regarding his application for the position of Secretary?
- 11. What was the content of the message?

- 12. Please provide copies of texts showing you sent the job application link to two persons other than Josh Murray with names and phone numbers of those persons redacted.
- 13. In your evidence you state that "we certainly went through the Q&A with" the Minister for Transport. Did the Minister raise any objection or seek any clarification of the references in the Q and A to the Minister making "the final choice"; "I choose Josh Murray"; "candidates for the Minister to choose from"; "the Minister was then asked by the panel chair to interview the final two candidates and make the final decision"?
- 14. Is it your understanding that the Minister for Transport made the final decision to appoint Mr Murray?
- 15. When did you tell the Minister for Transport that Mr Murray had applied for the position?
- 16. Did you discuss other applicants with the Minister for Transport prior to 28 June 2023?
- 17. Did the Minister express a view on Mr Murray or any other applicants prior to 28 June 2023?
- 18. In a text Mr Murray sent to you at 7.03 pm on Monday 10 July 2023 he said "Apologies just on a call. Can I try you back shortly". Did Mr Murray call you back on the evening of Monday 10 July 2023? If so, what did you discuss in that phone conversation?
