## SUPPLEMENTARY QUESTIONS

**QUESTION:**

**1. Please list every professional services engagement undertaken since 2017. In your answers, please detail:**

- the agency or individual engaged,
- the details of the work requested for each engagement,
- the details of the work undertaken for each engagement,
- the tendering process for the engagement,
- which other agencies were approached for a quote or tender for each engagement,
- the initial value of the engagement,
- the contract period relating to the engagement, and whether the engagement period was extended. If the engagement was extended, the additional length of that engagement as a result of the extension and the additional value of each subsequent extension,
- the total value of the engagement, and
- whether a post-engagement evaluation of the work was completed.

Due to the scale of the response, we have provided relevant records in the following attachment: **“SQ1 - List of TfNSW Professional Services Engagements”**

Transport has provided records in the following scope:

- Contracts and other individual Purchase Orders (engagements) issued by TfNSW, effective between 01/07/2017 and 30/06/2023 of disclosable value over \$150,000 (including GST).
- Engagements identified as Core Professional Services. This means those engagements largely procured under the Whole-of-Government Performance and Management Services Scheme (SCM005), Digital and Advertising Scheme and Legal Services. This includes Statement of Work-style arrangements and consulting engagements.
- Core Professional Services excludes construction and IT professional services, as well as the engagement of supplier secondees.

**QUESTION:**

**11. For consulting or contracting engagements requiring a business case, how many since 2017 have been granted to a consultant or contractor that had previously been engaged to develop the business case for that program?**

Transport for NSW can confirm that in FY21-22 and FY22-23, 80 identified business cases have undertaken a Gate 1 and/or a Gate 2 assurance review, of which 40 per cent were developed by an external consultant or contractor.
