Good afternoon,

as per the request for additional evidence to the Parliamentary Inquiry, please see the attached two examples that highlight the challenges confronting land councils with respect to land activation in New South Wales.

Example one, shows a GIS map of the Jindabyne area. Those parcels in yellow, denote land currently under claim. The light pink shading shows a residential land use zone. Several parcels deemed, likely to be claimable, are not in a compatible land use zone despite their proximity to residential land. There is no pathway to change the zoning outside a spot rezoning unless they can be captured in the currently LEP process and under the guidance of NSW Planning.

Example two, provided by NSWALC, shows a sample number of other parcels across the State that are also in land use zones that are currently not compatible with development due to the zoning. (Information provided by Mark Parison, Development and Construction Advisor NSWALC). NSWALC have reinforced with me that this is a statewide matter that has been raised on multiple occasions.

My personal attempts to change the current situation have been met with resistance and I have been using a range of means to progress dialogue with various government agencies. I have raised this issue in the following forums.

NSW Aboriginal Affairs - Aboriginal Land Rights Training Pilot held at Tathra August 2023

NSW Land Council regional forum (South Coast) held at Batemans Bay in June 2023

NSW Dept Regional NSW in dialogue with former regional director and sought to have a multi-agency round table to work through the issue and then pilot a solution. Attempts to have the forum held July - Nov 2023 with no success.


Raised during the 2022 NSW South East Regional Plan consultation session held in Bega.

Raised the issue with senior bureaucrats in Crown Lands, Planning and Aboriginal Affairs at numerous meetings between August 2022 - February 2024.
