Answers to Questions on Notice: Inquiry into the ability of local governments to fund infrastructure and services

Thank you for the opportunity to provide responses to questions taken on notice by Caroline Foley, Northern Beaches Council, when appearing before the Legislative Council Standing Committee on State Development on 3 June 2024 for the 'Inquiry into the ability of local governments to fund infrastructure and services'.

Question on notice 1

Dr AMANDA COHN: That was helpful. Just to follow that up—and this might need to be taken on notice—it sounds like you're talking about most of that cost incurred being damage to assets that needed repair.

CAROLINE FOLEY: It depends on the storm. It can be a lot of clean-up—trees on roads and the like—but it can also be significant infrastructure damage, which takes a longer time to repair. Being a coastal council, a lot of the damage, except for that February 2022 instance where there was a special exception, seawalls and things like that are not are actually covered under the arrangements.

Dr AMANDA COHN: Are you able to, on notice, provide a breakdown of that \$14 million? I'm sure it's more now that you've had that \$7 million—I'm sorry to hear that. I'm really interested in what the actual costs are and what council is paying for in that recovery.

CAROLINE FOLEY: Yes, we're happy to do that.

1. What types of costs are incurred in response to a natural disaster?

The Northern Beaches is highly exposed to a raft of natural hazards with current data indicating:

- Over 22,000 properties are affected by flood;
- 19.000 properties are bush fire prone:
- 63,000 properties exposed to moderate to high geotechnical risk, and
- close to 5000 properties affected by coastal hazards.

The recently released NSW State Disaster Mitigation Plan estimates that by 2060 the Northern Beaches will have the highest Total Average Annual Losses in NSW by 2060, with estimated losses of close to \$1 billion dollars per annum to the built environment alone.

The following table sets out the types of costs incurred by Council in the past 5 years for natural disasters.

AGRN 1025 NSW Severe Weather and Flooding from 27 June 2022 onwards	\$1,788,339	-	\$1,788,339	Significant road damage requiring heavy patching, drainage and pavement repairs caused by a sinkhole within Manly Corso and removal of damaged, hanging or fallen branches and trees
AGRN 1119 NSW East Coast Flooding from 1 April 2024	\$361,999	-	\$361,999	Emergency works to stabilise road embankments and clean up fallen trees and rocks along with repairing damaged roads and stormwater infrastructure.

2. Does your council invest in apprentices and trainees? If so, what is the percentage of your workforce?

Northern Beaches Council currently has 18 roles for apprentices and trainees, which equates to 1.4% of the workforce.

The successful Apprenticeship and Traineeship Program provides paid opportunities in areas including Childcare, Property, Finance, Youth and Community Development, Bushcare and Biodiversity, Traffic and Transport, Information Technology, Library Services and Customer Service. Many of our trainees and apprentices go on to secure a temporary or permanent position and grow with the Council.
