## **ANSWERS TO QUESTIONS ON NOTICE**

1. The Hon. CHRIS RATH: Mr Ofner, would you be able to provide to this Committee the communications that went out to those candidates, with what the process was and the nomination process?

See attached documents.

2. The Hon. SARAH MITCHELL: Mr Ofner, perhaps you could take on notice—and I appreciate what you said, Mr Nanva, about it being a busy time—whether there are any records of who communicated from the parliamentary team into headquarters at that campaign level? If you could provide that back on notice, that would be great.

According to campaign records, Josh Wright from the then-Opposition Leader's Office and Elizabeth Butterworth from the office of John Graham were the points of contact about the local commitment process in the Parliamentary Party.

3. The Hon. SARAH MITCHELL: Do you know, Mr Ofner? Do you remember? DOMINIC OFNER: The specifics of who in the staffing pool of the parliamentary party? I'd have to take that on notice. But it certainly aligns with my recollection that there were staff in the leader's office who were, essentially, managing the forms as such, which would have included the information in response to the criteria and, included in that, any conflict of interest declarations. The Hon. SARAH MITCHELL: If you could provide on notice who they were that it went back to. I mean, again, I appreciate if it didn't go back to your offices, but it would be good to know where they were sent to. The Hon. CHRIS RATH: And maybe a copy of the nomination form as well, if you could provide that to us on notice.

4. The Hon. MARK LATHAM: Are you able to provide the extract that refers to this local commitments to the Committee? DOMINIC OFNER: I'm not sure if it does. That's the first thing. I'm not sure; I can't remember. The Hon. MARK LATHAM: But if it does, can you provide it to the Committee? DOMINIC OFNER: I'd have to take that on notice.

5. The Hon. MARK LATHAM: Were they all preselected at that point? DOMINIC OFNER: I don't think so, actually. The Hon. MARK LATHAM: So which ones were still to be selected? DOMINIC OFNER: I don't know. I can take that on notice.

Candidates for the following seats were still to be preselected at the time in question: Cabramatta, Northern Tablelands, Fairfield, Epping, Wahroonga, Oxley, Murray, Cronulla, Monaro and Manly.

## **Guidelines for assessment**

Each electorate will be allocated a nominal \$400,000 under the fund.

Candidates will make recommendations to the Expenditure Review Committee subcommittee as to the proposed allocation of funds, up to that total limit.

The relevant candidate may assess the eligible applications in their electorate on how they address four Assessment Criteria:

- 1. Enhancing facilities: the project develops a vibrant, sustainable, and inclusive community through the enhancement or construction of community infrastructure.
- 2. Meeting community needs: the project supports activities and services needed by local communities.
- 3. Increasing community participation: the project encourages participation in activities or services needed by a broad section of the community.
- 4. The organisation's capacity: the applicant has the capacity to deliver the project on time and within scope.

Candidates will be invited to make funding recommendations for projects for Shadow ERC consideration.

Partial funding may be recommended for some projects to increase the benefit to be obtained from the funding allocated to each electorate. Reasons for recommending partial funding may include 'High demand for funds'; 'Some project activities not eligible' and 'Applicant advised part of the project can proceed with partial funding'.

In assessing and in making funding recommendations, candidates may give consideration to local requests for funding, the geographical spread of recommended projects across the electorate and whether the project has received funding from other state or federal government sources.

Candidates will be required to complete a conflict of interest declaration as a part of the assessment process.





A positive feature of the local commitment process was the manner in which every electorate, no matter its margin or Party status, would receive an equal amount of funding as part of the Local Small Commitments Allocation. The program was designed to combat the former Government's practice of favouring Liberal and National electorates over other electorates.
