Grant decisions under Premier's Discretionary Fund 2023-24 allocation

Briefing for the Premier

Issue

Approve or decline grant funding under Premier's Discretionary Fund (PDF) 2023-24 allocation for Wayside Chapel, The Salvation Army NSW (Street Level), St John's Community Services (Rough Edges).

Purpose

The Premier's Department has assessed the merits of the Proposed Grants having regard to the PDF Program Guidelines and the key principles of value for money and community benefit. The Premier's Department assessment offers advice to the Premier to ensure adherence to the key principles of grants administration specified in the Grants Administration Guide (Guide) and is contained in Attachment C. To inform the Premier's determination that the grants are an efficient, effective, economical and ethical use of money, see Attachment C.

The process for recommending proposed grants for funding through the PDF complies with the Guide. The Guide is issued under a Premier's Memorandum, which is binding on Ministers, officials and Ministerial staff, and compliance with the Guide is required under section 10.3A of the Government Sector Finance Act 2018 (NSW) (GSF Act).

Background

A. Grant(s) administration process

Application and selection process

Requests for funding from the PDF are identified or received on an ad hoc basis throughout the year for a broad range of purposes. The Premier previously approved the awarding of grants from the PDF using a method other than a competitive, merit-based assessment process (A5537046). The application and selection process; including eligibility and assessment criteria, are outlined in the PDF Program Guidelines.

Probity and conflict of interest management

The Premier's decision to approve or decline a grant must be recorded in writing, including any reasons for departing from the recommendation of the Premier's Department. All records are managed in accordance with the requirements of the State Records Act 1998 (NSW). Where a request for funding is supported, the Premier has discretion to determine the funding amount (this may be either the full funding amount requested, or a portion of the funding request). The Premier's decision and reason for departing from the funding amount recommended in this brief must be recorded in writing.

Grants from the PDF are not considered complex, high-risk or high-value in nature under the Premier's Department's risk management framework and as such the requirement under section 6.1 of the Grants Administration Guide (2022) to obtain probity advice does not apply.

The processes for managing conflicts of interest are outlined in the PDF Program Guidelines.

Notification to applicants

If the Premier approves the Proposed Grants, the Premier's Department will advise the Proposed Grantees in writing and has drafted letters for the Premier's signature for this purpose (Attachment B) to The Salvation Army and St. John's Community Services.

Terms and conditions of the grant

The Premier's Department will liese with the grantees to sign funding agreements in favour of the Premier's Department on behalf of the State of NSW and arrange payment from the PDF in accordance with the terms of the agreement. The funding agreement will clearly state the purpose of the grant.

Records and publication requirements

In accordance with the requirements of the Guide (section 6.5 and Appendix A), relevant information about the grants awarded will be made available on the NSW Government Grants and Funding Finder as soon as possible after the grant funding is approved or declined. All records in relation to this decision will be managed in accordance with the requirements of the State Records Act 1998 (NSW).
