Questions from Ms Cate Faehrmann MLC

Gambling Harm Reduction

- (1) What evidence did you rely on to determine the cashless gaming trial was ineffective and did not result in gambling harm reduction, as you stated on 17 June and again in response to questions in budget estimates on Wednesday 20 August?
 - (a) Please provide details of all reports or other evidence used to inform this position.

Lead poisoning and contamination in Broken Hill

- (2) The Broken Hill Environmental Lead Program (BHELP) was funded \$13 million over 5 years for the EPA and Health to address lead poisoning and contamination in Broken Hill. This funding ended in 2020 and the BHELP was replaced by the Broken Hill Environmental Lead Response Group (BHELRG). Since its establishment, how much funding has been allocated to the BHELRG?
 - (a) Please provide a breakdown of funding to date year on year, and over the forward estimates.
 - (b) Please provide a breakdown of funding by portfolio.
- (3) You were first notified of the serious funding shortfalls for addressing lead poisoning and contamination in Broken Hill in June 2023 when your government first came to power. What new funding commitments have you made to address lead poisoning and contamination in Broken Hill since this time?
- (4) Underfunding is preventing the Broken Hill Environmental Lead Response Group from analysing air monitoring. Will you commit to allocating funding for the establishment of an integrated air quality monitoring and response system for Broken Hill?
- (5) Documents released through SO52 indicate that equipment used by health practitioners for lead testing are likely to now be obsolete. Will you commit to funding the replacement of all obsolete lead testing equipment?

Questions from Ms Abigail Boyd MLC

Sexual harassment policies

- (6) Has the Public Service Commission (PSC) made any progress in relation to reviewing public sector agencies' sexual harassment policies?
 - (a) Can you advise whether any agencies are yet to provide a policy?
 - (b) How many meet the minimum standards in the direction?
 - (c) Can you break down how each agency is ranking against the minimum standards?

Inclusive employment in the public sector

- (7) What is the status of the Premier's Department's work in adopting a consistent definition of disability across the sector based on the social model and providing guidance to the sector regarding this?
- (8) Is there any work being done to improve fair employment opportunities for people with intellectual disability in the public sector, for example adjusting capability frameworks and job classification systems by adapting job descriptions and levels instead of having fixed capabilities and roles?
 - (a) Is the PSC or the Premier's Department looking at addressing issues with inaccessible entry points and recruitment processes for people with intellectual disability?
- (9) Has the PSC made any progress in coordinating tailored actions for the larger portfolios of Health, Education and Stronger Communities to deliver the greatest contributions to disability workforce targets?

Questions from Ms Sue Higginson MLC

Letter from President of Israel

(10) On 6 May 2025, you accepted a letter from the President of Israel, which effectively recognised NSW as a Friend of Israel. How does accepting a letter from the President of a State which has massacred tens of thousands of innocent Palestinians, including family members of NSW residents, align with your stated goal of improving social cohesion in NSW?

- (11) On 6 May 2025, when you accepted the letter from the President of Israel, the Israeli Government airstruck an UNRWA school-turned-shelter in Gaza. 30 people were killed, including babies, women and children. Do you condemn that action as a war crime?
- (12) Israeli president Izaac Herzog said that every single person in Palestine is responsible for the October 7th attacks "It's an entire nation out there that is responsible" and that justifies a genocide against innocent people. Why did you accept a signed letter from him?
- (13) If the President of Israel offered you another letter today for being a friend of the State of Israel, would you accept it?
- (14) Will you write back to the President of Israel expressing the NSW Government's desire for Israel's immediate withdrawal from Gaza and the recognition of a Palestinian State?

Protest

- (15) Given no individuals have yet been charged under your anti-protest laws, the Crimes Amendment (Places of Worship) Bill 2025 and the Crimes Legislation Amendment (Racial and Religious Hatred) Bill 2025, but references have been made to them by police in seeking to shut down peaceful protests, does this not prove the laws are not having the effect of protecting communities, and are instead simply giving impunity to police to shut down peaceful protests?
- (16) Premier, given you said you could not support the Harbour Bridge March even though it is not within your power to approve or disapprove of peaceful protests, and you have repeatedly said you do not support pro-Palestine protests, have there been any pro-Israel protests, gatherings or events that you have ever not supported or been opposed to?
- (17) Can you please elucidate your understanding of your own statutory role in New South Wales, specifically that Premiers don't have any authority to approve or prohibit protests?
- (18) Are your anti-protest laws disproportionately being used to reinforce your own ideology?

 Doesn't that set a dangerous precedent?

Palestine

(19) Will you join United Nations human rights experts and international lawyers in conceding that Israel's actions in Gaza constitute the crime of genocide, following your stance in calling out the war crimes of Russia?

- (20) What additional actions do you support the Australian Government taking to stop Israel's genocide in Gaza?
 - (a) Do you support sanctions?
 - (b) Do you support an end to the two-way arms trade?
- (21) Is there anything specific you've learnt as a result of the March for Humanity across the Harbour Bridge, where over 200,000 people defied you to march for Palestine, including several of your own Ministers?
- (22) Benjamin Netanyahu is a war criminal wanted by the International Court of Justice, will you direct NSW Police to assist the Federal Police to arrest him if he comes to this State in accordance with international law?

Kathleen Folbigg

- (23) Could you please describe your understanding of how ex-gratia payments work?
- (24) Do you believe what the State did to Kathleen Folbigg was wrong?
 - (a) Can you please describe your understanding of injustice perpetrated by wrongful imprisonment?
- (25) Recognising that it was the responsibility of the Attorney General who determined the payment, on behalf of NSW how do you justify an offer of just \$2m to Kathleen Folbigg, a woman who was wrongly imprisoned for 20 years, when a man gets \$7 million for 19 years of wrongful imprisonment?
 - (a) Does this not reflect a misogynistic double-standard on the part of the Minns Labor Government?
- (26) Are you satisfied that the ex-gratia payment process, in which one man has sole discretion over one of the only methods of redress for injustice, is sufficient for victims of injustice?
 - (a) Will you support an independent financial accounting process for ex-gratia payments going forward?
- (27) Do you seriously want to drag Kathleen Folbigg, a mother who has lost four children through the courts?
 - (a) Do you understand that financially dispossessed women cannot take governments to courts, and that the ex-gratia payment is therefore Ms Folbigg's only means of justice?
- (28) Why have you refused to meet with Kathleen Folbigg? Will you meet with Ms Folbigg?

- (29) What specific trauma-informed communication training have you undertaken as Premier?
 - (a) What specific trauma-informed communication have you undertaken since your election as Member for Kogarah in 2015?
 - (b) Do you instruct communications officers to undertake trauma-informed communication training?
 - i. If so, how often?
- (30) How do you justify \$7.9 million of taxpayers money for the Minns Labor Government's political deal with the Shooters Party to pass the Game and Feral Animal Legislation Amendment (Conservation Hunting) Bill 2025?
 - (a) Given this budget allocation, how can you say that you cannot justify more than \$2 million for Kathleen Folbigg?
- (31) Did you, or anyone from your Department to your knowledge, discuss the ex-gratia payment to Ms Folbigg, or ex-gratia payments in general, with the Attorney General or anyone from his office?
- (32) How many approaches did Ms Folbigg's lawyers make for a meeting with either yourself or the Attorney General since 2023?
 - (a) How many direct responses were provided to Ms Folbigg's representatives?

Community Flood Restoration Fund

- (33) Exactly how much of the \$150m Community Flood Restoration Fund was spent on buybacks, raises and retrofits in the Northern Rivers?
- (34) If none, why did a government media release identify that this Fund would be a "second installment" of the Resilient Homes Program?

Environment

- (35) At your meeting with Timber NSW representatives on 18 July 2025, was any reduction in the size of the proposed 176,000 hectare Great Koala National Park discussed?
 - (a) Was a proposed moratorium on logging in the Great Koala National Park assessment area discussed?
- (36) Can you rule out a Great Koala National Park announcement that is smaller than your implied promise of 760,000 hectares?

- (37) NSW Labor's 2023 platform stated that "Labor will prevent broadacre clearing and clearing of endangered and threatened regional ecosystems and ecologically sensitive areas."
 - (a) How is the 40% jump in land clearing recorded by SLATs data consistent with this election commitment?
 - (b) What specific steps have you taken as Premier to reduce land clearing in New South Wales?
- (38) Given you voted against the Liberals and National's Biodiversity Conservation Bill 2016 and Local Land Services Amendment Bill 2016 while in opposition, will the Government commit to repealing those pieces of legislation in full now you are in Government?

Climate Action

- (39) Is the Premier concerned his government is failing to keep on track with its legislated 2030 emissions reductions targets?
- (40) Will the Premier issue a direction or memorandum as a whole of Government message that reducing emissions and mitigating and adapting to climate change impacts is a priority for the NSW Government?

Hannah Thomas

- (41) You blamed Hannah Thomas in the aftermath of her assault for not giving a statement to police, and you said "It's very difficult for police, even though they've got body-worn video camera footage, to make a determination about what happened"
 - (a) Did you review the body-worn camera footage before making this statement?
 - (b) Did you seek advice from NSW Police on what the body-camera footage contained?
 - (c) Were you aware when you made this statement that the body-camera footage showed Ms Thomas being punched in the face?

Resilient Homes Program

- (42) On what date did you sign off on the decision to slash \$100m in funding for house-raises and retrofits from the Resilient Homes Program?
- (43) How can you justify putting at least 1000 homes at risk of further damage from flood impacts in the middle of a housing crisis, by cutting funding for raises and retrofits?

- (44) Did you make a formal request from the Commonwealth Government to allocate an additional \$100m funding for buybacks before seeking to withdraw support?
 - (a) If so, why did Labor MP Justine Elliott tell the Guardian on October 20 2023 that "In relation to additional recovery support, I'm advised that the federal government hasn't received a formal request from the NSW state government...We stand ready to assist and work with them."
- (45) On exactly what date was a formal request made by the state government to the commonwealth government for the additional contribution of \$180m in funding for the Resilient Homes Program?
 - (a) What was the exact dollar amount requested by the state government from the Commonwealth?
 - (b) What was the exact dollar amount proposed to be spent from the state government on the Resilient Homes Program?
- (46) The Prime Minister had previously instructed you to "consider the range of approved programs agreed by the Commonwealth under Category D of the DRFA relating to the February-March 2022 and July 2022 flood events, and write to me with options to use savings in the first instance."
 - (a) Have you made any written representations to the Prime Minister identifying savings from approved programs under Category D of the DRFA relating to the February-March 2022 and July 2022 flood events?
 - (b) If so, which savings were identified? Please include a list of which programs were proposed to have a reduction in funding.
- (47) Why have you sought to make public statements criticizing squatters when, under your government, just 1% of the 4000 raises and retrofits that were promised to flooded homes have been delivered?
- (48) Given that you told parliament on 19 September 2023 that "we have \$350 million for tranche one of the Northern Rivers Reconstruction Program. We have allocated, on top of all of those funds, an additional \$150 million for tranche two."
 - (a) Why did answers to Questions on Notice from the Hon Janelle Saffin MP claim that only an additional \$90 million had been allocated by the Minns Labor Government, when you claimed you had allocated "\$150m for tranche 2"?

Youth Bail Laws

- (49) Can the Premier name one expert, or one peer-reviewed study, who agrees that the Bail and Crimes Amendment Act 2024 has the effect of reducing crime rates in New South Wales?
- (50) Given over 500 experts in the fields of law, criminology, social sciences and Indigenous studies told the Premier that his bail laws "do not make communities safer and in fact exacerbate the social drivers of young people's contact with the justice system", why have these laws not been reviewed?
- (51) Since these laws were introduced, youth crime overall is going up: instances of kids stealing from retail stores are up, break and enter offences are up, robbery offences are up, property damages are up, driving offences are up, weapons offences are up, and there are more First Nations kids in prison which is exactly what 500 experts told you would happen. Given that Labor's laws are making crime worse, is it not now time to repeal them?
- (52) Crime is down compared with ten years ago, but your bail laws are clearly resulting in more kids reoffending because they've been traumatised by a criminal justice system that you've put them in deliberately. Will you concede your approach is motivated by a political desire to appease shock jocks and that you don't actually care about community safety?
- (53) How can the Premier justify spending over \$1 million to imprison just one child per year, and the resultant massive expense to the community of an increased prison population of children and no tangible decrease in crime?

Trauma-informed communication

- (54) What trauma-informed communications training has the Premier undertaken since coming to office?
 - (a) How many times has the Premier undertaken this training?
- (55) How often do communications staff in the Premier's department undertake traumainformed communications training?
 - (a) Can you please describe the subject matter in these training sessions?
- (56) Was any advice provided to the Premier on his communications with regard to the wrongful imprisonment of Kathleen Folbigg, a mother who has lost four children?
- (57) What steps does the Premier's Department take to avoid unconscious misogyny, or any other form of bigotry or microaggression, in communications made by the Premier?

- (58) On Monday the 14th of July, the Premier said with regard to a request to meet with Ms Folbigg "There's a lot of difficult calls for me to make as premier this isn't one of them." Is this style of communication consistent with trauma informed communications principles?
- (59) What training do staff in the Premier's department who handle meeting requests from vulnerable people like Ms Folbigg receive?

- (67) What direct instructions, if any, did the Premier give to public servants or Ministers about progressing this proposal before it became public?
- (68) Has the Premier or his staff held private meetings with the City of Sydney Council, and if so, on what dates and with what agenda?
- (69) Did the Premier or anyone in his office have contact with Clover Moore or her office about Moore Park Golf Course prior to this announcement, and can you table the records?
- (70) Has the Premier received any briefing papers that canvassed alternative options such as keeping the 18 holes and adding public parkland, and if so why were those options rejected?
- (71) What independent costings or economic impact studies were commissioned by the Premier's Office before announcing this proposal?
- (72) Did the Premier's Office receive any legal advice about the heritage status of Moore Park Golf Course or the impact on existing leases before making this decision?
- (73) Who in government decided that half the course should be carved off, rather than a smaller portion or other compromises, and what criteria were used?
- (74) Has Treasury modelled the loss of tourism and local business revenue if the course is reduced, and can those figures be provided?
- (75) Were any consultants or lobbyists engaged formally or informally to help shape the government's thinking on Moore Park Golf Course, and if so, who and at what cost?

- (80) Did the Premier or his staff discuss the possibility of rezoning or redeveloping any part of Moore Park Golf Course land for non-recreational use, and can he categorically rule this out today?
- (81) On what dates has the Premier or his office spoken with former Premier Bob Carr about Moore Park Golf Course, and will you table records of any calls, texts, emails or meetings?
- (82) What advice, written or verbal, has Bob Carr provided to the Premier or his office about this proposal, and why has that advice not been made public?
- (83) Did the Premier or his staff solicit Bob Carr's views before Cabinet or public service advice was finalised, and if so, can the Premier outline exactly when those exchanges occurred and what was said?

- (84) Since March 2023, how many bullying complaints have been received in ministerial offices, and can the Premier provide the dates and outcomes of each?
- (85) How many complaints of sexual harassment have been raised in ministerial offices since the Minns Labor Government came to office, and what action was taken in each case?
- (86) Has the Premier or his Chief of Staff ever personally spoken to a complainant about bullying or harassment, and if not why not?
- (87) Has any complaint been resolved through mediation or confidential settlement paid out of public funds, and if so, how many?
- (88) What processes does the Premier have in place to ensure staff making allegations are protected from reprisals?
- (89) Has any ministerial staff member resigned citing bullying or harassment, and if so, how many and from which offices?
- (90) Has the Premier's Office tracked the turnover rates of staff in ministerial offices to identify possible toxic workplace cultures, and what has that shown?

- (92) Have any Ministers themselves been directly accused of bullying or harassment, and what steps did the Premier take in response?
- (93) Has the Premier or his Chief of Staff provided specific instructions to keep complaints inhouse rather than escalate them through formal HR processes?
- (94) Have any workplace health and safety assessments been conducted in ministerial offices following complaints, and if so, what were the findings?
- (95) Has the Premier been made aware of any cases where a complainant was moved out of an office rather than the alleged perpetrator, and if so, why?
- (96) Has the Premier's Office conducted any staff surveys about workplace culture in ministerial offices since taking office, and what did those surveys reveal?
- (97) What guidance has the Premier issued to Ministers about how to handle bullying and harassment complaints in their own offices?
- (98) Has any Chief of Staff been subject to a bullying or harassment allegation, and if so, what action was taken?
- (99) Has any ministerial staffer been dismissed or forced to resign as a result of a bullying or harassment complaint since March 2023?
- (100) Has the Premier personally reviewed any of the complaint files relating to ministerial offices, and if not why not?

Intoxication on Ministerial and Parliamentary Premises

- (126) Has the Premier or his Chief of Staff ever been notified of ministerial staff attending work under the influence of alcohol or drugs?
- (127) Has the Premier's Office conducted any inquiries into Ministers or staff being intoxicated at work functions or while in ministerial offices?
- (128) Has any ministerial staff member been counselled, warned, or dismissed for being intoxicated on the job, and can the dates be provided?
- (129) Has any Minister been spoken to by the Premier about their behaviour after attending Parliament or their office while intoxicated?
- (130) Have there been any recorded workplace health and safety incidents involving intoxication in ministerial offices, and what action was taken?
- (131) Has the Premier or his Chief of Staff received complaints from staff about intoxicated behaviour by a Minister or staffer, and how was this handled?
- (132) Have any formal HR or disciplinary processes been triggered due to intoxication of ministerial staff, and what were the outcomes?

- (148) Has the Premier received complaints from other staff or the public about conflicts arising from staff serving as both councillors and ministerial employees?
- (149) Has the Premier's Office undertaken any audit of staff who hold council roles to ensure they are not using taxpayer resources for council duties?
