This is the mandatory level of compliance. Compliance with the Performance Requirements of the NCC can be demonstrated through a Performance Solution, a Deemed-to-Satisfy Solution or a combination of both. NCC 2022 Amendment 2 is the current edition of the NCC. Section D – Access and egress of Volume One of the NCC includes the relevant requirements for enabling building occupants to enter and exit a building. The Performance Requirements require that building occupants be provided with an appropriate means to safely exit a building. Where a Performance Solution is proposed to demonstrate compliance with the relevant Performance Requirements, the proposed solution needs to detail and to justify how the exits provide for building occupants to safely exit a building. The relevant Deemed-to-Satisfy provisions do not specify a particular point in time when a fire door is not required to perform the egress function.

2		The installation of fire bolts in fire doors is a national issue and the ABCB has been leading the national work into this matter. Building Commission NSW has been working closely with the ABCB on this important work and awaits the outcome from the ABCB.
		Building Commission NSW understands that the ABCB have had regular engagement with relevant fire authorities about this matter.
3	Section 109 of the Environmental Planning and Assessment (Development Certification and Fire Safety) Regulation states that a person must not, without lawful excuse, interfere or obstruct a fire exit door or the operation of fire door in providing egress. If, as the fire authorities warn, a fire door with bolts was to be rendered inoperable from activated bolts during a fire, how are those circumstances considered compliant with EP&A Regs?	I am advised: Section 109 of the Environmental Planning and Assessment (Development Certification and Fire Safety) Regulation 2021 seeks to ensure the ongoing effective operation of exits following a building being occupied. Accordingly, it regulates that fire doors are not to be interfered with post installation (e.g. changes made that are contrary to the requirements of any approval granted) and that exits are not obstructed in a way that would impede a person's ability to use the exit. Fire doors, including any relevant hardware, installed in a building must comply with the relevant NCC requirements as determined through the relevant approval processes prior to occupation of a building.
