Question 1 - Noise complaints

How many noise complaints have been received against live music venues since changes to the statutory disturbance complaint framework were introduced in July 2024.

Answer

I am advised:

222 noise and disturbance complaints were received against live music venues since 1 July 2024. Of those, four were statutory disturbance complaints, under section 79B of the *Liquor Act 2007*.

Question 3 - Noise complaints

Have any noise complaints been made against venues in special entertainment precincts since July 2024.

No noise complaints were received against venues in Special Entertainment Precincts since 1 July 2024.

Question 4 – Live Music Venues

How many venues are on the list?

Answer

I am advised:

479 live music venues and 71 live performance venues are on the approved L&GNSW dedicated live music and performance venues list.

Question 5 - Live Music Venues

How many venues on the list have closed?

Answer

I am advised:

Venues can only access the live music and performance venues incentives if they meet certain eligibility criteria and are included on the live music and performance venues published list. Venues which have closed would not be on the list.

Question 6 – Live Music Venues

How many venues have less than 2 live performances a week?

Answer

I am advised:

Venues can only access the live music and performance venues incentives if they meet certain eligibility criteria and are included on the live music and performance venues published list. Venues with less than two performances would not be on the list.

Question 7 – Live Music Venues

How many venues have no stages or production infrastructure?

Answer

I am advised:

Venues can only access the live music and performance venues incentives if they meet certain eligibility criteria and are included on the live music and performance venues published list. Venues with no room or space dedicated to live music performances that is a significant part of the venue, and which do not contain the infrastructure to support regular performances, would not be eligible.

Question 8 – Live Music Venues

When did L&GNSW last complete a full audit of compliance with eligibility requirements for live music?

I am advised:

L&GNSW is currently conducting an audit of Live Music Venues and Live Performance Venues to assess compliance with live music requirements. This compliance program is ongoing.

Since November 2024, L&GNSW has conducted 252 inspections of Live Music and Live Performance Venues in the extended Sydney Metropolitan area, as well as regional areas, including the Central Coast, Cessnock, Newcastle, Shoalhaven, Wollongong, Goulburn and Wagga Wagga local government areas. The current list of eligible live music venues sits at 479, however this continues to grow daily as more licensed venues are approved.

L&GNSW places a strong focus on engagement and education to ensure live music and live performance venues are aware of their legislative requirements. Of the 252 live music and live performance venues inspected, 14 venues have been flagged for further review due to not meeting compliance with eligibility requirements. Overall, L&GNSW compliance insights so far indicate a positive level of compliance with the legislative requirements.

Question 9 – Live Music Venues

Will the Minister consider requiring venues to have public-facing marketing or gig guides on their websites and social media through legislation to demonstrate compliance to the community, and also help promote the great live music being presented through this program across NSW?

Answer

I am advised:

This is however a good suggestion, and I have referred it to Sound NSW for advice. To demonstrate compliance with the eligibility requirements under the *Liquor Act 2007* for live music venues, venues must maintain records in relation to the hosting of live music performances. Question 12 – Restoring the 370 bus route from Leichhardt to Coogee

In February the Minister said "Options for restoring this part of the route remain under review. I am hopeful that Transport for NSW will determine a resolution of this matter in the relatively near future". In the last BE hearing we were advised "Options to enhance bus routes between Leichhardt, Annandale, and Forest Lodge to the University of Sydney are in development. Transport for NSW will engage with passengers and the community on any plans for the bus network before any changes are implemented to ensure that the community understand what the changes are, and how best to travel." When will these options be put out to the community for consultation?

- (a) What other public transport options are in place for commuters who live along the original 370 route who wish to travel to Coogee?
- (b) On average, how many commuters used the original route on a daily basis?

Answer

I am advised:

- (a) Passengers that live along the original 370 route between Leichhardt and Glebe can catch route 469 and transfer to route 370 to travel to Coogee.
- (b) According to Opal data, the original bus route 370 recorded an average of 5,232 weekday tap-ons per day in March 2021, excluding weekends and public holidays.

Question 13 – 437 bus running times during the morning peak

What proportion of city-bound 437 bus services operating between Catherine Street and The Crescent along the City West Link reported on-time running between 7:45am and 8:30am on Tuesdays, Wednesdays and Thursdays during the month of June 2025?

Answer

I am advised:

94.24 per cent of city-bound 437 bus services reported on-time running between 7am and 9am on Tuesdays, Wednesdays and Thursdays in June 2025.

Question 14 - Restoring the 445 bus service to Balmain East

Community consultation on the government's plans to restore the 445 bus service to Balmain East concluded in March 2025. What has been the outcome of this consultation and when can the community expect further information?

Answer

I am advised:

Transport for NSW undertook public consultation in November 2024 on options to restore Route 445 to Balmain East Wharf, receiving over 1,000 survey responses and additional feedback via calls, emails, and conversations. Feedback strongly favoured direct services to the wharf and highlighted accessibility concerns at Gladstone Park. The assessment of community input is currently being finalised

Question 15 – 501 bus for Sydney Secondary College Balmain students

In the last BE hearing we were advised that students in Ultimo and Pyrmont can catch the 501 bus service to Victoria Rd Rozelle and make their way from there to the Sydney Secondary College Balmain Campus. What steps is the Government taking to ensure the 501 bus service runs reliably and on-time so that students who take up this option are not frequently late for school?

I am advised:

Earlier this year, Transport for NSW collaborated with Busways, the contracted operator of bus service 501. The 7:56am 501 trip has been listed as a no cancellation trip to ensure this service always operates for students attending the Sydney Secondary College Balmain Campus.

Transport for NSW continues to work closely with Busways to monitor on time running and cancellation performance across the region. Data collected from this monitoring is scrutinised for performance issues and opportunities to improve on time running performance in future service reviews.

Question 16 - F10 ferry onto Opal network

In March the Minister announced that passengers using the F10 ferry service would be able to use their Opal cards "from the second half of 2025". When will this be delivered?

Answer

I am advised:

Planning is underway to incorporate the F10 ferry service into the Opal network.

Question 17 – Sydney Fish Markets Ferry

Will the planned construction of a ferry wharf at the new Sydney Fish Markets, and introduction of a ferry service between there and Barangaroo limit the options available for future use of the Glebe Island Bridge?

Answer

I am advised:

Transport for NSW is developing a Final Business Case for the Glebe Island Bridge. This work will consider Bridge opening scenarios to manage active transport and ferry service demands.

Question 18 – Sydney Fish Markets Ferry

The new Fish Markets ferry was originally announced to be leaving Circular Quay (by Howard Collins, Coordinator General at Transport for NSW, in January 2025) but the NSW Government Budget announcement in June referred to the service being 'linked to Barangaroo'. Where will the new Fish Markets ferry be leaving from?

- (a) What other stops will this ferry service make?
- (b) Will the ferry be stopping at Walsh Bay?

Answer

I am advised:

The NSW Government announced in the June 2025 State Budget that the new Sydney Fish Market will have a ferry service connecting to Barangaroo. Planning for the service, including fleet and other stops, is underway.

Question 19 – Ferry to Annandale

In 2023 NSW Labor made an election commitment to introduce a ferry service to Annandale. Since they formed Government Transport for NSW has continued to review the vessel, infrastructure and timetabling requirements necessary for delivery of this ferry service. When are we going to see some progress on this commitment and when will it be delivered?

I am advised:

Transport for NSW is conducting technical assessments, route planning and infrastructure evaluation, including requirements for wharf suitability.

Question 20 - Balmain West Ferry

How many people have used the Balmain West ferry service since it was reinstated on 18 August 2025?

Answer

I am advised:

In its first two weeks since it was re-instated, Balmain West ferry service saw strong weekday usage with over 740 passenger movements.

Question 21 – Balmain West Ferry

What feedback has the NSW Government and Transport for NSW received from passengers in relation to the reinstatement of the service?

Answer

Transport for NSW received positive customer feedback.

Question 22 - Balmain West Ferry

What feedback has the NSW Government and Transport for NSW received from others in relation to the reinstatement of the service?

Transport for NSW received positive customer feedback.

Question 23 – Balmain West Ferry

Are there any plans to extend the service beyond weekday peak times?

Answer

I am advised:

Transport for NSW will continue to monitor patronage and where necessary adjust frequencies in response to changed demand.

Question 24 – Glebe Island Bridge

When will a decision be made on the future use for Glebe Island Bridge?

Answer

I am advised:

Transport for NSW is developing a Final Business Case for Glebe Island Bridge, which is expected to be completed by late 2026. This will inform the assurance process and guide the NSW Government's investment decision.

Question 25 - Glebe Island Bridge

When will that decision be announced?

I am advised:

Refer to the response to question 24.

Question 26 - Victoria Rd & Parramatta Rd revitalisation

When will community consultation commence with regard to the revitalisation of Parramatta Rd and Victoria Rd?

Answer

I am advised:

Transport for NSW is committed to engaging with communities and stakeholders as planning progresses for the future of Parramatta Road, including areas impacted by recent rezoning announcements such as Burwood North and Leichhardt to Camperdown. Question 27 – Emergency incidents on Sydney metro lines

The Office of the Rail Safety Regulator (ONRSR) required Sydney Metro and the operator to resolve the capability gap impacting the response to emergency incidents on Sydney Metro rail lines. What is the status of this resolution?

- (a) What are the specific obstacles preventing a resolution?
- (b) How has the Government responded to the FRNSW provided a business case presented to the Government to uplift their rescue capability?

Answer

I am advised:

In agreement with Fire and Rescue NSW and The Office of the Rail Safety Regulator, Metro Trains Sydney, operator of the Sydney Metro North West and Bankstown Line, has implemented an interim agreement with Sydney Trains' Rail Fire and Emergency unit to support the response to emergency incidents on Sydney Metro rail lines. This arrangement is in place with Sydney Trains while Sydney Metro concurrently progresses a whole-of-government long-term solution. Engagement is ongoing between Transport for NSW and Emergency Services portfolios to confirm the preferred long-term model.

Question 28 - Emergency incidents on Sydney metro lines

The proposed e-bike ban on the rail network is understood to be the result of increased fire safety risks associated with lithium-ion batteries. Assuming that a ban is progressed by the Government, in what circumstances will the ban be lifted?

- (a) What specific requirements are the Government expecting from rail operators in these circumstances?
- (b) What implications does this have on the Metro South West line which is forecasted to open in 2026?

Answer

I am advised:

On the 22 September 2025, the NSW Government announced that train passengers and staff will be less at risk from lithium-ion battery fires as a result of a ban on converted e-bikes on the NSW rail network.

Converted e-bikes are defined as regular pedal bikes that have been fitted with batteries and motors. These have higher risk of electrical failure and fire risk due to DIY installations, inadequate wiring and use of second-hand batteries and incompatible or poor-quality components. Other e-bikes, shared e-bikes and mobility devices will not be impacted, however Transport for NSW will continue to monitor all e-micromobility incidents closely. To support the ban of converted e-bikes on trains, Transport will provide additional training for staff, conduct hotspot blitzes, and increase public messaging about the fire risk of modified devices.

Question 29 – Companion animals on public transport

Is consideration being given to allowing companion animals on public transport? If so, is there a timeline for public consultation?

Answer

Transport for NSW is continuing to engage with transport workers and with organisations representing people with disabilities on any future options regarding animals on services.

Answer

I am advised:

- (a) Transport for NSW has installed 22 parking bays at 11 Sydney train and Metro stations as part of a discreet pilot. This pilot is testing marked and geofenced parking arrangements.
 - i. 14 were installed in City of Sydney LGA.
 - ii. Five were installed in Inner West Council LGA.
- (b) Refer to the City of Sydney.
- (c) The sharing scheme parking trial concluded successfully. Transport for NSW is now planning to install new parking bays to service train and Metro stations.
 - i. To be determined through the design phase of the project.
 - ii. To be determined through the design phase of the project.

(d) As of 7 September 2025, there were approximately 10,500 shared e-bikes available for hire in NSW.

- i. Around 60 per cent of the shared e-bikes circulating in the Greater Sydney area are within the City of Sydney LGA.
- ii. Around 10 per cent of the shared e-bikes circulating in the Greater Sydney area are within the Inner West LGA.
- (e) The NSW Government is committed to integrating shared devices into the transport network.

In addition to potential regulatory reform, Transport for NSW will be creating new shared device parking bays in operating areas throughout Sydney this financial year. This will be done in collaboration with local councils and State Government land managers. Site selection for the parking program is underway and builds on lessons learned from the shared e-bike parking pilot delivered in 2024/25. Transport is also developing shared device parking guidance to support local councils in better integrating shared devices as a local transport option.

Question 31 – Sound NSW (Collins) Contemporary Music Festival Viability Fund

Are all recipients of grants from Sound NSW required to pay the minimum fee of \$250.00 per artist?

Question 32 – Sound NSW (Collins) Contemporary Music Festival Viability Fund

Recognising that eligibility criteria for the Contemporary Music Festival Viability Fund do not allow artists to apply for fees, are the recipients of Contemporary Music Festival Viability Fund grants from Sound NSW required to pay the minimum fee of \$250.00 per artist across their event programs?

Answer

Sound NSW is currently undertaking the development of a policy in relation to the minimum fee. This policy is currently being finalised and will be implemented following approval.

Question 33 - Office of the 24Hr Economy Commissioner - Purple Flag Precincts

A story on Channel 7 News on Saturday August 23 2025 reported a 20% drop in visitation for the York Clarence Kent purple flag precinct last year.

- (a) Have you looked into the potential cause of this decrease in visitation? If so, please detail the reasons for the drop in visitation numbers.
- (b) What, if any, requirements are placed upon venues or precincts that benefit from NSW Government-funding, in terms of hosting, advertising or otherwise prompting live music events?

I am advised:

(a) Yes. The Data after Dark platform allows us to monitor trading patterns across the State, including Sydney Inner City within the Sydney North SA2 area.

Businesses are facing challenges, particularly during the cooler months. The data shows the impact varies precinct to precinct. For example, June 2025 trade compared to June 2024 in Parramatta North, Burwood and Chatswood East was up 5.4 per cent, 4.4 per cent and 17.5 per cent, respectively year on year. This may indicate audiences are seeking more affordable options closer to home.

NSW's night-time economy has shown early signs of recovery. For example, data from Data After Dark (June 2025 quarter) shows in-person spending in NSW is \$3.6 billion, 1.5 per cent higher compared to June 2024.

(b) Live music and live performance venues, including participating venues located in Special Entertainment Precincts, can access reduced licensing fees and extra trading hours if they meet certain eligibility requirements including programming music twice a week.

In addition, programs like the Live Performance Venue Program encourage venues to diversify into live performance, including music. Funding under this program supports costs relevant to staging, sound, lighting, programming and marketing for live performances. It supports existing small-to-medium hospitality venues in NSW to increase the number and diversity of live performances being staged.

This approach has seen an uptake by venues both in and outside government supported precincts. Examples include Elton Chong (in Penrith), 7th Day Brewery (in Brookvale), Buddy's Bar (in Newtown) and Coledale RSL.

Question 34 – Office of the 24Hr Economy Commissioner - Purple Flag Precincts

How many Purple Flag Precincts are there in NSW?

Question 46 - Festival funding

What is the government's plan to address the number of non-ticketed festivals in NSW which are facing financial difficulty?

Answer

I am advised:

The NSW Government's 10-year Contemporary Music Strategy recognises the value of strengthening our communities with music, pledging to support communities to collaboratively market and deliver local music events.

The festivals ecosystem is a delicate one, with wide-ranging sizes, genres and formats. That is why it's important to focus both on structural changes and also target support to certain areas.

The NSW Government has focused on changing regulations and reducing costs, for example through the Music Festivals Act 2019 reform and Transport for NSW's Permit/Plug/Play to bring down structural costs of street activations and the broader Vibrancy Reforms.

It is also providing grant funding for the music festivals and events community through the Contemporary Music Festival Viability Fund, Destination NSW's major events funding and regional event fund and Transport for NSW's 'Open Streets' program.

The NSW Government aims for NSW to be home to a thriving grass roots music and festivals ecosystem.

Five contemporary music festivals received Sound NSW funding in 2024-25.

- (c) All five festivals in 2024-25 were ticketed. One festival in 2023-24 (Yabun) was unticketed.

I am advised:

Powerhouse pays for the services of scientists, researchers, educators, facilitators, collaborators, speakers and artists who collaborate with the museum to deliver exhibitions and programs. These fees are reported on in the Annual Report.

The \$1.33 million in 2023-24 supported over 300 collaborators and included First Nations programs, research fellowships, Sydney Design Week, Sydney Science Festival, publication commissions, the opening program for Powerhouse Castle Hill, family programs at Powerhouse Castle Hill, learning programs, exhibition public programs, regional programs and programs at Sydney Observatory.

Question 49 – Powerhouse

The latest Powerhouse Annual reports state that contract services were up from \$6.09m to \$9.4m, a 56 per cent increase. What is the reason for this increase? Can you provide a list of the contracts and payments made for that financial year and 2024-25?

Fees for contract services were higher due to operating costs relating to the relocation of the Powerhouse Collection from Ultimo to Castle Hill and services relating to the opening exhibitions and operationalising Powerhouse Parramatta.

Between 2021 and 5 September 2025, the Point to Point Commission issued 3,464 fines to taxi drivers and companies for offences such as touting, overcharging, and failing to display driver identification.

Annual infringement totals were: 34 (2021), 597 (2022), 1,281 (2023), 1,055 (2024), and 497 (2025 to date).

Since 2023, 11 fines were issued for refusing passengers with assistance animals, and five fines were issued in 2025 for failing to start the meter before a wheelchair passenger was ready.

Over the five-year period, six taxi drivers were disqualified, including four for breaches involving wheelchair-accessible services.

Question 65 - Questions to the Point to Point Commissioner

I am advised:

Between 2021 and 5 September 2025, the Point to Point Commission issued a total of 3,365 fines to rideshare and hire vehicle drivers or companies, with annual totals of 85 (2021), 961 (2022), 782 (2023), 989 (2024), and 548 (2025 to date). Since 2023, nine drivers have been fined for refusing passengers with assistance animals, and two drivers have been disqualified over the five-year period. The Commissioner also fined DiDi approximately \$100,000 for non-compliance and is currently pursuing legal action against Uber for alleged breaches involving unauthorised passenger services.

Question 66 – Questions to the Point to Point Commissioner

In the last 5 years, has the Commission received any complaints regarding discrimination, harassment, abuse or fraud involving passengers identifying as having a disability?

- (a) If yes, how many were referred to NSW Police?
- (b) How many were referred to Anti-Discrimination NSW?

Answer

The Point to Point Commission investigates incidents and complaints relating to offences under point to point transport law and where can commence legal action such as prosecution. For matters outside point to point transport law, the Commission's authorised officers may also advise complainants to report matters to the NSW Police.

Complaints relating to matters such as harassment, abuse or fraud are handled by NSW Police. Anti-Discrimination NSW is the state body responsible for handling complaints relating to disability discrimination.

Question 67 – Art Gallery of NSW

Given the \$7.5 million budget shortfall for the Art Gallery of NSW comes at a cost of some 51 roles with many in vital front facing public interaction roles, why has action not been taken to address this?

- (a) When did the government first inform the Art Gallery of NSW about the budget shortfall?
- (b) What communication has the government had with the Trustees about this?

Answer

I am advised:

The Art Gallery is taking action to align operating expenses with its budget (composed of government allocation and self-generated revenue). With the proposed changes there will be a reduction in roles. A staff consultation process is underway.

- a. The NSW State Budget was handed down on 24 June 2025. The Art Gallery of NSW reviewed various proposed scenarios following delivery of the budget and is now working to achieve a break-even budget and spend within its government allocation and self-generated revenue.
- b. The Minister for the Arts met with the President of the Board of Trustees, Michael Rose and Director of the Art Gallery, Maud Page (among others) in July 2025 to discuss the Art Gallery's budget.

Question 68 – Art Gallery of NSW

What is the government's understanding of the vision for the Art Gallery of NSW's restructure?

- (a) Is the Art Gallery of NSW intending to outsource in order to meet shortfalls with project budgets?
- (b) Given that the re-structure is resulting in the reduction of specialist staff and reduced skills and capacity in the arts sector, what is the Minister doing to address these impacts?

I am advised:

Decisions regarding the organisational structure of the Art Gallery of New South Wales fall under the responsibility of the Director and the Executive team of the Art Gallery. Like all cultural institutions and other organisations, the Art Gallery must respond to the changing environment, stay within its budget and operate sustainably. To achieve this, the Art Gallery needs to make ongoing savings and plan for the future.

The Art Gallery is undertaking consultation with staff on a proposed structure to ensure resources are aligned with government and operational priorities.

The proposed organisational change reflects operational requirements, future programming and ambitions for the Art Gallery, its collections and its audiences.

- (a) Outsourcing is not part of the proposed structure, however staff consultation is still underway, and it would be inappropriate for the Art Gallery to speculate on the final structure or resourcing while that staff consultation process is ongoing.
- (b) Change is a normal part of any organisation's evolution. The Art Gallery is stable and focused, with a strong executive team committed to delivering its vision. The Art Gallery will continue to deliver a visionary and exciting annual program, including two major winter exhibitions and two major summer exhibitions.

Question 69 – Art Gallery of NSW

Does the government determine how the Art Gallery of NSW manages its operational budget?

(a) Does the gallery have the ability to make decisions about how much of the operational budget is spent on staffing?

Staff consultation on the proposed structure is currently taking place. It would be inappropriate for the Art Gallery to speculate on the final structure or resourcing while the staff consultation process is ongoing.

Through extensive consultation and analysis, the Art Gallery can confirm that all impacts arising from the organisational change are being carefully and properly considered.

(a). Programming will need to be adjusted in line with the new structure to support achievable program delivery and ensure staff workloads are sustainable. The Art Gallery will continue to deliver a visionary and exciting annual program, including two major winter exhibitions and two major summer exhibitions. From next year, for example, the exhibition schedule will be adjusted to lengthen the duration of exhibitions in line with the practice of other global art museums.

The proposed structure shows cuts to Cultural Gifts coordination. Cuts to editing have a serious impact on curatorial changeovers and publications, which will again impact on delivery to the public and the broader art community – how have these likely impacts been considered and appropriately dealt with to ensure the proposed cuts do not have a negative impact on the operations of the gallery?



I am advised:

- (a) Development costs and cost-benefit analysis for these locations have not been prepared by government.
 - The Central Coast Studios is a private development that has not been funded by government. Information relating to this project is held by the developer.
 - Financial and economic analysis regarding the future use of the Paints Sheds at North Eveleigh as a film studio has not been developed by government.
- (b) Government is currently considering options to determine the location of a film studio in Sydney that will guide a future process.
- (c) The allocation is currently 40 per cent for Made in NSW and 60 per cent for the Post Digital and Visual Effects and Digital Games rebate.
- (d) The NSW Screen and Digital Games Strategy 2024-2027 sets out "success measures" including targets for employment in the screen industry in NSW. Screen NSW will undertake annual public reporting of available data.

Question 301 - ACFP Reform Results and Regional Impact

Legacy multi-year funding commitments - \$11,046,932

This amount will also be committed in 2026-27 with indexation applied to the nine 4+4 year and 82 4-year funding recipients and two legacy Key Festivals.

(c) 11 organisations who had previously held annual funding and applied were unsuccessful in securing multi-year funding.

(d) The total successful multi-year funded organisations in Sydney (including Western Sydney) is 89, with a dollar value of \$32,910,182. The number of successful multi-year funded regional NSW organisations is 69, with a total dollar value of \$111,527,970

Question 302 – ACFP Reform Results and Regional Impact

- (d) This data is not collected.

- (c) Applications to the 2-year multi-year funding round are assessed and recommended by Artform Board members who are industry experts.

(d) The measurable outcomes from the \$15.4 million investment include access for regional, Western Sydney and metropolitan Sydney audiences, employment of artists and arts workers, mentorship and career pathway development, leveraging of additional funding sources and the number of activities delivered. These will be collected through the acquittal process.

Question 304 – Western Sydney Arts Plan Accountability

The Plan for Western Sydney Arts, Culture and Creative Industries 2025-2028 was announced July 29, 2025, with \$5 million funding:

- (a) This statement refers to arts and cultural investment across multiple funding sources as identified in Western Sydney University's 'Unleashing Creativity' report, in addition to feedback received from consultation undertaken during the development of the *Creative Communities* policy. A comparison with regional NSW is not available.
- (b) Specific targets on Create NSW's investment in Western Sydney will be set as part of the implementation of the plan.

Question 305 - Western Sydney Arts Plan Accountability

The government claims \$380 million in cultural infrastructure investments in Western Sydney:

- (a) What is the breakdown of this \$380 million by specific project, location (including address and LGA), and timeline?
- (b) How much of this \$380 million represents new 2025-26 budget allocations versus previous commitments or announcements?
- (c) Which projects have experienced cost overruns or delays, and what are the revised budgets and completion dates?
- (d) What measurable community engagement targets exist for each major infrastructure project?

Through the Western Sydney Infrastructure Grants Program, the NSW Government has committed \$160 million for building a lyric theatre as part of the Riverside Theatres redevelopment in Parramatta, a 350-seat theatre in Campbelltown and a new cultural centre in Blacktown.

It has also committed \$78.5 million for Western Sydney University to develop an Indigenous Centre of Excellence at its Parramatta South Campus, \$20.3 million for the Burwood Urban Park and Arts and Cultural Centre and \$21 million for a new civic park and state of the art performance space in St Marys.

The NSW Government has further invested across a range of arts and cultural projects in Western Sydney – details of all projects can be found at: https://www.nsw.gov.au/grants-and-funding/western-sydney-infrastructure-grants-program/project-information.

Question 306 – Summit Costs and Commonwealth Engagement

The Art of Tax Reform Summit scheduled for September 26, 2025 at Sydney Opera House:

- (a) What is the total budgeted cost to NSW taxpayers for this summit? Please provide an estimated breakdown including by venue hire, catering, accommodation, and travel subsidies for interstate attendees?
- (b) How many submissions were received by the original 10 August 10 2025 deadline and what was the breakdown by stakeholder category (artists, organisations, tax experts, etc.)?
- (c) How many people have been invited to attend, and what were the selection criteria for invitations?
- (d) Which Commonwealth Government representatives have confirmed attendance, and what authority do they have to make policy commitments?

Answer

I am advised:

- (a) The total cost will be confirmed following completion of the summit.
- (b) More than 305 submissions have been received. This is the third largest number of submissions received on a Have Your Say engagement since 2020. Submissions have been received from a range of stakeholders, including artists, organisations, tax and economic advisers and other interested parties. Over half of these submissions were received by 10 August 2025, with the deadline extended at the request of a number of stakeholders.
- (c) The total number of invitations will not be known until after the event is held, noting ongoing interest from stakeholders to attend. Everyone who made a submission or completed the survey on the Have Your Say website (and chose to provide contact details) was considered an expression of interest to attend the Summit.
- (d) The NSW Government is engaging with a range of Commonwealth Government representatives in relation to the Art of Tax Reform Summit, including: Creative Australia, the Treasury, the Board of Taxation, the Australian Tax Office and the Office for the Arts. Insights from the Summit will be used to help unlock opportunities to improve the tax system to support Australian creativity.

Question 307 – Summit Costs and Commonwealth Engagement

For the tax reform proposals being developed:

- (a) Which specific reforms does NSW Government plan to advocate for (Live Theatre Tax Offset, live music venue rebates, arts prize tax review), and what economic impact modelling has been conducted?

- (b) This project is being undertaken using existing agency budgets.
- (c) The Summit will produce recommendations for the next National Cultural Policy, due in 2028.
- (d) Outcomes of the summit will be publicly released in late 2025. The NSW Government will continue to engage with the Commonwealth Government, State and Territory Governments and other stakeholders on opportunities to unlock opportunities to support creativity including by improving the tax system.

Question 308 – Creative Industries Connectivity and Innovation

The inaugural Creative Industries Connectivity Grants program allocated \$500,000 to ten recipients:

 - Sydney (excluding Western Sydney) = 5
- (b) Success will be evaluated against the short-term outcome of the program to create new collaborative opportunities between arts and cultural organisations and creative industries. Other outcomes and longer-term measurement will be undertaken when the outcomes have had time to be realised.
- (c) Evaluation criteria for the program include the realising of new collaborative opportunities, the benefit seen from the funded programs and appetite for future partnerships created.
- (d) Create NSW is still considering the 2026-27 program.

Question 309 – Creative Industries Connectivity and Innovation

For specific funded connectivity projects:

Regarding the Createability internship program for artists with disabilities:

Employment outcomes were tracked with past interns through follow-up interviews and a survey, contributing to an evaluation of the program.
- (d) In 2026, the program will offer the option of four longer internships of up to eight-weeks equivalent with select organisations (grants of \$12,160), in addition to 12 four-weeks equivalent roles (with grants of \$6,080). The budget is \$150,000.

- (b) For Create NSW, in the 2024-25 Regional Arts Touring rounds there were 16 potential Conflicts of Interest across 94 applications. Of these, seven were found to be real Conflicts of Interest, meaning that the panel member left the room for the discussion of that applicatio0n and any relevant ranking discussion. Conflicts of Interest are noted prior to the assessment meeting, recorded in the governance minutes and managed in accordance with the NSW Government's Grants Administration Guide.
- (c) For Create NSW, Conflicts of Interest are managed prior to any funding decisions to ensure no remediation needs to happen.

- (c) For Create NSW to date, no such investigation has been required.
- (d) For Create NSW, personal, professional, or financial connections with arts companies or regional venues are disclosed by assessors as both real and perceived Conflicts of Interests. These are managed in accordance with the Grants Administration Guide and independent probity advice.

In addition, they are provided with an assessment matrix to ensure assessment against the published criteria informs all scoring.

(d) There have been no probity issues identified. Should probity issues arise they would be managed in accordance with departmental procedures and the NSW Grants Administration Guide.

 - limited or irregular programming of contemporary live music
 - live music not being the primary function of the business

- not holding a lease or occupancy agreement with at least two years remaining from the application close date (where the premises are not owned by the operator).
- (c) No recipients of Sound NSW venue grants have closed.

- (a) Employee Related expenses for the Department of Creative Industries, Tourism, Hospitality and Sport are available on page 4-2 of 2025-26 Budget Budget Paper No. 4 Agency Financial Statements 04 Creative Industries, Tourism, Hospitality and Sport. The employee expenses of the Office of the 24-Hour Economy Commissioner along with the other divisions of the department are included here. Information regarding grant programs for the Office of the 24-Hour Economy Commissioner are available at https://www.nsw.gov.au/grants-and-funding
- (b) Since the vibrancy reforms implementation, a total of 553 venues have benefited from extended trading hours and reduced licence fees. The total value of the reduced licence fees is \$4.1 million.
- (c) The Data After Dark platform, created by the Office of the 24-Hour Economy Commissioner, measures the growth of the night-time economy with the following data:
 - **Spending:** Tracks how much money people spend at night (6:00pm to 6:00am), what they spend it on, and whether they pay in-person or online.
 - **Economic Value**: Estimates the yearly total value of all goods and services produced by night-time businesses.
 - Jobs: Calculates the number of people working at night in different locations and industries.
 - **People Movement:** Uses location data from smart devices to count how many trips are made at night and how many visitors are in an area.
- (d) In a Special Entertainment Precinct (SEP), the relevant local council sets sound limits for licensed and unlicensed premises in a precinct management plan, which creates certainty for businesses and the community about how much sound from entertainment activity can be made.

Liquor & Gaming NSW regulates entertainment sound from licensed venues across the state, and councils manage non-licensed venues and other complaints from noise sources such as venue air conditioning or deliveries.

NSW Police also have powers to issue improvement notices to licensed premises in certain situations that require an immediate response.

A council must evaluate the operation of a SEP and can amend a precinct management plan to resolve any ongoing issues with sound conditions or trading hours.

How many 'Vibrant Going Out Districts' are there in NSW from the Office of the 24Hr Economy Commissioner?

There are currently 37 unique Districts funded through the Uptown Grant Program Round 3 across Greater Sydney, Central Coast, Lower Hunter and Greater Newcastle, and Illawarra-Shoalhaven regions.

At 8 September 2025, there are seven Special Entertainment Precincts (SEP) in NSW, which includes a permanent SEP at Enmore Road and six trial SEPs at Balmain, Dulwich Hill, Leichhardt, Marrickville North, Marrickville Town Centre and Rozelle.

In addition, Sydney now also has four accredited Purple Flag areas. This global accreditation program across 100 locations recognises excellence in night-time precinct management across vibrancy, diversity, mobility and safety at night. The Sydney locations are YCK (York, Clarence and Kent Streets, in the Sydney CBD), Parramatta CBD, Haldon Street (Lakemba) and Illawarra and Marrickville Roads (Marrickville).

Question 375 - Neon Marketplace

How many 'Vibrant Going Out Districts 'are there in regional NSW?

Answer

The Uptown Grant Program Round 3 expanded beyond Greater Sydney in FY2024-25, with \$3,021,196 awarded to 16 regional Districts across the Central Coast, Lower Hunter and Greater Newcastle and Illawarra-Shoalhaven regions. These recipients are currently delivering their 12-month funded projects for completion by 30 June 2026.

There are no Special Entertainment Precincts (SEPs) established yet in regional NSW; however, six regional councils have resolutions to establish or investigate a SEP in their Local Government Area. Byron Shire Council, Goulburn Mulwaree Council and Tamworth Regional Council received funding under the SEP Kickstart Grant to establish SEPs.

Agencies are required by section 59ZD of the *Privacy and Personal Information Protection Act 1998* (PPIP Act) to prepare, publish and make publicly available a data breach policy. The PPIP Act does not provide for the internal register to be made public.

Under clause 17 of Schedule 1 to the *Government Information (Public Access) Act 2009*, it is conclusively presumed that there is an overriding public interest against disclosure of information contained in a document prepared for the assessment of an eligible data breach under the PPIP Act, Part 6A, if the information could worsen a public sector agency's cyber security or lead to further data breaches.

All Ministers are expected to comply with their obligations under the NSW Ministerial Code of Conduct (Ministerial Code) at all times. The Ministerial Code sets the ethical standards of behaviour required of Ministers and establishes practices and procedures to assist with compliance.

Among other matters, the Ministerial Code requires Ministers to:

- disclose their pecuniary interests and those of their immediate family members to the Premier
- seek rulings from the Premier if they wish to hold shares, directorships, other business interests or engage in secondary employment (known as 'prohibited interests')
- identify, avoid, disclose and manage conflicts of interest
- disclose gifts and hospitality with a market value over \$500.

A substantial breach of the Ministerial Code (including a knowing breach of any provision of the Schedule) may constitute corrupt conduct for the purposes of the *Independent Commission Against Corruption Act 1988*.
