Jillian Segal Recommendations

UNSW is committed to providing our students and staff with a positive, safe and rewarding experience at our university, and the best possible environment in which to learn, study and work.

The Special Envoy was appointed by Government to produce her report, and the Government has not yet responded to its recommendations.

Needless to say, political criticism of Israel, however inflammatory or adversarial, is not by its nature criticism of Jews in general or based on Jewish racial or ethnic identity...The conclusion that it is not antisemitic to criticise Israel is the corollary of the conclusion that to blame Jews for the actions of Israel is antisemitic; the one flows from the other."?

No. The university sector has sought to adopt a common definition of antisemitism, approved by Universities Australia (UA). This UA definition is a good faith attempt by the university sector to reconcile a working definition of antisemitism with our legal obligation under the French Model Code.

UNSW's Anti-racism and Anti-religious Vilification Policy does not include a single source definition of antisemitism. The policy provides supporting and reference information that includes links to:

- 2. the Jerusalem Declaration on Antisemitism; and
- 3. the UA Working Definition of Antisemitism ("Statement on Racism").

We do not have plans to 'indigenise and decolonise' the university curriculum.

There have been no job cuts over the last 12 and 24 months respectively.

UNSW typically reviews and approves proposals to suspend or disestablish ("cancel") programs a year in advance of any such suspension or disestablishment having effect.

Faculties are well aware that decisions about disestablishing (moving to teach out) or suspending (temporary closure of applications for a year) must be made well in advance with careful consideration of transitional arrangements for existing students and pipeline applicants.

UNSW carefully monitors program quality and student demand and makes adjustments accordingly. In a considerable number of cases, any disestablished programs are replaced by similar programs which better address the needs of students and employers.

(47) How many courses have been cancelled mid academic year, 2023, 2024 and 2025? (a) What impact has this had on students, including financial, emotional and social?

Due to our current trimester calendar, there is no clear 'mid-year' point at UNSW. However, in 2023, there were three courses where the decision to disestablish the program was approved in the same year that the disestablishment took effect (i.e. programs were closed to applicants immediately and entered into the teach out period). There were three in 2024 and five in 2025.

Wherever possible, UNSW reviews and approves proposals to suspend or disestablish ("cancel") programs in the calendar year ahead of the year the program is either suspended or disestablished.

(48) How has the University measured or assessed the impact?

The University's governance processes require careful consideration of potential impacts on students and applicants. Any changes are planned with sufficiently long implementation timeframes and typically include structured teach-out periods for existing programs and rules, ensuring continuity and minimising disruption.

(49) How has the University assisted students, addressing financial, emotional and social impact and needs?

The University carefully considers the impact of suspending or closing a program on current students, applicants, and offer holders. Impacted students are identified and supported with tailored study plans to help them finish on time. Where new programs are introduced, students are usually given the choice to transfer or remain in their existing program. These processes prioritise the student experience while ensuring compliance requirements are met.

Students can access UNSW Student Advisors for personalised support with wellbeing, study habits, appeals, and financial hardship. Advisors connect students with appropriate services, including Psychology & Wellness, 24/7 Mental Health Support and the UNSW Health Service. Dedicated support is also available for Indigenous, international, LGBTQIA+ students, and students with disabilities. Financial assistance includes scholarships, grants, interest-free loans, and access to the Arc-run Food Hub, which provides free food and essentials to ease cost-of-living pressures.

UNSW does not characterise its courses in such terms. Our programs are designed to equip students with the knowledge and skills needed to contribute to their careers and goals, the economy, and society.

(52) What evidence do you have that graduates of these courses secure employment in roles that contribute to NSW's economy?

UNSW graduates have very high employability, ranking number 1 in Australia for employment outcomes according to the 2026 QS World University Rankings. UNSW has been named the AFR's Most Employable University for six consecutive years (2020-2025) and our graduates have the highest median graduate salaries among the Group of Eight universities.

(53) Are there plans to review or adjust course offerings to prioritise disciplines with higher employment outcomes, given taxpayer funding?

UNSW faculties regularly review course (subject) and program (degree) offerings to ensure alignment with industry standards, pedagogical excellence, and societal needs. This includes responding to feedback from students, employers, and government priorities. As part of UNSW's Academic Offerings Monitoring and Review Procedure, programs are assessed for relevance, quality, and viability, taking into account employment outcomes, skill shortages, and emerging market demands. These reviews help ensure that taxpayer-funded education delivers strong career pathways and supports Australia's evolving workforce needs.

Our objective is to upload the agenda shortly after the meeting and the minutes once they have been confirmed at the next Council meeting.

Specific outcomes on submissions are notified to contributors within 7 days of the meeting. Several reports are publicly disseminated following consideration by Council, including the UNSW Sustainability Report, UNSW Modern Slavery Report, annual Gendered Violence Prevention and Response Report, annual Conduct and Integrity reports, and the UNSW Annual Report tabled in NSW Parliament.

- (e) What is the annual budgeted expenditure for the operation of your University's Council/Senate/Board of Trustees?
 - i. Are Council members provided any payments, allowances, or reimbursements for their membership on the Council, their attendance at Council meetings or their participation in Council activities?

The typical annual expenditure budget for Council is around \$25,000 per annum.

Council members are not remunerated for their participation in Council activities. Council members are entitled to claim reimbursement of expenses of items such as travel, telephone and childcare incurred in connection with Council business. Members rarely claim expenses.
