The Commonwealth government recently released new guidelines on the recognition of sex and gender, which "standardise the evidence required to change gender identity" and support the applicable *Sex Discrimination Act* amendments.¹ Among other changes, the new guidelines specify, "where sex and/or gender information is collected and recorded in a personal record, individuals should be given the option to select M (male), F (female) or X (indeterminate/intersex/unspecified)".² The Commonwealth Attorney-General has indicated that he wishes to work with the states and territories to make nationally consistent guidelines.
