### BUDGET ESTIMATES 2014-2015 SUPPLEMENTARY QUESTIONS ON NOTICE FAMILY AND COMMUNITY SERVICES 22 August 2014

#### **Questions from Hon Jan Barham MLC**

1. Has the Government undertaken or commissioned any cost-benefit analysis or other analysis or modelling of the potential longer-term savings (in both Family and Community Services and other Government-funded services such as health and justice) that could result from increased investment in early intervention support services in child welfare, housing, etc.?

(a) If so, please provide details of the work that has been undertaken and its findings.

As with previous NSW Governments, the Government undertakes analysis and modelling on a range of issues to inform government decision making.

2. What funds are dedicated to providing new parent support services for families where there is a history of risk or where there is an identified potential risk?

I am advised by the Department of Family and Community Services that a wide range of non-government organisations deliver prevention and early intervention programs that provide services for families, including new parents.

3. What analysis of data is undertaken to identify districts or localities at risk in relation to child protection issues and what action is being taken to provide services and early intervention?

I am advised the Department of Family and Community Services (FACS) delivers targeted prevention and early intervention services to improve outcomes for vulnerable children and families through twenty-three programs across NSW. Each of these programs has a specific purpose and program parameters that are articulated in the program's guidelines and service provider contracts.

I am further advised FACS reviews District performance through the Quarterly Business Review which periodically assesses whether Districts are meeting goals. FACS is in the process of adopting best practice program management standards across all relevant programs.

4. Given the recommendations of inquiries by both the Community Services Committee and Public Accounts Committee last year that the Auditor-General be granted additional power to "follow the dollar" and evaluate performance of non-government service providers, when can we expect a response from the Government to those recommendations?

(a) What other frameworks and accountability mechanisms are you putting in place given the increasing pace of outsourcing across the human service areas?

I am advised the Department of Family and Community Services (FACS) is currently rolling out a new Contract Governance Framework across FACS Community Services funding programs and Specialist Homelessness Services. The new framework was developed to improve FACS current performance monitoring processes and address issues of risk with service providers.

5. Was the Outcomes Evaluation of Keep Them Safe completed by June 2014 as planned? When can we expect the evaluation report to be made available? And given the continuation of funding for KTS programs was announced earlier in the year, what plans are in place for addressing any problems or areas for improvement identified in the evaluation?

The evaluation has recently been received by the NSW Government and is being carefully analysed.

6. Given that achieving increases in the percentage of children and young people reported at risk of significant harm (ROSH) has been made difficult due to the rising total number of ROSH reports (uncorrected proof transcript p. 15), what analysis has been conducted of why reports are rising (e.g., increased reporting rates vs increased incidence of abuse and neglect), what has been found and what actions are being taken to address these rising numbers of reports?

I am advised by the Department of Family and Community Services that changes in reporting are generally linked to extraneous factors driving reporting behaviour such as increased media interest in child protection.

7. The forecast average cost for OOHC per child is forecast to rise from \$43,000 to \$45,000. Does this reflect an increase in the standard unit costing for OOHC services or is there another explanation for part or all of this increase?

I am advised by the Department of Family and Community Services that the forecasted increase is in line with indexation.

8. What role does Community Services have in the delivery of earlier intervention services such as Brighter Futures and Strengthening Families?(a) Does the department have an ongoing role in service delivery for Brighter Futures and Strengthening Families?

The Department of Family and Community Services (FACS) delivers a range of prevention and early intervention programs annually based on a service continuum aimed at reducing the likelihood of children and young people from entering or remaining in the child protection system.

FACS is implementing significant reforms to the child protection legislative and policy including the transition of out-of-home care to the non-government sector, and *Safe Home for Life*. The implementation of localisation will also ensure service planning decisions are made at the local level.

Over the next two years, FACS will be considering how its funded programs can be aligned to support these reforms and be more focused on local needs.

9. The latest Australian Institute of Health and Welfare child protection statistics showed that Aboriginal and Torres Strait Islander children in NSW were 9.5 times more likely to be the subject of a substantiated child protection notification than non-Indigenous children, 11 times more likely to be subject to a care and protection order, and 11.8 times more likely to be placed in out-of-home care. What is being done to address the alarming over-representation of Aboriginal children in the child protection system?

Safe Home for Life will give NSW's most vulnerable children the best chance of a better future. The reforms will ensure that support services work with families earlier and will work with parents to improve their parenting capacity to keep their children safe.

The reforms will also challenge the way FACS works and will consider new and innovative ways to deliver child protection services. By working in close partnership with the sector, FACS aims to deliver a cohesive and culturally appropriate support system that meets the needs of Aboriginal children, young people, their families and communities.

10. It is more than 18 months since the Ombudsman's report on *Responding* to child sexual assault in Aboriginal communities with its 93 recommendations following an audit of the Interagency Plan was released. Are you able to update us on the Government's progress in considering the recommendations and when we might expect a public response to the report?

A large number of the Report recommendations are supported by NSW Government; and a significant number have already been implemented. The NSW Government continues to address the recommendations within the Ombudsman's report and to inform the Ombudsman on progress towards the important issue of achieving a reduction in child sexual assault in Aboriginal communities.

The Department of Family and Community Services (FACS) is working with other agencies to improve direct service delivery and try new approaches to prevent child sexual assault in Aboriginal communities.

11. In the hearing (uncorrected proof transcript p. 6) it was indicated that in the past financial year there were 270 new starts and 359 completions of public housing properties, and in the current year there will be 759 new starts and 443 completions. For each of these total figures, can you please provide a

### breakdown of how many properties started or completed are located in each Allocation Zone?

16. One part of the Going Home Staying Home reforms has been the introduction of Link2Home as a state-wide referral source for homelessness services. However, women's refuges rely greatly on word of mouth due to the importance of confidentiality and safety. What steps have been implemented to ensure access to refuges isn't compromised by their inclusion in the homelessness reforms, particularly given that some services are changing in terms of their providers and potentially in the location of premises?

The tender process as part of the Going Home Staying Home reforms, may result in the closure of a number of women's refuges and youth refuges that are relied on by Aboriginal communities. Many of these services are at the front line of the community's response to domestic violence and the breakdown of family functioning, and it has been suggested that holistic, trauma-informed 24/7 care models are being lost through these reforms. How will the Minister ensure that Aboriginal women and young people will not be further disadvantaged through this process?

The Premier's Council on Homelessness provides advice to the NSW Government on how it can improve its responses to homelessness in the future. It includes positions for representatives with lived experiences of homelessness.

22. Given that we have had two years of uncertainty created by the late finalisation of one-year extensions of NPAH for 2013-14 and 2014-15, what is the NSW Government doing to attempt to ensure an ongoing agreement with the Commonwealth for funding to support homelessness programs?

The NSW Government is actively engaging with the Commonwealth at every opportunity to secure a long term funding source for homelessness.

- 23. What was the amount of FACS expenditure allocated to managing and monitoring the two Social Benefit Bond (SBB) programs in 2013-14?
- (a) What are the budgeted expenditures relating to the SBB programs for 2014-15, 2015-16 and 2016-17?

Social Benefit Bonds are innovative financial instruments that represent a new approach for funding services for vulnerable people. The savings generated from achieving successful social outcomes enables Government to repay the upfront investment and provide a return.

24. What, if any, changes in data collection and recording within FACS have been implemented to support evaluation of the SBB programs?

I am advised the changes in Department of Family and Community Services data collection and recording to support the evaluation of the SBB programs have been minimal.

25. Has the Government developed any strategies or initiatives to act on the recommendations about capacity-building and other issues identified in the KPMG *Evaluation of the Joint Development Phase of the SBB Trial*?

This matter falls within the portfolio responsibility of the Treasurer.

I am advised by the Department of Family and Community Services that there is cross agency coordination on homelessness, including through the Homelessness Interagency Committee which oversights policy and program responses and committees across NSW working to improve collaboration at a local level.

Questions about NSW Health homelessness outreach work and broader questions on the allocation of NSW Health budget should be addressed to the Minister for Health.
