#### QUESTION

Dr JOHN KAYE: Could you take on notice that the Committee be provided with the policy or at least the details of when somebody can access distance education and when they cannot? It is relevant to this inquiry because that is one issue raised by those who are homeschooling as an alternative.

A copy of the *Distance Education Enrolment Procedures 2014* is provided at **Attachment 1.**

CHAIR: Can I add on to this, because this has come through in some of the representations. Some people who are homeschooling would like to connect their children for certain parts of the education process at local schools, for instance the local library or local sporting events. Would the department encourage that or is it discouraged? Given the fact that one of the major themes is socialisation of these children, why would we not encourage openness to that approach in homeschooling?

Mr LENNOX: I guess the current situation is that a student that is enrolled in homeschooling is not eligible in those circumstances. If there were to be a proposal to change that, it is a complex area with resourcing implications and a range of other implications.

CHAIR: Tell me what those complex situations are.

#### **ANSWER**

Children registered for home schooling accessing their local school for some activities would not be formally enrolled in a government school. Some of the complexities this would present include but are not limited to:

#### 1. Duty of care.

The school would owe a duty of care to the student. However with the student not enrolled in the school, it would be difficult to determine what school policies would be applicable to the student and the extent of authority of school principals and teachers regarding the student. For example, application of the department's student discipline policy and work health and safety policy amongst others.

### 2. Resourcing.

School staffing is partially calculated on student numbers. The school's actual enrolments are used for the determination of teacher and school administrative and support staff (SASS) entitlements. The potential impact of homeschooling students accessing the school for some activities on resourcing and staffing levels is unclear and likely variable.

#### 3. Support Needs

The school is responsible to meet its obligations to all students under the Disability Standards for Education.

The school would need to identify, assess, plan and support any additional needs the student may have prior to entering the school site. A proportion of students registered for home schooling have a disability or additional learning and support needs.

#### 4. Maintaining a Safe School Environment

The Department has an obligation to ensure that, among other things, the systems of work and the working environment of its employees are safe. It is also required to obtain and use, as appropriate, information to ensure both the health and safety of its employees at work and of others who come onto Departmental sites.

Principals would be required to assess any risk a homeschooling student accessing the school site may present. Prior to access occurring, information that is relevant to a risk assessment would need to be gathered and assessed. The application of part 5A of the Education Act (1990) which deals management of health and safety risks posed to schools by a student's violent behaviour, to homeschooling students accessing the school site would likely be complex.

#### The issues would include:

- the need for the school to have authority to have access to all relevant health and safety information pertaining to the student,
- making informed decisions if the student was not under the supervision on a daily or regular basis by teachers in that they current have an understanding on skills and abilities of students based on their day to day involvement with them.
- the student may have a behaviour history that if not clearly provided by parents or carers the school would potentially be accepting the responsibility for the student without having all the required information which may place the student or others at risk.

#### 5. Curriculum Delivery

There is need to plan schooling around the effective delivery of curriculum to all students. The ability of homeschooling students to move in and out of the school setting may impact on school planning and the effective delivery of curriculum.

The Hon. CATHERINE CUSACK: Following on from a question asked earlier by Dr Kaye about distance education, would you also be able to provide us with details of the postcodes of students who are enrolled in distance education and the numbers? It would be interesting to see, for example, how many students and from which postcodes?

#### **ANSWER**

The postcode enrolment data for full time distance education has been aggregated from post offices to postal exchanges due to the volume of data. This gives general areas of enrolment across NSW and the ACT. The data is for full time students only and does not capture single subject provision or students travelling overseas or within Australia.

Data is not available from North East Public School of Distance Education (Port Macquarie).

Data for Broken Hill School of the Air was not collected, however their enrolment profile can be assumed as homogeneous and is considered as Far West NSW.

A breakdown of available data for students enrolled in distance education by mail delivery centres follows.

The Hon. CATHERINE CUSACK: How are you enforcing compulsory schooling in relation to homeschooling and have you ever taken any actions in relation to that?

Mr WATERHOUSE: It depends on what you mean in relation to homeschooling. If someone is—

The Hon. CATHERINE CUSACK: Registered.

Mr LENNOX: —registered for homeschooling there is no reason to take action.

The Hon. CATHERINE CUSACK: But how are you enforcing it? They might be registered but it might not be happening.

Mr WATERHOUSE: That is a question for the Board of Studies as to its monitoring.

The Hon. CATHERINE CUSACK: No, I am asking you because you are responsible for compulsory schooling.

Mr WATERHOUSE: A person who is registered by the Board of Studies as a homeschooler is meeting their compulsory schooling obligation.

The Hon. CATHERINE CUSACK: How do you know?

Mr WATERHOUSE: That is by definition. One of the two elements of the definition I read out under section 22 is that you are either enrolled and attend a government school or you are registered as a homeschooler. If you are registered you are compliant with the Act. We do not go behind that in terms of regulation.

The Hon. CATHERINE CUSACK: The regulation assumes that you are being educated. There is no way of questioning whether or not you are being educated?

Mr WATERHOUSE: From a regulatory point of view, no. But the way of examining it is that the Board of Studies has a responsibility of determining whether they should or should not be registered under its criteria.

The Hon. CATHERINE CUSACK: So you would rely on the Board of Studies to deregister them if the board felt they were not being educated? Is that how it would work?

Mr WATERHOUSE: Correct.

Mr LENNOX: As I indicated earlier, if the board indicates that it has refused registration then we follow that up at the local level with our home school liaison team to make sure—

The Hon. CATHERINE CUSACK: Have you taken action in those cases?

Mr LENNOX: I indicated earlier that there are some matters in which we have taken action.

The Hon. CATHERINE CUSACK: Can you take that question on notice and get back to us with the details?

Mr WATERHOUSE: In 2013, 79 matters and in 2014, 54 matters have been referred to home school liaison officers. Of those, in 2013 six were referred to the Children's Court in relation to the process I outlined earlier and four in 2014 so far. Of those going to the Local Court, two have gone to the Local Court and four in the current year have gone to the Local Court—

The Hon. CATHERINE CUSACK: But are those cases registered for homeschooling?

Mr WATERHOUSE: Those are cases of people who are not meeting the compulsory schooling requirements. So they are not registered for homeschooling, they are not enrolled.

The Hon. CATHERINE CUSACK: I am only interested in the subset registered for homeschooling. They are the statistics I am asking you about.

Mr WATERHOUSE: There are no people who are registered for homeschooling who are prosecuted or taken to the court because they are meeting the requirements of compulsory schooling.

#### **ANSWER**

These questions relate to students deregistered from home schooling by the Board of Studies, Teaching and Educational Standards (BOSTES) and are answered in the supplementary questions.
