- 1. What funds are allocated to informing the community of the opportunity to move to an individualised service package under Living Life My Way reforms?
 - a. What would be the time frame for the transfer?
 - b. What would be the time frame for someone expressing an interest and then moving to a new package offering individualised supports and direct funding?
 - c. Will all clients have the ability move to individualised supports, irrespective of the program they are currently funded for?
- 2. What funds are available to ensure checks and balances are in place to ensure that current service providers such as the Homecare Service of NSW, are suitably ready for the paradigm shift in service provision under Living Life My Way and Disability Care Australia, offering the flexibility of individualised funding?
- 3. What funding for training will be available for staff on frontline services to ensure they understand the rights of people with a disability receiving services with all the benefits of the current reforms?
- 4. What performance measurement will the NSW government be implementing to ensure organisations have received the right levels of education and training especially frontline staff to assist clients to maximise their choices through individualised funding?
- 5. In the 2013-14 NSW Budget the Ageing, Disability and Home Care announced \$208 million for community care services for home based assistance for people aged under 65. Can you outline the types and number of services this will cover?
 - a. How does this compare to the previous financial year?
 - b. How many new clients will be assisted for the current financial year?
- 6. Can you specify all the accommodation settings the \$16 million will be spent on under the Fire and Safety Program for this financial year?
 - a. Is this allocation (\$54 million over four years) part of the Ageing & Disability budget or does it come another portfolio?
- 7. Please provide information on how the \$25 million is being spent under the Industry Development Fund? Can you provide a breakdown of all the funding allocations under the Industry Development Fund?
- 8. The National Disability Services website provides only a small amount of information on the Industry Development Fund. Why is there not more coverage detailing the types of projects taking place under the Industry Development Fund?

- 9. Will those young people currently housed within residential aged care facilities be eligible for Disability Care Australia as it rolls out across the state?
 - a. How much is being spent on accommodation under the YPIRAC program for the current financial year?
- 10. There is currently a severe lack of suitable accommodation facilities to house young people with significant disabilities. Under the YPIRAC program, what funds for new accommodation facilities are to be built to support people with disabilities under the age of 65 moving out of residential aged care facilities and where will they be located?
- 11. During the 2012 Budget Estimates hearing we learnt that the distinction between the Attendant Care Program and High Needs Pool would disappear. Given the current differences between the two services, when is this likely to occur? Can you provide a time frame on this and what funding changes have occurred in relation to this change?
- 12. As of June 30, 2012 there were 429 applicants on the Service Needs Register within the Attendant Care and Physical Disability Unit. How long are they likely to wait for a personal care package?
- 13. With significant changes taking place across disability services that will offer the possibility of individualised funding, what work has been done to communicate the changes occurring to service users so that they can make an informed choice?
- 14. Can you provide information on how much money has been spent from the \$5 million Consumer Development Fund and the types of supports being provided under the program?
- 15. Can you explain the scope of My Choice Matters? What is the reach in terms of the numbers gaining access to training and information?
- 16. Part of the training under My Choice Matters will include a leadership program. What will this involve?
- 17. What other programs are available for people to access under that Consumer Development Fund?
- 18. What funding is allocated for the 300 new places for 24/7 supported accommodation? There are 888 people registered on the Immediate Need register for 24/7 supported accommodation waiting an average of 848 days for a place. This is a significant period of time. Will the 300 new places for this financial year address this demand?
- 19. There has been a great deal of demand for places in supported accommodation for a number of years. What is being done to reduce the numbers on the waiting list?
 - a. Will the new money coming in under Disability Care Australia go some way in meeting the needs of people in this area given the long waiting times?
- 20. How many people moved directly from the family home into supported living for the current financial year?
- 21. Applications are being sought for the third and final round of the Supported Living Fund between Monday, June 24 and Friday, August 30, 2013. Can you please explain why this is the final round as

stated on the website? Does this have anything to do with the gradual rollout of Disability Care Australia?

- a. How many new applications will be accepted in this round?
- 22. To date, how many individuals are receiving assistance through the Supported Living Fund and what is the budget allocation for this program?
- 23. The Westmead, Rydalmere and Riverside Centres are currently under redevelopment. Can you advise on the allocation of funds for these projects and provide an update on these facilities in terms of the progress of the redevelopment?
 - a. How will the nature of the accommodation change from the current model of a large residential centre?
- 24. The ADHC website states that the new model of accommodation will "provide a home like environment, with more privacy, flexibility in daily living and opportunities for increased participation in the local community." Can you explain further on what this means for residents?
- 25. What does "flexibility in daily living" mean? How will this improve the quality of life for residents of this accommodation model?
- 26. What funds have been allocated to promote the Payroll Tax Rebate Scheme Disability Employment?
- 27. This year the Legislative Council passed a motion calling on the Government to consider lowering the Seniors Card eligibility age to 45 years for Aboriginal and Torres Strait Islander people.
 - a. Will the Minister outline whether the agency has commissioned a review of NCOSS figures which suggest such an eligibility change would cost approximately \$2 million per annum?
 - b. Has the agency undertaken a social or economic impact analysis of lowering the Seniors Card eligibility age for Aboriginal and Torres Strait Islander People?
- 28. The Ageing Grants Program is being reformed under the Ageing Strategy.
 - a. Will the Minister indicate what the budget allocation for the Ageing Grants Program has been for the last financial three years and whether there has been any CPI indexed increase in Ageing Grants Program funding?
 - b. What is happening with this program?
 - c. Is money being allocated for programs in its absence?
- 29. Will the Minister advise of what consultation and involvement the agency has with the Department of Planning and Infrastructure on the *State Environmental Planning Policy (Housing for Seniors or People with a Disability) 2004*?

- 30. As older single women are seen to be a growing group in the community at risk of homelessness, will the Minister indicate what targeted strategies the Government are developing to help this demographic more effectively access affordable housing?

- 31. Will the Minister advise what funding is available to support grandparents in the Grandparent Support Group Project which is a project aimed at strengthening and supporting grandparents who provide care?
 - a. Is funding available to print the newly created Grandparents Raising Grandchildren A Networking Resource?
- 32. The NSW Elder Abuse Helpline is operated and managed by Catholic Community Services and is funded to support people aged over 65 experiencing abuse. According to Combined Pensioners and Superannuants Association (CPSA) Catholic Healthcare has over 7,000 clients across aged and community services settings.
