- 31. It has been indicated that the Labour Expense Cap will reduce the rate of growth and avoid additional labour costs of around \$2.2 billion across all government agencies.
 - a. What is the specific Labour Expense Cap for education and training services?
 - b. What does this equate to in terms of specific staff positions?
- 32. Is it true that the business case for LMBR is based on a saving of approximately 1,600 SASS positions in schools? When will these positions be removed and how is this factored into the Department's Budget? How many SASS positions will be removed from schools at the start of the 2013 school year?
- 33. The Minister for Education has previously stated that \$80 million would be required over 4 years to implement the new Board of Studies syllabuses in English, Mathematics, History and Science. How much money has actually been allocated for their implementation?
- 34. The Government has made significant cuts to the number of staff who currently support both professional learning and curriculum implementation. Please outline:
 - a. The savings achieved by these cuts?
 - b. The funding which will be provided for a structured program of professional learning to support the implementation of the new syllabuses?
 - c. Whether or not professional learning will occur in school time?
- 35. In addition to professional learning opportunities, teachers will require both resources and additional time to ensure that the new syllabuses are implemented in a way that best supports the learning needs of students. Will the Minister outline how much funding has been allocated to meet this objective?
- 36. Implementation of the new syllabuses, particularly in primary schools, will require significant improvements in physical resources to ensure safe storage and teaching spaces as well as the

purchase of equipment and consumables. Will the Minister assure teachers that funds will be allocated to ensure there is a significant improvement in the physical and other resources necessary to implement the new syllabuses?

- 37. Can the government assure teachers in NSW that the cost of implementation of the new syllabuses will not be transferred directly to schools?
- 38. Will the government ensure that funding for consultancy positions will be restored to support syllabus implementation in NSW schools?

What strategies have the Minister for Education and his Department initiated or continued, to ensure that the risks faced by transsexual and intersex young people who are affirming their true gender-identity, in relation to discrimination, vilification, victimisation and physical violence are minimised?

- 40. What data was relied upon by the Minister for Education, to justify cutting the Arts education budget on the grounds that "Fine Arts, whilst valued by the community, are areas of low employment growth"?
- 41. The NSW Commission for Children and Young People has consistently recommended that the ratio of school counsellors to students in Government schools be improved to 1:500.
 - a. What is the current ratio of school counsellors to students in Government schools?
 - b. Will the Minister guarantee that school counsellors are classified as 'front-line' staff, and that there will be no cuts to funding for these positions?
 - c. As the Minister is aware, the Department of Education and Communities commenced a review of school counselling services available to NSW public schools in 2011.
 - i. What is the status of this review?
 - ii. Will the report on the review be publicly available?
 - iii. If so when? If not why, not?
- 42. To date, how many P6 schools have been told by the Department that they will be closed in 2013? Please provide a list of those schools. Please indicate which schools will be closed permanently and which schools will be "in recess" in 2013.
- 43. Can the Minister confirm whether it is Departmental policy that, despite provisions in the Privacy and Personal Information Protection Act and the Health Records and Information Privacy Act, families do not have the right to determine who can share sensitive and personal health information within the NSW public school system?
 - a. If yes, is it true that the same applies for students' counselling records?
- 44. Are there any plans to amend the policy that refuses families the right to determine who can share sensitive and personal health information within the NSW public school system to reflect the intentions of the Privacy and Personal Information Protection Act and the Health Records and Information Privacy Act?

- a. If not, why not?
- b. If yes, please outline what steps have been taken.
- 45. What steps has the Minister taken to protect the Adult and Community Education industry in NSW from damaging entitlements based funding reforms like that experienced in Victoria?
- 46. A letter sent to John Kaye by Mr Piccoli (reference number: RML12/4949, dated 09/10/12) regarding Adult and Community Education, states that Victoria's experience with vocational education and training reform will be considered in developing the government's approach to reform.
 - a. In what way will Victoria's experience be an influence?
 - b. Has the government identified any particular positive or negative developments in Victoria that will be appropriated here in NSW?
- 47. Can the Minister confirm what the current staffing arrangements are for the nine teacher/consultant for students with disabilities in the South Western Sydney TAFE Institute and in particular can the Minister confirm whether it is true that:
 - a. The Teacher/Consultant for students who are deaf and hearing impaired position based at Padstow College has been temporarily filled for 9 years and was recently reduced to 0.5 position with no consultation, change in student numbers or workload.
 - b. The 0.5 Teacher/Consultant for students who have psychiatric disabilities position based at Bankstown College has also been temporarily filled for 9 years.
 - c. The Teacher/Consultant for students who are deaf and hearing impaired position based at Miller College has been temporarily filled for 7 years.
 - d. Two Teacher/Consultants for students who are blind or have vision impairments retired last term with ample notice. One position has been temporarily filled. The other remains vacant.
 - e. The Teacher/Consultant for students who have physical disabilities position at Granville has been temporarily filled for 3 years with casual employees with no qualifications or experience in working with students with physical disabilities. This position was reduced to 0.5 on the advice of the teacher returning from maternity leave.
 - f. There have been no Expressions of Interest (EOI) for these positions since the current manager has been in the position (6 years). Casual employees are instead directly appointed on temporary contracts regardless of qualifications or experience.
 - g. These positions are now renewed on a term by term basis offering no stability to the casual employees acting in the positions and no stability for students with disabilities. These casual employees are contributing to a large extent to the future directions of the disability units at South Western Sydney TAFE Institute.
 - h. Can the Minister confirm whether or not these nine positions are supposed to be permanent positions?
 - i. If yes, what has caused the delay in filling these positions permanently and what steps have you taken to ensure that they are filled as soon as possible?
- 48. For each of the following equity programs in NSW public schools, please provide the budgeted amount and the expenditure for the previous budget year and the budgeted amount for this budget year:

- a. Priority Action Program
- b. Priority Schools Funding Program
- 49. For each of the following items of expenditure within the Non-Government Schools service group, please provide the budgeted amount and the expenditure for each of the four previous budget years and the budgeted amount for this budget year:
 - a. Operating expenses
 - b. Interest subsidies on loans for approved building projects
 - c. Conveyance of school children
 - d. Grants to organisations
 - e. Per capita pupil allowances to primary schools
 - f. Per capita pupil allowances to secondary schools
 - g. Textbook allowances
 - h. Living away from home allowances
 - i. Other (please explain)
