RE: INQUIRY INTO THE NSW TAXI INDUSTRY

I refer to your email of 30 April regarding additional questions taken on notice during my evidence that have not yet been answered. I apologise for overlooking these, and they are set out below.

From Mr Donnelly:

- 1. (Page 22) That question can be taken on notice. What are the approximate costs of running your electronic system in New South Wales?
- A. Cabcharge operates nationally and internationally. The Cabcharge Payment System is set up to operate nationally and cannot be segmented into each individual State and Territory.

Fundamentally, the costs of operating the Cabcharge Payment system comprise capital investment costs and day-to-day operating costs.

Capital investment costs include:

- Investment in a computer system at base office for processing transactions as well as Cabcharge Payment System equipment for installation in Taxis spread across Australia;
- Investment in research and development costs in order to keep the Cabcharge Payment System in the forefront of technology and security measures. A case in point is the investment in the development of the requirements of the 'Chip & Pin' and Contactless capability in the Cabcharge Payment System;
- Investment in respect of purchase of inventories of the Cabcharge Payment System equipment; and
- Investment is also made in respect of computer system back-up capability so that the Cabcharge Payment System is always up and running 24-hours a day and 365-days each year.

The Operating costs include:

- 1 Costs of installation and maintenance of the Cabcharge Payment System located across Australia;
- 2 Telecommunication costs:
- Merchant fee paid for transactions processed via the Cabcharge Payment System;
- 4 Cash flow financing costs; and
- 5 Other related costs eg investigation of complaints by customers, printing and stationery, mail and insurance.

The above costs are in addition to those listed in Annexure A of my letter of 28 April 2010.

- 2. (Page 22) I will repeat the question, which is quite specific: What is the approximate value once again I am not looking for the last cent of the revenue generated for Cabcharge annually by the 10 per cent surcharge?
- A. The value of the revenue generated for Cabcharge annually is disclosed in the Cabcharge Annual Report. For the financial year 2009, the value of the revenue generated was \$87.5m. We have provided Annual Reports for the years 2000 through to 2009. Mr Kahn was *incorrect* in asserting to the Hearing (Page 22 in mid page) that the answer was 'No' to Mr Donnelly's question directed to me.
- 3. (Page 23 regarding an alleged document of contractual arrangements) If it is established that such a document exists and you or the organisation has a copy of it, could you provide it to the Committee?
- A. Our documents are 4-5 pages, mainly reflecting requirements to conform with the specifics of the Passenger Transport Act and Regulations. The only substantial document of any size we believe, was the contractual arrangement required by Lime Taxis on its formation. We do not have a copy of it however.

From Ms Rhiannon:

- 4. Thank you, Mr Kermode. Are you aware that the Cabcharge International's website has advertised that the cost of taking a taxi from Sydney airport to the city is \$88?
- A. I sought details of this and attached are the details which are self-explanatory. It is a UK controlled site aimed at servicing areas common to our UK and Singapore based operations. They rely on Hire Car rates but I believe it would have been sensible to add the price of a standard Taxi to the chart this I intend to arrange. As stated, I was not aware of the site's existence as it was seen as an operational issue by the UK author.

I believe that I have now responded to all outstanding issues and sincerely hope that information provided by me to the Committee has assisted in clarifying a number of matters of concern.




