



## **Project Update**

- Tenders have been called for the provision of professional services for the investigation, design, documentation, project management and site supervision for movement area pavements and lighting upgrade at Narrabri Airport. Tenders will be received up until 2:00pm on Tuesday 15th July 2014.
- Arrangements for the installation of the new aviation fuel facility are progressing. The removal of the existing Avgas facility and site remediation is expected in the coming
- The NSW Rural Fire Service have conducted geotechnical investigations at the proposed site for the new Deep Creek station located at the airport. Tenders for construction are expected to be called in the coming months.
- Integrated 2014-2034 Airport Master Plan has been distributed for review by Line Managers, Directors and General Manager.

#### **Achievements**

- Appointment of full time Airport Manager
- Recruitment for Airport Reporting Officer position has commenced with applications closing on the 30 June 2014.
- First regular flight of Fokker 70 jet aircraft operated by Alliance Airlines on 30 June 2014.

Annual Civil Aviation Safety Authority Surveillance Audit of Narrabri Airport conducted 25-27 June 2014. Report on findings expected by end of July 2014.
