Thank you for your email of 30 January 2006 about Merlin Stock and advice about the unissing. No Stopping sign.

Lagree with you that Merlin Street is an area where much parking abuse happens. We also receive complaints from residents in Merlin Street regarding the parking situation, which has worsened since the Expressway works have commenced. Accordingly the street is regularly patrolled by Council's Rangers.

The missing sign will of course be replaced, although as you know, a sign is not required to enforce at a crossing. The law requires 20 metres in front and 10 metres after be kept clear. In any event, all the vehicles depicted in the phosos you sent have received Penalty Infringenent Notices.

We have been experiencing a major problem in Merlin Street, whereby the RTA contracted too truck drivers pick up broken down vehicles from the Expressway and dump them in the pedestrian crossing area. I have formally raised this with the RTA and as yet have had no response.

Attached are photos taken today of the new Pedestrian Crossing in Merlin Street.

I don't know who approved it, but it is difficult to imagine any professional person being as utterly incompetent as this, in this day and age.

The RTA's "default" No Stopping zone preceding a Pedestrian Crossing is 20 metres. This should never be varied without an independent safety audit, so in the event of a pedestrian injury or death, Council can justify its decision to vary the standard.

On the eastern side of this crossing you have allowed 5 metres.

On the western side you have allowed "zero" metres, preceded by a Work Zone.

Instead, someone has placed a couple of plastic devices which apparently are supposed to get you around the requirements..

They don't.

As usual, safety always comes a long way after commerce and parking.

Especially as this is preceded by a Work Zone where you can expect this location to be occupied by very large trucks, so line of sight will be virtually NIL.

It's abundantly clear that whoever made this decision has been pressured to allow as much parking as possible and safety hasn't even entered the equation. It could hardly be more dangerous with the movement of all these huge earth-moving trucks and vehicles, even B-doubles.

Please read the Court of Appeal (Bussell vs. Canterbury Council) and realise how someone has set North Sydney Council up for a potentially massive (possibly punitive) negligence and damages claim if someone is killed or injured at this very busy location (during the construction phase of the access ramp to the Freeway).





We worked for over 7 years to get this offence raised to the status of Demerit Points. It received unanimous support from all Road Safety stakeholders.

The white vehicle in the middle of the three on the northern side of Merlin Street remains illegally parked (within 20 metres of a pedestrian crossing) without a PIN. Is that because your Rangers believe they require a No Stopping sign before they can issue a PIN for \$225 plus 1 DP? Well they can and they should, especially when there is serious potential for harm like this.

We wrote to you about 6 months ago when your Rangers issued the wrong PINs. It appears they are still at it and require some serious training.

First, let us congratulate you on your new portfolio. We look forward to working closely with you in order to reduce the NSW Road Toll.

We are writing to you in utter frustration.

We note that only a week ago, your predecessor, the Hon Joe Tripodi announced a major review, by the RTA into Pedestrian Deaths (and injuries)

But what is the point, when the same agency shows such utter contempt for pedestrian safety.

The correspondence below is self-explanatory. It involves RTA contractors placing abandoned and illegally parked vehicles in a pedestrian zone.

But the (RTA towed) illegally parked vehicles remain. They have been there since at least 7 January 2006. One has two tickets on it which I suspect the RTA will have to pay.

This is scandalous. No sense of urgency. No sense of duty of care. No possible notion that if someone were killed or injured due to the obstruction caused by these vehicles, the RTA would be liable, possibly criminally negligent. It shows nothing but utter contempt for pedestrian safety. And this is when the pedestrian death toll is already up 40% on last year (copy of yesterday's Road Toll attached -7 more killed over the weekend).

Would you please have these vehicles removed immediately (TODAY if possible) and ensure the RTA has very strict policies that vehicles are not to be towed and parked in pedestrian zones. And discover why there has been absolutely no reaction to the joint please from the Council, the Police and ourselves.

Additionally, perhaps you might like to reconsider who conducts the inquiry into Pedestrian Deaths and Injuries. Maybe an independent study and report would be more appropriate.

Unbelievable. And this is the same organisation that only a month ago announced an inquiry (their own - not an independent) into Pedestrian Deaths and Injuries.

Would you please take a personal interest in this very serious Road Safety matter to ensure it does not happen again.

These photos were taken just over an hour ago. This was not staged. The women pushing the pram told me how dangerous it was there and how trucks were always parking there.

Sgt Dave Olsen called me this morning and informed me he had just booked 3 vehicles there for the \$224 + 1 DP offence. He's doing a fantastic job. The North Sydney Ranger booked 2. I've given up trying to get North Sydney Rangers to properly enforce the law and focus on safety first.

Dave has now issued over 2 dozen tickets for this offence at this location (Merlin Street)

But North Sydney Council Rangers continue to refuse to properly enforce the above offence, preferring the \$175 penalty. I can't get the GM to explain.

As you can see from our Media Release, North Sydney Council has clearly decided to not issue this penalty, which was brought in to try and dissuade this potentially lethal practice.

The number of PINs issued for this offence last year fell from 65 to 9 (first six months compared with second six months). This can't be accidental. Someone has decided to go ultra soft on enforcing this law.

And of course, then you get tragedies like last Friday. The photos attached show you just how potentially dangerous all pedestrian crossings are when line of sight is obstructed.

And the NSW Court of Appeal has left no doubt that Councils must provide adequate line of sight around all crossings (including Pedestrian Refuges). The one in West Street just near the Police station has provide less than a metre for No Stopping. But the Councils cares not a fig. All they are interested in is more and more on-street parking and Safety Be Damned.
