### Questions from the Hon Amanda Fazio MLC

1. In relation to Cruise Ship Statistics:
  - a. What was the Cruise sector's contribution to the State Economy in the 2010-2011 financial period?
    - i. Is it expected to increase in the current financial year 2011-2012? If not, why not?
    - ii. What is the expected increase for the next decade for the industry?
  - b. How many cruise vessels stopped in Sydney and other NSW Ports in the last financial year and how many will arrive this year?
    - i. How much did cruise ship passengers contribute to the NSW economy in the last financial year?
2. In relation to the Visitor Economy Taskforce:
  - a. Minister part of this documents strategy requires establishing a Visitor Economy Taskforce, and to execute the Taskforces strategy (which is to report early next year) requires a boost in funding of \$40 million dollars? 23. In relation to Project Size of the Convention & Exhibition Centre:
  - a. As stated in a answer to a question on notice I asked the Minister for Planning, the newly expanded project will comprise a 12 hectare site. In such a compressed area in the Darling Harbour South Precinct, where are you going to find 12 hectares for the project and do you expect the project to encroach on existing open space?
  - b. Will the new project require the acquisition of any properties not already owned by the NSW Government or Government agencies?
24. In relation to the Sydney Olympic Park alternative to the Exhibition Centre
  - a. What investigations were undertaken to determine whether current Sydney Olympic Park facilities would be suitable for either the maintenance or expansion of its convention centre facilities?
  - b. Do the current Sydney Olympic Park facilities meet the required future industry demand?
  - c. Minister I am sure you have seen plans for improvements to facilities at Sydney Olympic park, is the Government supporting those plans?
  - d. What would be the costs of upgrading currently facilities at the Sydney Olympic Park?
25. In relation to job creation and costs of the Exhibition Centre
  - a. Through the establishment of the Exhibition Centre, what is the expected total revenue for the financial year 2015/16 or even 2016/17?

  - g. What have been the administrative costs so far for the establishment of the tendering process and the Expression of Interest process?
26. In relation to Project Impact of the Exhibition Centre:
- a. Considering the impact of the expected 4 year construction of the project what process will the government undertake to mitigate impacts on traffic and pedestrian use of Darling Harbour. What impact do you expect the project's construction to have on the 26 million tourists who visit this area annually, have there been an assessment of the impact during construction on existing small business operators and have they been informed of the plans.
  - b. Given the \$6 billion Barangaroo Project is to be developed over nearly the same period, what alternative measures have or will be established to allow for commuters and visitors to the Darling Harbour area whilst the construction is taking place in the same 5 year period.

37. Given that the Coalition when it was in Opposition was highly critical of the Homebush event, its handling or mishandling by the then Minister, why is the government accepting the review commissioned by the previous administration?
38. Will the government commission its own review of the V8 Supercars legislation?
  - a. If not, why not?
39. Does the Minister think it is appropriate for the sexist, passé` Chilletes promotion to be permitted at an event sponsored by the state of NSW?

40. In relation to the Thoroughbred Racing Amendment Bill 2011:
  - a. If an applicant for board appointment falls within the 12 month period of membership to Racing NSW the selection panel will refer to a probity officer to determine the individual applicant's compliance. What probity measures and compliance measures will the probity officer use to determine the eligibility to for board membership?
41. In relation to Melbourne Cup on 1 November 2011:
  - a. Did you receive any complimentary hospitality on Melbourne Cup Day?
  - b. If so, from whom?
  - c. Were any people present lobbyists for racing and gaming interests?
  - d. If so who are they and who do they represent?

What specific actions has the government taken to address the proliferation of gambling online and in other places and the proliferation of signage at venues other than licensed venues?
- 46. What is the funding in the 2011/12 Budget provided to the Alcohol Licensing Enforcement Command (ALEC)?
  - a. How does that compare to the previous budget?
- 47. How many compliance officers are currently employed by OLGR?
  - a. Is the Minister satisfied that there are enough licensing officers employed to enforce compliance by licensed venues of the Liquor Act?
  - b. Are there any plans to increase the number of compliance officers employed by OLGR?
- 48. Could the Minister please provide the current list of licensed venues that are on either Level 1 or 2 licensing conditions?
  - a. When does this list expire and a new one created?
- 49. As a possible solution to alcohol-related violence, would the Minister consider modification of licence fees to require each venue to bear a larger proportion of its attributable costs of the policing of RSA and for the impact of the venue and its patrons on the neighbourhood?
- 50. What role does the Minister believe the provision of more late night public transport services would have in reducing alcohol-related violence?
- 51. What upgrades in terms of betting facilities will be included in the redevelopment of the Randwick racecourse?
