Efficiency Dividend

1. For each of the past three financial years, what was the efficiency dividend in dollar value to be met by each of the agencies within your administration?

ANSWER:

The Industry, Resources & Energy portfolio is part of the principal Department (NSW Department of Industry, Skills and Regional Development form 1 July 2015, and NSW Trade & Investment up to 30 June 2015).

Cumulative savings measures for 2014/2015 imposed since the formation of the Department on 3 April 2011 totalled \$42,204,000. This comprised \$5,272,000 of efficiency dividends and \$36,932,000 of other savings measures, including procurement savings, reductions in annual leave and program savings;

Cumulative savings measures for 2013/2014 imposed since the formation of the Department on 3 April 2011 totalled \$34,626,000. This comprised \$Nil of efficiency dividends and \$34,626,000 of other savings measures, including procurement savings, reductions in annual leave and program savings; and

Cumulative savings measures for 2012/2013 imposed since the formation of the Department on 3 April 2011 totalled \$18,998,000. This comprised \$Nil of efficiency dividends and \$18,998,000 of other savings measures, including procurement savings, and program savings.

2. What savings and revenue generating strategies did each agency implement to achieve the efficiency dividend and what was the amount of the savings or revenue actually achieved?

ANSWER:

The Department's budget is reduced by the amount of savings required. Major savings initiatives included labour reforms, cost recovery measures such as the implementation of the Periodic Licencing Scheme, environmental compliance levy, and procurement savings. Savings requirements are met when the Department operates within the adjusted budget, which it did for each of these years.

3. What is the efficiency dividend in dollar value required to be achieved by each agency within your administration for this financial year?

ANSWER:

The Industry, Resources & Energy portfolio is part of the principal Department (NSW Department of Industry, Skills and Regional Development form 1 July 2015, and NSW Trade & Investment up to 30 June 2015).

Efficiency dividends of \$14,847,000 were imposed on the Department as part the 2015/2016 budget process.

4. What savings and revenue generating strategies are you implementing this financial

year and what do you expect to achieve for each strategy?

The Department's budget is reduced by the amount of savings required. Major savings initiatives include labour reforms, cost recovery measures and procurement savings. Savings requirements are met when the Department operates within the adjusted budget. Prior year savings initiatives which have been achieved allow the Department to operate within revised budget baselines for 2015/2016.

ANSWER (5-9):

Coal Seam Gas

- 9. What progress has been made to date in implementing recommendation 3 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 10. When will there be full implementation of recommendation 3 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (9-10):

The Government has tasked the *Independent Pricing and Regulatory Tribunal* (IPART) with investigating and benchmarking landholder compensation rates. IPART released a draft report on this matter on the 22nd of September 2015. This report can be found at: <u>http://www.ipart.nsw.gov.au/</u>

The Government is also implementing a range of reforms in relation to land access including implementing transparent requirements and processes for the selection of arbitrators, and public consultation and release of land access guidelines. The Government is also on track to introducing legislation in 2015 to implement recommendations made by Bret Walker SC in relation to land access.

Separately the Government has recently concluded formal consultation on the establishment of a Community Benefits Fund for communities that will be affected by onshore gas development. 11. What progress has been made to date in implementing recommendation 4 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.

12. When will there be full implementation of recommendation 4 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (11-12)

The Government will undertake an assessment of the whole-of-government cost for the regulation of the coal seam gas industry in the near future. The assessment will take place following the completion of the buy-back scheme and the implementation of new regulations for the industry.

Once the assessment has been completed an annual statement on this matter will be provided as part of the Budget process.

- 13. What progress has been made to date in implementing recommendation 5 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 14. When will there be full implementation of recommendation 5 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (13-14):

Recommendation 5 has already been implemented. The Government has banned CSG activities within 2km of residential areas and protected critical industry clusters. The Government will soon be legislating to establish a Strategic Release Framework for future titles and to take National Parks out of existing titles. Future titles will only be released by the Government following a triple-bottom line assessment of environmental, economic and social factors. Unlike the Labor Party, the whole state will not be open to coal seam gas titles.

- 15. What progress has been made to date in implementing recommendation 6 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 16. When will there be full implementation of recommendation 6 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.

ANSWER (15-16):

NSW will move to establish a single Act for all onshore subsurface resources (excluding water). This will require a number of legislative steps.

- 17. What progress has been made to date in implementing recommendation 7 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?
- 18. When will there be full implementation of recommendation 7 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.

ANSWER (17-18):

Recommendation 7 has already been implemented. The Government has appointed the Environment Protection Authority as the sole authority responsible for compliance and enforcement of consent conditions for coal seam gas activities (excluding work health and safety), separating these functions from the allocation of exploitation rights.

- 19. What progress has been made to date in implementing recommendation 8 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?
- 20. When will there be full implementation of recommendation 8 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.

ANSWER (19-20):

The Government has reviewed all the codes and conditions which regulate the onshore petroleum industry. Updated codes came into effect on 1 July 2015.

This includes the commencement of Improved Management of Exploration Regulation (IMER) which delivers tough new streamlined rules across all onshore exploration activities, the introduction of new minimum standards for petroleum exploration, and the release of the *Petroleum Drilling and Well-Servicing Competencies* guideline.

- 21. What progress has been made to date in implementing recommendation 9 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 22. When will there be full implementation of recommendation 9 the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (21-22):

The Government is examining whether a three-layered security framework could bring additional benefits to the state, noting the existing security fund framework.

- 23. What progress has been made to date in implementing recommendation 10 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 24. When will there be full implementation of recommendation 10 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (23-24):

The Division of Resources and Energy is jointly developing the Environmental Data Portal with the Department of Finance, Service and Innovation (DFS). Phase 1 will be completed in September 2015 which includes a market analysis of existing government portals, resulting in the identification of data assets, user requirements, internal and external specifications, and the development of a Business Review Document with recommendations for Phase 2.

Phase 2 will commence in January 2016 and encompass the portal design, build, and deployment. A Go-Live date is expected for mid- 2016.

The launch of Common Ground also allows the public to easily access a single source of information about exploration and mining activities in NSW.

- 25. What progress has been made to date in implementing recommendation 11 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 26. When will there be full implementation of recommendation 11 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (25-26):

The Government is currently examining the development of a centralised Risk Management and Prediction Tool.

- 27. What progress has been made to date in implementing recommendation 12 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 28. When will there be full implementation of recommendation 12 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (27-28):

Recommendation 12 has already been implemented. On the 11th of August 2015 the NSW Government announced the establishment of the Gas Industry Social Environmental Research Alliance (GISERA) in NSW. GISERA will see the CSIRO undertake regular and constant research into the impacts of CSG projects on the environment and communities. The research will be controlled by an independent, community led board, with all work being made public upon completion.

- 29. What progress has been made to date in implementing recommendation 13 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 30. When will there be full implementation of recommendation 13 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (29-30):

The Government has announced that it is investing an additional \$23m to enhance its ability to map, monitor and protect groundwater resources across NSW. This project started with the Gunnedah, Gloucester and Clarence Moreton basins and is now being rolled out across the state. The mapping results are available online and will support Government, industry and community to quickly identify and respond to pressure on our water resources.

The Environmental Data Portal will also provide open access to broader environmental data relevant to gas extraction. As such, all this work will be available to GISERA.

The NSW Government has engaged GeoScience Australia to undertake a \$1.4 million, three-year CSG Subsidence Pilot Study to investigate the subsidence effects of CSG production. We are also working with GeoScience Australia on a CSG-related Seismic Monitoring Project to check for any indications of increased seismic activity as a result of CSG extraction.

- 31. What progress has been made to date in implementing recommendation 14 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 32. When will there be full implementation of recommendation 14 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (31-32):

Guidelines were released in July on petroleum drilling and well servicing competencies.

- 33. What progress has been made to date in implementing recommendation 15 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 34. When will there be full implementation of recommendation 15 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (33-34):

The Government is ensuring that all legacy matters associated with prior coal seam gas development are being managed – particularly in areas where titles have been extinguished through the NSW Government's PEL buy-back scheme. The Derelict Mines Program has developed a screening and risk assessment process for derelict petroleum wells based on structural integrity and environmental impact. One hundred and ten site inspections were conducted for the highest risk wells

- 35. What progress has been made to date in implementing recommendation 16 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014? In answering this question, please list each discrete action taken.
- 36. When will there be full implementation of recommendation 16 of the final report of the NSW Chief Scientist and Engineer on coal seam gas dated September 2014?

ANSWER (35-36):

This issue will be considered in the development of a single onshore resources Act.

37. Has there been an increase in the number of suicides and mental health occurrences affecting electricity workers in NSW?

ANSWER:

An employer is not always aware, because of privacy laws, of the nature of an employees' medical reasons for being absent from the workplace. A finding of death by suicide is generally a determination of police or the coroner and is not the subject of speculation by employers. There is therefore no reliable information available to answer this question.

A recent report titled "State of Workplace Mental Health in Australia" by Beyond Blue found that "one in five Australians (21%) have taken time off work in the past 12 months because they felt stressed, anxious, depressed or mentally unhealthy." There is no reason to think that electricity network employees would not represent a cross section of the community.

ANSWER:

Notional salary is \$195,205 per annum. Remuneration is \$213,750 per annum.

- 40. Why was the Office of Coal Seam Gas abolished?
 - a) When was this decided?
 - b) Who made the decision?

ANSWER:

The Office of Coal Seam Gas was dissolved on 1 September 2015.

The decision was made by the Deputy Secretary Resources & Energy to integrate the functions back into the relevant functional areas within the Division of Resources and Energy (DRE).

41. Where do the functions of Office of Coal Seam Gas now reside in your portfolio, in which position(s) in which division in which agency?

ANSWER:

DRE remains responsible for the assessment and granting of petroleum titles, activity approvals and the compliance and enforcement of work, health and safety related conditions. These are functions also performed across other classes of mineral commodities.

The Office of Coal Seam Gas ceased to operate formally from 1 September 2015 and its remaining staff have been integrated back into the relevant functional areas within DRE.

42. Which person(s) now exercise the functions of the former Director, Office of Coal Seam Gas? **ANSWER:**

The functions have been absorbed into the relevant functional areas of DRE.

Mental Health of Workers

43. Are you aware of the number of power workers have taken their own life in the past 3 years or had mental health issues including breakdowns and depression?

ANSWER:

See response to Question 37.

44. Minister I am of the understanding that there is a high level of angst felt among power workers due to the amount of workplace change, uncertain futures and severe deterioration of morale as a result of aggressive management. Have you heard these same reports?

ANSWER:

The NSW Government introduced a Network Reform Program in July 2012, adopting elements of a model proposed by the ETU prior to the March 2011 State Election. The objective of the Network Reform Program was to put an end to double digit increases in electricity prices for families and businesses. Change is difficult for any organisation and effective consultation and employee support has been a hallmark of the reform program over the past 3 years.

45. Do you think the risk of suicide and mental health related issues could be reduced in the electricity sector namely at Ausgrid, Endeavour Energy and Essential Energy?

ANSWER:

See response to Question 37.

46. Is it true that in recent times Ausgrid have deployed additional employee assistance program resources to deal with a spike in employees seeking assistance and if so can you please outline what additional services have been made available, when they were engaged and what prompted their introduction?

ANSWER:

Ausgrid, Essential Energy and Endeavour Energy have employee assistance programs to support the health and wellbeing of employees and their families. Each organisation has incorporated mental health awareness programs as part of their employee assistance programs consistent with good practice. As part of its program, Ausgrid engaged the "Beyond Blue" organisation in 2011 and again in early 2014 to provide mental health awareness sessions.

47. Will you and your government commit to doing whatever is necessary to reduce any future risk of suicide or mental illness within the electricity sector?

ANSWER:

Programs are already in place to identify and support employees who may suffer health issues, including mental health issues.

Blue Scope Steel

48. As Minister for Industry, can you please advise what measures, if any, that the NSW Government is undertaking to support the ongoing operation and retention of hundreds of regional jobs at Blue Scope Port Kembla?

ANSWER:

The NSW Government is working closely with BlueScope, the Commonwealth Government, and members of the Illawarra business community to support BlueScope and the Illawarra region during the current period of structural adjustment.

I met with BlueScope management, the then Commonwealth Minister for Industry and Science and local stakeholders on 7 September 2015 to discuss issues relating to the future viability of the steel works. I am considering, in consultation with the Commonwealth, BlueScope and the Illawarra business community, a number of options regarding the ongoing viability of the Port Kembla steel works and the Illawarra Region.

49. If Blue Scope Steel seeks financial assistance from the NSW Government, will you as minister do whatever possible to secure this assistance? What will you do?

ANSWER:

See response to question 48.

Publicly Owned Electricity Companies Employment

- 50. The Electricity Network Assets (Authorised Transactions) Act provides that network operators will "not implement a program of forced redundancies (except by agreement with the affected employees or in accordance with the Fair Work Act)". Why then is Networks NSW, Ausgrid and Endeavour Energy now attempting to introduce forced redundancies without the agreement of the workforce?
- 51. Will you guarantee that a policy of no forced redundancy will be maintained as it was intended under the electricity Network Assets (Authorised Transactions) Act?
- 52. Do you believe that the publicly owned electricity companies should explore every available opportunity to maximise employment opportunities and staff retention including seeking contestable work?

Electricity Generator Authorised Transaction Bill 2012

53. Clause 3, Schedule 4 of the Electricity Network Assets (Authorised Transactions) Act sets out the minimum staffing levels for the industry as follows:-

3 Minimum number of employees

(1) For each relevant period during the employment guarantee period, the number of full time equivalent employees of a network operator must not be less than the appropriate staffing level for the relevant electricity network SOC.

(2) The "appropriate staffing level" for an electricity network SOC is the number of full time equivalent employees that is sustainable in the context of business revenue resulting from the AER Final Determination for the SOC as determined in accordance with the business practices of the SOC, being:

(a) for Ausgrid-3,570 full time equivalent employees, or

(b) for Endeavour Energy-2,100 full time equivalent employees, or

(c) for TransGrid-1,000 full time equivalent ememployees.

Can you confirm that these numbers are of direct employees in filled positions and do not include consultants, contractors or other forms of engagement of labour?

54. Under the Electricity Generator Authorised Transaction Act 2012 Act 2012 section 16 (4) covers future employment of apprentices as follows:

(4) The Treasurer is to take all reasonable steps to ensure that, under the transaction arrangements with all private sector employers, a total of at least 150 apprenticeships is maintained in the electricity generation businesses of those employers in NSW during any employment guarantee period under this section. The timeline for purchases was as follows with the 2 year employment guarantee period for each commencing at the time of sale.

- 1 July 2013 Origin Energy buys Eraring Energy
- · 25 July 2013 Energy Australia buys "Delta West"
- 2 September 2014 AGL buys Macquarie Generation
- 29 December 2014 Snowy Hydro buys Colongra Gas Fired Power Station
- Delta Coastal (Vales Point + Munmorah Development Site) yet to be sold

Draft Wind Planning Guidelines

Federal Renewable Energy Target

 - i. What is the government's understanding of the total investment loss to NSW as a result of a reduction in the RET?

 - iii. How many job opportunities in NSW have been impacted by the cut to the RET?
 - (b) Is the Baird government considering the introduction of a state-based renewable energy scheme in order to address the loss of investment expected as a result of the cut to the RET?

ANSWER:

The NSW Government is a long-time supporter of the Commonwealth Renewable Energy Target. With the RET now settled NSW is well placed to attract significant investment to our state.

Around 2,700 megawatts (MW) of renewable energy projects currently have development approval in NSW. On top of that, a further 5,100 MW of projects are in the planning pipeline.

These projects are worth billions of dollars. NSW can now take advantage and ensure that investment comes here.

129. Of the \$7.3 billion of clean energy projects seeking approval as of August 2014 as noted in the 2014 Renewable Energy Action Plan annual report, how many are exposed to the Renewable Energy Target?

State Renewable Energy Policy

- 130. According to the Renewable Energy Action Plan 2014 annual report, 79.5% of NSW's energy generation came from coal and just 12.9% from renewables in 2013.

ANSWER

Under the NSW Renewable Energy Action Plan, the NSW Government detailed three goals and 24 actions to most efficiently grow renewable energy generation in NSW. The NSW Government is progressing the implementation of the Plan.

The Government has already completed more than a third of the actions, with significant progress made towards the other actions in the Plan. This includes:

- The Renewable Energy Advocate has facilitating the development of projects totalling 3,600 megawatts.
- NSW leveraging over \$582 million of Commonwealth funding for 104 renewable energy projects in NSW.
- The announcement of the NSW Smart Meter Policy, allowing metering providers to offer smart meters to customers as part of energy deals.
- Establishing the NSW Energy Innovation Knowledge Hub to foster research and innovation.

130. Is the Minister committed to a secure, affordable and renewable energy future for NSW?

The Government continues to be committed to a reliable, affordable and clean energy future for the people of NSW.

As part of the recent restructure within the Division of Resources and Energy, the Division now has a team of four professionals (including the Renewable Energy Advocate) dedicated to the development of increased investment and jobs in the renewable energy sector.

Their role is to:

- Promote investment opportunities in renewable energy projects and services
- Grow investment in the renewable energy sector
- Assist companies to achieve positive development outcomes
- Advise investors and provide a link for industry to the whole of Government regarding renewable energy projects and supply chain opportunities.

- 131. According to the Clean Energy Council's 2014 Clean Energy Australia Report, NSW is the poorest performing state when it comes to renewable energy generation, behind South Australia, Western Australia, Victoria, Tasmania, and Queensland.
 - (a) Would the Minister agree with this finding?
 - If not, please provide reasons.

I am advised that the share of generation from wind, solar and bioenergy sources together have more than doubled over the last four years. NSW is a strong performer in solar and is home to Australia's largest solar plant (102MW) at Nyngan, in Western NSW. There are also PV solar plants under construction at Broken Hills and Moree, as well as a concentrated solar thermal plant at Forbes.

AEMO advises that NSW currently has the most installed capacity of small commercial systems amongst the states. Commercial solar has surged in NSW, increasing by 15 times over the past five years. AEMO forecasts this capacity will be doubled by 2020 and reach ten times at 1.5 GW by 2035.

Coal industry

132. How many people are currently employed in NSW

ANSWER:

Information on employment is available from a variety of sources including the companies and Coal Services.

- 133. Which mines in the Hunter region of NSW currently supply fuel to Bayswater coal fired power station? Please provide

 - (d) the amount that is contracted
 - (e) timeframes for those contracts

ANSWER:

This is a commercial matter between AGL Macquarie's Bayswater coal fired power station and its coal suppliers.

Vegetation clearing by electricity companies

134. How is the Minister addressing the concerns of community members regarding the removal of vegetation by the distribution and transmission companies?

(a) Can the Minister please advise whether his office has received complaints of this nature and any response given.

ANSWER:

Effective control of vegetation adjacent to live electricity conductors is important for public safety, bushfire risk management and network reliability. Vegetation clearance is subject to appropriate standards and involves trained arborists in the execution of those standards. The network businesses continue to work with local councils to reduce, wherever possible, the impact on the streetscape associated with necessary vegetation control. Unfortunately, in cases where inappropriate species of tree have been planted in close proximity to live electricity conductors it is not always possible to maintain the visual amenity of the tree immediately after pruning.

(a)Yes.

NSW electricity networks trim trees to help prevent blackouts and to keep staff and the community safe. They have an obligation under *the Electricity Supply Act 1995* to reduce any potential risk to public safety from the electricity network.

Trees allowed to grow too close to powerlines can bring live wires down to the ground.

They can also start bushfires and endanger children climbing near the live electricity network. While contractors work to balance the need for a safe electricity network with the aesthetics of local streets, the Government understands trimming can look harsh, particularly on very tall trees planted directly under the network.

That includes single-leader eucalyptus trees which are often planted by local councils across the State directly underneath powerlines, which can grow to heights of between ten and 40 metres.

It can also be hard to achieve an aesthetically pleasing cut on fast-growing species like jacarandas, which grow up to 15-20 metres tall, when they are planted near major, high-voltage powerlines.

Contractors are trained to prune trees to Australian standards to protect the health of the tree, and to long-established statewide industry standards to protect public safety.

These strict guidelines determine the minimum safety clearances around the tree according to the species, the voltage of the powerlines and whether it's in a bushfire zone.

Trees are also trimmed to allow for annual regrowth, in line with network cutting cycles. The branch is then cut to the nearest collar, or growth point, to protect the tree from infection (in accordance with *Australian Standard (AS 4373-2007) Pruning of Amenity Trees.*)

Each branch will have different locations for a growth point, meaning some trees will be pruned more than others.

The network businesses and each of their contracted tree trimming companies employ arborists or horticulturalists to inspect the work carried out by the contractors.

Any tree which is identified as potentially unsafe for any reason is reported for further detailed assessment, and action taken if necessary.

Decline of Coal

135. Given the world wide transition away from coal, which will likely accelerate with political agreement in Paris and technological advancements in renewable energy, does the NSW Government have any plan or strategy to transition regional economies away from coal?

ANSWER:

The NSW Government's Strategic Statement on Coal sets out the objectives which will guide the growth and performance of the NSW coal sector.

136. Is there a structural decline in coal mining occurring in NSW?

ANSWER:

No.

Wilpinjong

137. According to the recently released Coal Industry Profile Volume 2, Peabody produced 17.33 million tonnes of raw coal and 14.62 million tonnes of saleable coal in 2013-14 despite their conditions of consent at the time only allowing 15 million tonnes of raw and 12.5 million tonnes of saleable to be produced. Have Peabody breached their Conditions of Consent for their Wilpinjong mine?

(a) If so, what has or will be done about this?

ANSWER:

Fit and Proper Person Test

138. What process do you go through to determine whether a company or person applying for a mining lease meets the fit and proper person test?

ANSWER:

A preliminary assessment of compliance risks is undertaken which involves searching open information sources to identify any issues in relation to the applicant or related entity with regards to considerations identified in s380A of the *Mining Act 1992*.

If requested by the decision-maker, a more comprehensive Fit and Proper Person Test will be undertaken which may involve requests for information directly from relevant persons, directions to provide information, or (if the concerns warrant a potential investigation into indicative noncompliances) third party searches undertaken in compliance with PPIPA, available MoUs and other relevant frameworks/policies.

Rehabilitation Security Deposits

163. Can the Minister guarantee that the \$158,675,800 held as security for the mines operated by Metropolitan Coal Pty Limited, Wambo Coal Pty Limited and Wilpinjong Coal Pty Limited is enough to rehabilitate the three mines if Peabody goes bankrupt?

ANSWER:

The rehabilitation security bond is required to cover the full cost of all rehabilitation and closure activities that may be required to be undertaken by the NSW Government should a former leaseholder default on their rehabilitation obligations.

The rehabilitation security bond is calculated on an approved rehabilitation plan on either the 'maximum disturbance/greatest rehabilitation liability at any one point in time' or 'snapshot of current disturbance'.

The latter requires a title holder to re-submit a new Rehabilitation Cost Estimate as part of the reporting process.

The adequacy of rehabilitation security bonds is reviewed regularly.

164. Can the Minister guarantee that the NSW Government currently holds enough rehabilitation security guarantees to cover the rehabilitation cost estimates for all existing coal mines in NSW?

ANSWER:

The rehabilitation security bond is required to cover the full cost of all rehabilitation and closure activities that may be required to be undertaken by the NSW Government should a former leaseholder default on their rehabilitation obligations.

The rehabilitation security bond is calculated on an approved rehabilitation plan on either the 'maximum disturbance/greatest rehabilitation liability at any one point in time' or 'snapshot of current disturbance'.

The latter requires a title holder to re-submit a new Rehabilitation Cost Estimate as part of the reporting process.

The adequacy of rehabilitation security bonds is reviewed regularly.

165. When a mine is sold, does the purchaser automatically assume the full rehabilitation cost and conditions under which the mine was been approved?

Yes.

166. How often is the DRE Schedule of Rehabilitation Costs reviewed?

(a) When was it last reviewed?

ANSWER:

A review of the DRE Schedule of Rehabilitation Costs including the Rehabilitation Cost Calculation Tool is currently underway as part of DRE's continual improvement of the security deposit process. The Schedule of Rehabilitation Costs was last published in February 2013.

167. Does the DRE Schedule of Rehabilitation Costs increase with CPI annually?

(a) If no, why not?

ANSWER:

- The DRE Schedule of Rehabilitation Costs is based on third party rates (e.g. that which would be provided by an external contractor for quotation). A number of factors are considered in the review of the Schedule including CPI as well as market rates.
- 168. In her answer to the committee on rehabilitation security deposits, Deputy Secretary Kylie Hargreaves said "obviously we reconsider and revisit those bonds on a regular basis". How often are the rehabilitation cost estimates reviewed for coal mines in NSW?
- (a) Is there a standard time period in which they must be reviewed for each mine? **ANSWER:** Yes. Depending on the nature and scale of an operation, the review period can range from annually for dynamic operations (e.g. coal mining) to every seven years where the disturbance footprint associated with active mining remains static. In addition, where there is a change to a mining operation

outside of the approved plan or where there is a change to rehabilitation, the Government undertakes a review of the security amount to account for any change to rehabilitation liability.

169. Do companies which have participated in the NSW Government's buy back scheme for petroleum exploration licenses still have a responsibility to meet their rehabilitation requirements or has this responsibility been transferred to the state?

ANSWER:

Shenhua

A wide range of internal, open-source and (where permissible) third-party data is analysed for these tests in order to effectively assess the applicant and its related persons (including ultimate holding companies, wholly-owned subsidiaries, controlling shareholders and/or directors).

ANSWER (176-177):

The Government has disclosed 3,934 meetings since the policy commenced in July 2014.

Centennial Coal

178. Is the Minister investigating whether Centennial Coal meet the fiit and proper person test given they have breached their Environmental Protection License more than 1360 times since 2000?

ANSWER:

The Environment Protection Agency is the appropriate authority for addressing pollution events.

179. Under what circumstances would the Minister review whether an existing mining company in NSW meets the fit and proper person test?

ANSWER:

The fit and proper person test was intended to be used when systemic high risk non-compliances have occurred or for matters of an extremely serious nature. For example, matters referred from ICAC. The fit and proper person test is to be applied on a case by case basis, usually around the grant or renewal of a title.

Renewable Energy Target

180. Does the NSW government have a renewable energy target for energy generated in NSW?

(a) If your government does, what is the plan to achieve this target?

ANSWER:

NSW Government is a long-time supporter of the Commonwealth Renewable Energy Target and continues to support the achievement of the national renewable energy target.

181. In the 'Progressing the NSW Renewable Energy Action Plan, Annual Report 2014', the NSW Government "reiterated its support for the achievement of a national 20% (41,000 gigawatt hours)" target. Now the national target for large-scale generation is only 33,000 GWh in 2020. If your target is Tony Abbott's target, does this mean that NSW has lowered its renewable energy target by about 20%?

ANSWER:

NSW Government is a long-time supporter of the Commonwealth Renewable Energy Target.

The implementation of the NSW Renewable Energy Action Plan positions NSW to increase the use of energy from renewable sources at least cost to the energy customer and with maximum benefits to NSW.

Environmental Data Repository

182. Where is the establishment of an Environmental Data Repository, as recommended by the NSW Chief Scientist, up to?

ANSWER:

The Division of Resources and Energy is jointly developing the Environmental Data Portal with the Department of Finance, Service and Innovation (DFS). Phase 1 will be completed in September 2015 which includes a market analysis of existing government portals, resulting in the identification of data assets, user requirements, internal and external specifications, and the development of a Business Review Document with recommendations for Phase 2;

Phase 2 will commence in January 2016 and encompass the portal design, build, and deployment. A Go-Live date in expected for mid- 2016.

The launch of Common Ground also allows the public to easily a single source of information about exploration and mining activities in NSW.

Mine Subsidence Board

- 183. The Wallarah 2 PAC suggested in their report that a thorough investigation was needed into the Mine Subsidence Board's given the lack of independence and significant public concern about its processes. Have you instigated or are you considering any review?
- 184. Has the Department commenced or does the Department plan to commence any reviews into the standards of governance of the Mine Subsidence Board following the allegations made to the ICAC that Darren Bullock, the former district manager of the Picton branch of the NSW MSB, received at least \$300,000 in corrupt payments from Kevin Inskip, the principal of Plantac Pty Limited?

ANSWER (183-184):

Werris Creek coal mine
