### BUDGET ESTIMATES 2013-2014 GENERAL PURPOSE STANDING COMMITTEE NO.2

Supplementary Questions for the Minister for Sport and Recreation

#### SCG funding versus community sport

1. In the Sydney Morning Herald 'New Era for Hallowed Ground' (7/8/13) it says that 'The state government will contribute \$86 million to upgrading the SCG, in Sydney's east, prompting criticism that ageing sports fields in western Sydney did not get the same treatment.'

What percentage of the Sport and Recreation budget is allocated to western Sydney as opposed to 'Sydney's east'?

I am advised by the Department the Sport and Recreation budget is not allocated on a geographical basis.

2. In the Budget Statement the Minister states that that "...the Government remains committed to supporting grassroots sport and recreational organisations..." With this in mind, how much money goes directly to 'grassroots' sport as opposed to projects like the SCG upgrade?

I am advised by the Department the Sport and Recreation budget is not allocated on such a basis.

### **Gaming machines funding**

3. One of the main government-endorsed community grants available to community sporting groups – ClubsGrants NSW – is directly sourced from poker machines within those sporting groups' communities. In light of this:

- a. What percentage of community-based sports clubs relied on funding from the Gaming Machines Act 2001 in 2012/13?
- b. What are the projections for 2013/14?
- c. Are these trends going up or down?
- d. Does the government consider it acceptable that community sports groups, who are often financially vulnerable and in poor communities, are reliant on gaming revenue to keep themselves afloat?

This is a matter for the Minister for Tourism, Major Events, Hospitality and Racing.

4. In the Budget press release, Minister Annesley states that the 'impact sport and recreational activity can have on people's lives goes well beyond the obvious health

### benefits'. What impacts do poker machine addiction have on people's lives, considering pokies and community sport funding are so inextricably linked in NSW?

This is a matter for the Minister for Tourism, Major Events, Hospitality and Racing.

#### AFL buying sports grounds

In recent years there have been several instances whereby the AFL, in partnership with local councils, has bought up local sporting ovals, thereby restricting access to other sports groups and general users. The most obvious example of this was Parramatta's Holroyd Oval in 2011.

#### 5. Has this practice abated? If not, why not?

The provision of sports grounds and facilities is predominantly the responsibility of individual councils. Not-for-profit community groups and individual councils can apply for funds to improve their facilities through the Sport and Recreation Participation and Facility program.

### 6. What is the government doing to ensure community sports groups have access to ovals and sportsgrounds?

The provision of sports grounds and facilities is predominantly the responsibility of individual councils. Not-for-profit community groups and individual councils can apply for funds to improve their facilities through the Sport and Recreation Participation and Facility program.

#### Uniform grants program

The Victorian Government has recently renewed its highly popular Uniforms Grants Program – which provides grants of up to \$1000 to assist in the purchase of sports uniforms – for another three years. A direct grant of this nature does *not* exist in NSW.

### 7. Will the Government adopt a similar program in NSW?

Funding for uniforms is currently available as a component of the Sport and Recreation Participation and Facility Program.

### **Community sport**

8. What proportion of the Sport and Recreation budget goes to elite sportspeople and their administrative bodies as opposed to small, community-based sports groups in NSW? I am advised by the Department the Sport and Recreation budget is not allocated on such a basis.

## 9. In reference to the 2013/14 budget allocating \$1.5 million to developing a network of ten regional academies of sport, what consultation was undertaken to determine this funding allocation?

### a. How long will this funding continue?

I am advised by the Department the Regional Academies of Sport Incorporated, which is the representative of the regional academies, was consulted. RASi submitted a Business Case requesting funding of \$1.5 million to the regional academies of sport until and including 2016/17. This was approved and announced in September 2012.

10. NSW's main community sports grant - the Participation and Facility Program - requires no more than 50% of project expenditure may be used on each of the following items: clothing/uniforms and equipment. In light of the restrictive nature of this funding to community sports groups, will the Government commit to modifying this grant to better reflect the day-to-day needs of struggling sporting clubs?

A comprehensive review of all Sport and Recreation grant programs has already been undertaken. The overall objectives of the Participation and Facility Program are to:

- Increase regular and on-going participation opportunities in sport, recreation or structured physical activity in a sustainable manner.
- Address barriers to participation in sport, recreation and structured physical activity.

# 11. Live Odds Betting during Sports Telecasts – Minister you made a number of public statements joining community concern about broadcasting live odds for betting during sports telecasts, particularly Rugby League telecasts. What have you actually done about stopping it?

Regulatory responsibility for broadcasting is a matter for the Commonwealth Government. The NSW Government is currently supporting national research into the impact of gambling products, including live odds, on children and young people.

# 12. The Community Sports Facilities Program has long been a very valuable way of small communities getting the facilities they need to promote grass roots participation, is it the case that this year sports grants have been cut from \$144,646 2012/2013 - \$48,000 – 2013/2014 (per electorate?) why have you cut this funding?

Sport and Recreation does not administer a grant program called the 'Community Sports Facilities Program'.

## 13. Stadia Plan - The Olympic Park concept is expected to cost \$240 million. Does the Government have the funding available for this in the forward estimates? Where will the funding come from?

The Office of the Minister for Sport and Recreation has not received a proposal for the redevelopment of ANZ Stadium from Stadium Australia Group.
