6. What are the overall savings in dollar terms Trade and Investment is being expected to find over each year for the next four years?

6. The original targets imposed by the previous government using 2010-2011 as the baseline were:

2014/2015	\$80.1 million
2015/2016	\$87.0 million

An additional savings target of \$189.1 million over 2012-2013 to 2015-2016 was imposed in the 2012/2013 budget process. In addition to this other savings targets imposed during the 2012/2013 budget for contributions to the State Contracts Control Board Fees, and Public Service Commission Leadership Program in 2012/2013 are:

QUESTION 7

7. How many positions are being cut or made redundant?

ANSWER

7. As outlined in the 2012/13 budget, the Government's 2011-12 program of voluntary redundancies remains on track to reach its target of 5,000 positions.

A labour expense cap has also been introduced as a new savings measure across the public sector with the target of a 1.2 per cent per annum reduction in labour costs growth.

Directors General will be given as much flexibility as possible to achieve the savings in the most appropriate way to meet the service requirements of their agencies. If it was solely achieved through headcount this would equate to up to 10,000 jobs over four years.

Nurses, police officers and teachers in schools have been quarantined from this measure.

QUESTION 8

8. In evidence to the recent Cronulla fisheries committee hearings DG indicated that he had some 32 change management processes underway in the Department. Can you list those plans, are they publicly available, can you make them available?

ANSWER

The Department is undertaking an ongoing program of organisational change. 8. The change program is being rolled out in a logical progression and by its conclusion all areas of the Department will be reviewed. Industry, Innovation and Investment Division has recently completed a large change process covered by four change plans. Crown Lands and Catchments NSW and Destination NSW have plans that will reach finalisation in the next two months. NSW Forests has completed four plans that cover different parts of its business and have a large change process running. NSW Water and Fisheries has active change plans in place. Finance Strategy and Operations Division has recently commenced a change plan affecting its corporate operations area and has finalised a plan that covered the Legal Services Area. Primary Industries is currently developing four plans to address recent Government announcement regarding regional service delivery. A further five plans are in drafting stages. Eight change plans were completed in 2011/12. The plans are not publically available; they are released to affected staff and representatives during consultation. These plans contain information relating to specific employees and are not considered public documents.

QUESTION 9

9. What areas of Trade and Investment currently based on the Sydney basin are you considering for decentralisation? How many employees does Trade and Investment have in the Sydney basin? Will you be moving the head office from rental accommodation in the CBD to a regional area?

ANSWER

9. The Department has a number of change management plans that will result in decentralisation of positions from the Sydney basin to regional NSW. The operational areas are NSW Office of Water, Crown Lands Office and NSW Fisheries as well as the division of Finance Strategy and Operations.

NSW Trade & Investment has 1,394 employees in the Sydney basin in an area bounded by West Pennant Hills, Richmond and Menangle.

The NSW Government has no plans to move the head office from rental accommodation in the CBD to a regional area.

QUESTION 10

10. What areas of the Department are affected by the 32 change management plans that your Department head has said are currently in operation?

ANSWER

The Department is undertaking an ongoing program of organisational change. The change program is being rolled out in a logical progression and by its conclusion all areas of the Department will be reviewed. Industry, Innovation and Investment Division has recently completed a large change process covered by four change plans. Crown Lands and Catchments NSW and Destination NSW have plans that will reach finalisation in the next two months. NSW Forests has completed four plans that cover different parts of its business and have a large change process running. NSW Water and Fisheries has active change plans in place. 14. The Country Halls Renewal Fund ceased to operate on 1 July 2012. Two alternative programs are available to provide assistance toward community based infrastructure through a competitive application process; the Public Reserves Management Fund administered by Crown Lands, and the Community Building Partnership Program administered by the NSW Department of Premier and Cabinet.

- 15. What was the total amount allocated to the community building partnership program in the 2011/12 and 2012/13 Budget?

ANSWER

QUESTION 16

16. What criteria are you applying to consider what areas can be decentralised? What measure will you apply to determine success of the decade of decentralisation?

ANSWER

- 16. The Government's Decade of Decentralisation policy is designed to support regional communities by implementing strategies that encourage decentralisation and promote steady and strategic growth in regional NSW. Elements of this policy include:
 - identifying more public sector job opportunities which could locate to regional areas;
 - ensuring that viable services are available to make regional living attractive; and
 - giving back to local communities as much local decision-making and participation as possible, along with appropriate accountability and responsibility.

A key initial element of this policy is to identify public sector jobs and services which can be decentralised from the Sydney CBD to other locations in metropolitan Sydney and regional NSW. Broadly, two main criteria are being used to identify what areas can be decentralised from the CBD:

- (1) the nature of service delivery and CBD interactions; and
- (2) alignment with Government's strategic objectives.

The Government will also decide whether any agencies with state-wide functions in metropolitan Sydney can be decentralised. An example of the policy being implemented is the recent decision to locate 105 new public sector jobs in Grafton, covering a range of functions carried out by Roads and Maritime Services, Crown Lands, Renting Services, and the Office of Environment and Heritage. The success of the policy will be demonstrated by the additional jobs, skills and expenditure brought to regional communities.

QUESTION 17

17. What process will you follow?

ANSWER

17. Work is currently underway to identify centres that have the suitable skills and infrastructure to support additional public sector jobs and services. Other elements of the work include: a review of principal agencies' leased and owned office tenancies in the Sydney CBD and metropolitan Sydney to make an assessment of potential for relocation; formulating a plan to strategically release CBD property holdings with particular attention on higher cost office space; and assessing procurement and workplace design options that will optimise economic benefits from relocations.

QUESTION 18

18. You were involved in the decision on Cronulla fisheries, what could you have done better? Will that be a model for future decentralisation?

ANSWER

18 The NSW Government is committed to delivering the Decade of Decentralisation policy.

The Government is currently considering the Legislative Council Report into the Closure of the Cronulla Fisheries Research Centre of Excellence.

Infrastructure NSW (INSW) Report QUESTION 19

19. The Government identified several projects for development as part of the 20 year Infrastructure Strategy including the upgrade of the Rail Line in Gunnedah – what role will Royalties for Regions play in the development of this project?

ANSWER

19. The specifications for components of the pinch points program referred to and the role for Resources for Regions will be developed with Transport for NSW (TfNSW) and published by Infrastructure NSW in the first five year State Infrastructure Plan with the 2013-2014 budget papers.

QUESTION 20

- 20. Do you agree with INSW report to sell the Governments stake in Snowy Hydro?
- a) Has Trade and Investment consulted with INSW about any possible arrangements for this privatisation?
- b) How much is expected to be gained through this sale?

ANSWER

20. NSW Treasury is the relevant agency and any questions on this matter should be referred to the Treasurer.

QUESTION 21

- 21. INSW has identified that within the next 5 years 'coal communities' in the Hunter will their road and rail infrastructure upgraded. What are the projects identified?
- a) What contribution will Resources for Regions provide to these programs?

ANSWER

21. The specific projects for the Coal Communities program referred to and the contribution of Resources for Regions will be developed with Transport for NSW (TfNSW) and published by Infrastructure NSW in the first five year State Infrastructure Plan with the 2013-2014 budget papers.

Infrastructure NSW does envisage that Resources for Regions and Commonwealth Regional Infrastructure Funding will be sought to support the highest priority items in this program.

In another initiative the NSW Government, through the Department of Premier and Cabinet, is currently establishing a Regional Taskforce Group to examine impacts on mining affected communities in Western NSW, including those relating to infrastructure provision. Local government representatives will be invited to participate on the Taskforce.

The Bridges for the Bush program delivers on the Government's commitment to improve road freight productivity by replacing or upgrading bridges over the next five years at 17 key locations in regional NSW.

Bridges in mining communities which will be upgraded include the Gunnedah Railway Bridge (\$16m), Middle Falbrook Bridge (\$10.5m), Dunmore Bridge (\$15m) and Brig O'Johnston Bridge (\$14m)

Payroll Tax Incentives QUESTION 22-24

- 22. How many businesses have relocated to regional NSW from Sydney over the past year?
- 23. How many businesses have received payroll tax concessions from your Government over the past year?

National Broadband Network (NBN) QUESTION 25

25. What work has your Department done to ensure that regional NSW businesses and residents are able to fully utilise the NBN?

ANSWER

- 25. NSW Trade & Investment's Office of Regional Development has provided funding assistance to a number of projects relating to the NBN:
 - NBN Information workshops were initiated and organised by the Department in Armidale in March 2011, Inverell in May 2011 and Glen Innes in June 2011. Funding was provided by NSW Trade & Investment to Regional Development Australia Northern Inland to engage a speaker and organise the workshops in Tamworth in October 2011, and in Gunnedah, Narrabri and Moree in November 2011.
 - 'NBN Explained for Small Business' workshops were held in Eurobodalla and Merimbula in the 11/12 year. The Department funded a speaker and organised the workshops.
 - Financial assistance was provided to Southern Cross University in 2011 to develop and operate an e-demonstration centre where the benefits of high speed broadband can be demonstrated and promoted to businesses, organisations and the public. The centre commenced operating in early 2011 and will operate for three years.
 - RDA Northern Inland was provided assistance in 2011 towards a New England North West NBN Co-ordinator to develop a roll out strategy for the New England, to help secure NBN in the region and to run workshops to educate businesses on the NBN.
 - RDA Hunter was also provided with assistance to employ an NBN project officer for the Hunter and Central Coast. The aim was to present the Hunter and Central Coast as priority regions for NBN, to work with councils, businesses and other stakeholders for preparedness of the NBN and to identify opportunities as a result of NBN.

- RDA Northern Rivers was provided with funding in March 2011 to conduct a broadband needs and services survey for critical industries in the region.
- RDA Northern Inland was offered funding in early 2012 to develop a broadband smart house to attract commercial operators.
- The roll out of the Community Broadband Development Program is underway. The program is administered by NSW Trade & Investment and the roll out is due to be completed in December 2014 subject to delays, i.e. adverse weather conditions. It will provide high speed broadband access to a number of small country towns and areas with a population below 5,000 which are not covered by the NBN.
- The Community Technology Centre network was established by the Commonwealth and NSW governments to provide information and training to businesses and residents in rural and remote small communities on how to connect to the NBN and how it can be used. NSW Trade & Investment is the government department with responsibility for oversight of the network.

Burrinjuck trust and other sacked trusts QUESTION 26

26. Why did you decide to sack the trusts who had previously managed the crown reserve at Burrinjuck dam and other similar areas around the state?

ANSWER

The NSW Government and the community are very grateful to the hard-26. working volunteers who have managed the seven inland State Parks up until now. However, State Parks are forced to operate in an increasingly complex regulatory environment and competitive marketplace. This requires a commitment beyond that which can be reasonably expected from part-time volunteers. Therefore, following consultation with the current management of State Parks, it was announced that a single professional management structure will replace the seven separate trusts previously responsible for these valuable community facilities. The new structure will provide a sustainable future for these State Parks to enable them to operate in an increasingly competitive leisure market. By introducing more efficient and professional management practices, the Inland Water Holiday Parks will be able to offer improved access, facilities and overall a better experience for visitors. The expertise and local knowledge available from local communities is highly valued, which is why community advisory committees will be established to advise park management.

QUESTION 27

27. Will you rule out leasing out the management of those areas?

ANSWER

27. It will be the responsibility of the new trust to determine the optimum management model.

Cronulla Fisheries QUESTION 28

28. What involvement did you have in the decision to close the Cronulla Fisheries Research centre of excellence?

ANSWER

28. The NSW Government is committed to delivering the Decade of Decentralisation policy.

The Government is currently considering the Legislative Council Report into the Closure of the Cronulla Fisheries Research Centre of Excellence.

Extension Officers QUESTION 29

29. As Minister for Regional Development do you approve of the plan to move DPI Extension Officers in with CMAs and LHPAs?

ANSWER

29. As Minister for Regional Infrastructure and Services I support any plan which improves service delivery to farmers and landholders in regional NSW. The *Local Land Services* reforms announced by Minister Hodgkinson will see the end of multiple agencies providing unco-ordinated, highly duplicative, inequitable and unnecessarily expensive services to farmers and regional landowners.

Transport NSW report QUESTION 30

- 30. Are you concerned that out of the nearly \$137 billion worth of projects compiled by Transport NSW, the Bells Line road was not one of those projects listed?
- a) What is the Governments agenda for the Bells Line road?
- b) Did you make any attempt to guarantee that the Bells Line road would be added to Transport NSW report?

ANSWER

30, a),b) These questions should be directed to the Minister for Roads.

Crown Lands QUESTION 31

31. When did you take responsibility for the portfolio of Crown Lands?

31. The Minister for Primary Industries and I have had joint responsibility for the Crown Lands Act since 3 April 2011

QUESTION 32

- 32. Through the appointment of new staff to the Grafton Lands office, what are the current skills requirements for the positions that will be advertised?
- a) When will they be advertised?
- b) Will staff that recently lost their job at the Grafton Gaol be suitable for these jobs?

ANSWER

- 32. The positions are all focused on delivering on the Crown Road Disposal project. There are numerous positions at various levels and the skills and expertise required are clearly stated in the Position Descriptions. The successful applicants will be undertaking tasks associated with land administration such as the closure and sale of Crown roads, within a business centre environment.
- a) The positions were advertised on line in early October via the normal government channels and in the Maclean Coastal Views and the Grafton Daily Examiner on 12 and 13 October 2012, with a closing date of 4 November 2012.
- b) Individual applications will be assessed on their merits

QUESTION 33

- 33. As the Government has made the decision to relocate the Native Title office to Newcastle where will all the native title mapping information be held?
- a) Will it be easy for staff to access? Will they have to travel from the office in Newcastle?

ANSWER

- 33. The information supporting Native Title applications is provided through the Status Branch, which is being relocated to Newcastle. Most of the mapping information for Native Title is stored in information systems available to staff on-line, although there is still some reliance on historical records that are not yet available online. A review is being undertaken to ensure that improvements to information systems including the scanning of historical records are addressed.
- a) Arrangements will be made to minimise the need for travel by staff and to improve the accessibility of information online.

QUESTION 34

34. Is the government seeking to make regional Job Plans available for the rest of the State, considering that Crown Land jobs in Nowra, Griffith, Hay and Parramatta are being relocated?

- a) What will be the effect of these relocations to the communities?
- b) Has the Government developed regional impact statements for these areas?

34. a) & b)

The NSW Liberals & Nationals Government is committed to jobs and employment growth in regional NSW. The Jobs Action Plan will help create 100,000 new jobs, of which 40,000 will be in regional NSW. Employers are eligible for a payroll tax rebate of \$4,000 for each new employee they take on.

Under the Regional Relocation Grant, people selling a house in Sydney and buying a house or land in regional NSW are eligible for a \$7,000 in order to help them make the move.

The Government will shortly release Regional Action Plans which will outline key priorities for each region.

QUESTION 35

35. How many State Trusts does the Government look to privatise as part of its review of inland water parks, North Coast and South Coast holiday parks?

ANSWER

35. These reserves will remain within the Crown reserve system.

QUESTION 36

36. As Minister for Regional Infrastructure and Services do you consider the allocation of funds in this year's budget for the Kings Highway to be adequate?

ANSWER

QUESTION 37

37. What are the employment periods contained in the employment contracts for staff appointed to the Grafton Crown Lands positions to expedite the crown road lease sale process?

Trade and Investment Account Payments QUESTION 38

- 38. As at 30th September 2012 are there any accounts payable by Trade and Investment outside 30 days?
- a) If so, how many?
- b) What are the amounts for each invoice outside the 30 days?
- c) What strategies are being put in place to bring the accounts within the 30 days?

38. As the Premier stated in Parliament on 23 August 2012, the 30 day bill payment policy formally commenced on 1 January 2012. The first quarterly performance report is currently being finalised for release. In the first quarter almost 92 per cent of invoices were paid within 30 days, consistent with our policy and initiative. 31 small businesses have already been eligible to receive automatic interest charges on overdue accounts.

Grafton Gaol Downsizing QUESTION 39-41

- 39. When was the Deputy Premier first made aware of the decision to downsize the Grafton Gaol?
- 40. Was there a Rural Impact Statement was submitted to Cabinet regarding the downsizing of Grafton Gaol?
- 41. Did this decision go to the Expenditure Review Committee of Cabinet?

ANSWER

39 - 41

Grafton Correctional Centre (Grafton) has recently been restructured as an intake and transient facility.

The facility will cater for offenders who are remanded in custody in the local, regional area, and for inmates who need to attend court in the Northern Rivers region.

Grafton had unsustainable operating costs due to its age. The restructure will save taxpayers \$5.8 million per year.

Staff affected by the decision will be offered the opportunity to transfer to Cessnock or another NSW correctional centre or voluntary redundancies.

The decision to move towards the restructuring of Grafton Gaol was made earlier this year.

The decision regarding full extent of the restructure, including the final details concerning staff, inmate and bed numbers, was only made shortly before the announcement by the former New South Wales Corrective Services Commissioner Ron Woodham on 29 June 2012.

Northern Rivers Jobs Plan QUESTION 42

- 42. Minister, in early September you announced the Northern Rivers Jobs Plan was delivering 79 new jobs.
- a) How many of these 79 jobs will last more than 12 months?

- b) How much of the announced funds have been expended to date in supporting the two companies?
- c) Is there a review date on the success or otherwise of the Northern Rivers Jobs Plan?

- 42 a) In September, two successful projects supporting 79 new jobs, including 77 jobs over a six month period, were announced under the Northern Rivers Jobs Plan. Further successful applicants will be announced in coming weeks.
- b) Payment of funding is subject to companies meeting milestones set out in the terms of their individual contracts with the NSW Government. Under the terms of the contract, companies are entitled to claim funds when they demonstrate they have met agreed milestones including the employment of an agreed number of fulltime equivalent employees. The companies have to provide evidence via a statutory declaration when making their claim for payment. These two companies are not yet due to reach their milestones. Contracts with the companies remain commercial in confidence.
- c) The reporting of the results of the Northern Rivers Jobs Plan will be determined by timing of the milestones in the contacts with the companies that have received funding. Program results are reported in the Department's annual report and through the Government's communications activities.

Public Sector Job Relocations QUESTION 43

- 43. After the decision to downsize Grafton Gaol was announced you were tasked with identifying possible public sector jobs for relocation to Grafton.

(a-f) Conditions consistent with the *Public Sector Employment and Management Act 2002* would be imposed by the individual agencies concerned. This process was managed within existing resources

Infrastructure NSW Report – Coal Communities Fund QUESTION 44

44. Minister, do you support the recommendation of INSW to create a Coal Communities Fund worth \$500M? Do you envisage the Resources for Regions programme will be rolled into any such fund? Will the Resources for

Regions programme operate as a separate scheme to the Coal Communities Fund?

ANSWER

44. Infrastructure NSW's Strategy 2012-2032, *First things first*, does not recommend creation of a coal community fund worth \$500 million. The government is currently considering the recommendations in the strategy, and will be responding to them by the end of the year.

QUESTION 45
