It has been brought to my attention that there are serious concerns by highway patrol members in relation to the suitability of the XR8 Fords for highway patrol work. I believe there are serious concerns regarding the vehicles while in pursuit and also severe smells of fuel in the cabin while the vehicles are driven. Highway patrol personnel tell me that the XR8s on occasions, particularly during pursuits when doing a turnaround after an offender, are stalling. Could you inform the Committee of the status of the matter involving the XR8s?

8: RECRUITS - SACKINGS OR RESIGNATIONS?

Question:

Has it been practice at the academy that rather than forcing people to leave if they are deemed to be unsuitable because of conduct they resign and walk out the door with a clean slate, or has everyone found to have conducted themselves improperly for a host of reasons been sacked? Have they all been sacked or have some been given the option simply to resign?

Answer:

NSW Police has advised me:

In the event of a student being found guilty of misconduct, their status of professional suitability is removed, either temporarily or permanently, commensurate with the seriousness of the misconduct.

If an allegation of misconduct is made, but the student resigns prior to the completion of the investigation into that allegation, the allegation is endorsed on their file and the student is not considered for re-entry to the Academy until the issue is satisfactorily resolved.

To ensure natural justice and transparency, a Student Professional Suitability Review Committee, comprising Professional Standards Manager, Corporate Services (Chair), Staff Officer Education Services and generally a Local Area Commander, can determine appeals from students who have had their status of professional suitability removed.

Question: 11 : COMMUNITY / COMPLAINANT SATISFACTION

Question:

I return to the figure I quoted of 40 per cent from your 2004-05 report. The source is "Community satisfaction with policing survey: NSW Police complaints handling system". So that is the source of that. The reason I asked that question is that the Standing Committee on Social Issues report 38 of June 2006 on Policing Strategies and Resources in the Macquarie Fields Area found there was a need to develop and support initiatives to prevent further disturbances in the area. I am aligning that 40 per cent with people reacting the way they feel they have been treated unfairly. The Macquarie Field area and Cronulla riots have seen resources allocated after the events. So the event has happened, and the resources have been allocated. Has the department identified potential areas of future conflict? In other words, are you aware of where the next area of conflict might be, and have you pre-allocated resources to the local area commands accordingly; or are you pre-empting what is potentially happening out there in consumer land?

Answer:

NSW Police has advised me:

NSW Police continually analyses available information and allocates resources to ensure community policing needs are met. Issues such as socio-economic disadvantage are recognised contributing factors to criminal activity and civil unrest. Police work with community groups, government and non-government organisations to address these underlying causes of crime. Initiatives such as Police Accountability Community Teams and a range of joint consultative committees, currently in operation at Local Area Commands across the state, contribute to risk assessments and strategic planning.

There are 5 domestic violence officers attached to the Macquarie Fields Local Area Command Domestic Violence Unit, in addition to a civilian support officer.

There is currently no specification, design brief or development being undertaken on a load bearing bullet resistant vest for NSW Police.

A commencement date of early 2007 is anticipated for the drug testing regime. Drugs to be screened are cannabis, methamphetamine and ecstasy.

Can you indicate how many properties are currently owned by New South Wales Police in your portfolio? Does that contract (with United Services Group) list all of the New South Wales Police property? If that is the case, could you also take on notice the full list of all properties owned by New South Wales Police and table it with the Committee? Given your earlier answer that you would take on notice how many were owned, do you know how many properties currently held by NSW Police contain operational police duties?

NSW Police has 1,431 property assets of which 1,246 are owned and 185 leased.

It should be noted that a number of premises other than police stations do house operational police.

Mr Scipione, the Ombudsman's report in January 2004 was critical of inspectors Moore, Douglass and Monk for failing to adequately act upon prior complaints of Richard McDonald. The Ombudsman also indicated that no good reason has been given for the delays. What advice did the police give to the police Minister on this matter in terms of responding to the Ombudsman's report?

NSW Police has advised me:

There is no record within the Professional Standards Command, the Command responsible for this matter, to indicate that a copy of the Ombudsman's report or NSW Police's response to the Ombudsman was forwarded to the Office of the Minister for Police.

Answer:

NSW Police has advised me:

- a) The role of mentor is not compatible with that of reviewing officer as there would be a clear conflict of interest in holding those two positions concurrently.
- b) While the use of the word 'mentor' in Sergeant Brooks' fax was unfortunate, during his review the Sergeant clarified his position as being a 'point of contact' by agreement with Mr McDonald.

18: MACQUARIE FIELDS DOMESTIC VIOLENCE DISPUTES

Question:

Of the 200 domestic violence disputes per month, which is what was reported, how many of those are repeat disputes? Presumably, there would be a high incidence of repeat disputes? How many of those disputes are attended by a domestic violence officer?

Answer:

NSW Police has advised me:

There were 1420 recorded domestic violence related incidents within the Macquarie Fields Local Area Command in the period 1 May 2006 - 31 October 2006. However, 745 (52.4%) of those were cases where there was no offence or were verbal argument incidents only. It should also be noted that, where an offender is arrested on multiple charges, each offence is recorded as a separate incident.

Statistics sourced from the Crime Management Faculty Unit for the period April - September 2006 show 287 individuals who are recorded as being involved in domestic incidents on 3 or more occasions as either a complainant or person of interest. This data also includes the 'no offence' incidents as mentioned above.

Domestic violence officers do not attend all domestic violence incidents; however, they review the appropriateness of police attendance and where necessary initiate an appropriate response. The Macquarie Fields Local Area Command is also currently involved in the Attorney General's Department Domestic Violence Intervention Court Model project which addresses these issues via a whole-of-Government approach.

19: COST OF SECURITY AT BULLDOGS GAMES

In relation to additional police security at Canterbury Bulldogs games in March this year, the police Minister indicated that it was important that there be proper cost recovery on behalf of taxpayers. What has been the total reimbursement to NSW Police by the Bulldogs Rugby League Club since that date? Are you aware if there has been any reimbursement at all? Would you also take on notice what amount is still outstanding? Also, what cost per officer is the club being charged?

Answer:

NSW Police has advised me:

Total reimbursement of \$4,032 (excl. GST) has been made to NSW Police by the Bulldogs Rugby League Club Ltd since March 2006. An additional \$160,588 (excl. GST) has been recovered from relevant sporting grounds for police services associated with Canterbury Bulldogs games. There is no outstanding amount. The Club is charged a standard rate of \$72 (excl. GST) per officer per hour.

Question:

Mr Scipione, can you outline to the Committee the reasons for denying former police officers who retired prior to 2002 and who had previously served for more than 10 years, the police medal? How many officers are estimated to fall into the eligibility category?

Accurate figures are not available in relation to the numbers of police who would otherwise be eligible for the medal if the 2002 commencement date did not apply.

The Commissioner is currently reviewing eligibility criteria for this medal.

a) Are you aware that the NSW Ombudsman report of 16/1/04 stated 'I recommend that the NSW Police reconsider taking appropriate steps to acknowledge the unnecessary stress caused to Mr McDonald by NSW Police as a result of the delays and poor management in dealing with his matters'?

b) What is the Police Minister's response to this recommendation?

Answer:

NSW Police has advised me:

Whilst it is acknowledged that there was a delay in the referral and finalisation of Mr McDonald's matters, the delay cannot reasonably be fully attributed to poor management of the complaint by NSW Police. A number of correspondence reviews and assessments took place at the time due to Mr McDonald continually submitting new complaints or restating old matters. Hence it would be simplistic to assess those delays merely on the dates without examining the extenuating circumstances involved.
