DPP

- 1. Have you requested advice from the Director General or from the Executive Director of the DPP concerning a new rank of Crown Prosecutor to be on a salary less than presently paid to Crown Prosecutors?
- 2. Have you requested or been provided with advice on the number of assistant solicitors employed by the DPP and/or whether the numbers should be reduced and/or eliminated?

NSW Trustee and Guardian

- 3. In regard to the judgment of McLaughlin AsJ in the matter MacDonald v Public Trustee [2010] NSWSC 684, how do you respond to His Honour's criticism of the management of this estate by the Office of the Public Trustee?
- 4. Have you ordered an independent review regarding the management of all current estates?
- 5. What procedures have you put in place to ensure that this type of conduct does not occur again?

Legal Costs

- 6. Despite the fact that you advised the General Purpose Standing Committee No 3, 12 months ago, that SCAG had agreed that its work on legal costs should be fed into the COAG Legal Profession Taskforce reform process, another year has gone by with no reform on this issue in NSW. Are you intending to take any initiative in the reform process to resolve this issue of excessive legal costs in NSW?
- 7. There has been considerable criticism of the time costing system including comments by the Chief Justice urging the profession to reconsider the use of billable hours or time costing to charge clients. Do you intend to abolish this system?
- 8. The Legal Services Commissioner Steve Mark has stated that he thought it was time consider a system of proportionate costs and that other States followed the lead of Queensland and adopt "the 50-50 rule". This would mean that legal fees must not exceed half of what remains of the judgment after the expenses are taken into account. Mr Mark is quoted as stating that this step would restore some proportion to litigation. Are you intending to introduce a system of proportionate costs?
- 9. When might we expect to see some action in regard to this issue?

ANSWERS

I am advised:

In May 2010, the COAG National Legal Profession Reform Taskforce released its draft Legal Profession National Law and National Rules for a three month consultation period. The package contained draft legislative provisions and rules in relation to legal costs. The Taskforce is currently considering the submissions and will report back to COAG before the end of 2010.

Given that concerns about excessive overcharging could arise in any Australian jurisdiction, it is desirable to seek national uniformity on legislative provisions to address them. Consequently, the NSW Government intends to await the outcome of the COAG national legal profession reform process before considering further action on legal costs within New South Wales.
