Questions on Notice - Tamworth Regional Council

Mr DAVID SHOEBRIDGE: Thank you all for your presentations. The first question is addressed to you, Councillor Webb. Do you know since amalgamation what the change in council employment numbers are in each of Nundle, Manilla and Barraba?

Amalgamation occurred on 17 March 2004 and at that time the number of regular staff (as defined by the Act) was as follows:

•	Barraba	36.05
•	Manilla	44.17
•	Nundle	20.72

Existing employment numbers attributed to each centre are currently as follows:

•	Barraba	24.36
•	Manilla	26.50
•	Nundle	6.78

Barraba Shire Council was split between Tamworth Regional Council and Gwydir Shire Council and at the time of amalgamation it was agreed that 12 staff should have been transferred to Gwydir Shire Council. This did not occur and Tamworth agreed to host all of the staff for the initial three year period following amalgamation. Therefore the number of staff attributed to Barraba at amalgamation that relate to Tamworth Regional Council should be 24.05 as compared to 24.36 that are currently employed.

However, it may also be of interest to note that there has been very little change in where employees of TRC reside since amalgamation. In 2004 council employed 29 residents of Barraba compared to 22 today, 34 employees were residents of Manilla compared to 35 today, and 19 were residents of Nundle and there are currently 17 residents employed from this area. This demonstrates that while the actual place of employment may have changed, this has not had a major detrimental impact on the population of those towns.

Mr DAVID SHOEBRIDGE: What about population in those towns? Has population gone up or has population gone down? Does that contrast to Tamworth?

The available population statistics based on census data for each area is as follows;
