- 1. Road collapse Gosford Council LGA
 - a. What steps is the government taking in respect of roads such as Pearl Beach Drive, on the Central Coast, where a council may simply not be able to afford to fix a road?
 - b. Was the transfer of the road to the Council from the RTA a factor in the Somersby Rd. collapse, or did that Council have sufficient funds to undertake the work?
- 2. Coal and Allied developments at Catherine Hill Bay and Gwandalan
 - a. What are the latest developments regarding the Coal and Allied proposal for Gwandalan?
- 3. Mangrove Mountain and Coca Cola Amatil

The NSW Fire Brigade has constructed new stations on the Coast and has increased its crewing to match population increases on the Coast, in fact the fire station has constructed four new stations, along with an additional 60 staff. The number of ambulance stations and staff have remained the same.
 - i. How is this justifiable?
 - ii. Will you undertake to increase staff levels?
 - iii. What planning is there for new ambulance stations? Where?
- 29. The ambulance service state there has been no increase on night shifts in the last 15 years, despite population increase in that period of more than 30%.
 - a. How is this justified, especially given the higher than average incidence of aged people on the Central Coast?
 - b. How many cars are in fact allocated for night shift on the Central Coast?
 - c. What has happened to the rescue truck given the huge number of visitors to the Coast over the Christmas holidays?

- 30. As Minister for Health, and as former Minister for Industrial Relations, how do you justify the new death and disability award, which those over sixty are still required to pay, even when they are not entitled to any remuneration if injured or killed?
- 31. Are you aware that the Ambulance Service complained that, frequently on the Central Coast, patients are being transported by supervisors in the front of cars due to staff shortages?
 - a. What action is being taken to remedy this?
- 32. The Health Services Union recently called for the dismissal of the CEO of the Ambulance Service. Given that front line ambulance officers have lost confidence in him, why do you still retain him?
- 33. How do Gosford and Wyong Hospitals emergency admission delays compare to the statewide average?
 - a. Is it a fact that these are among the worst in NSW? If not, why not?
 - b. What action are you taking to remedy this?
- 34. You are aware that it is quite common for ambulances to be delayed for periods of up to 6 hours at Gosford Hospital to discharge emergency patients.
 - a. What action have you taken to remedy this?
- 35. Does the Department of Health intend to take away meal penalties?
 - a. Does it intend to take away the meal hour and replace this with two 30 minute crib breaks?
- 36. What childminding facilities does the Department plan to develop for the Central Coast ambulance staff?
- 37. The population of Warnervale and Northern Wyong is expected to increase by 60,000.
 - a. What preparations has the ambulance service made for this?
 - b. When will the ambulance service construct stations at:
 - i. Kincumber?
 - ii. Warnervale?
 - c. How much is being allocated?
- 38. Minister, did the Chairman of the Medical Staff Council at Wyong Hospital resign, or threaten to resign, because of your treatment of medical staff at Wyong Hospital two weeks ago?

- 42. Three days before the 2007 state election, the then Premier Morris Iemma, accompanied by the four Labor candidates for the Central Coast seats, promised a \$27 million roads program for the Central Coast, including major works at the Brisbane Water/Central Coast Highway intersection.
 - a. The RTA has allocated \$3000 for 2008/09 for the upgrade of the intersection of Central Coast Highway, Brisbane Water Drive and Manns Road at West Gosford, yet there is no allocation in the 2008/09 State budget for works on that intersection.
 - b. Why has no funding for works to commence been allocated?
 - c. When will funding be allocated?
 - d. How can this promise be fulfilled prior to the 2011 state election?

Will we be back to square one?
- 53. Has there been any communications between NSW Health and NSW treasury to raise concerns over lengthy and expanding waiting lists that the budget is incapable of resolving in one financial year?
- 54. Can NSW Health please provide the inquiry with the cumulative costs of the 2 formal reviews (Carla Cranny and PwC) and any other PADP review costs? It would be interesting to note how many times and at what cost it takes the NSW government to realise that a program is underfunded.
- 55. Can the minister confirm that since 1999, and maybe even further back, that there has been a consistent message coming to his office both internally and throughout the disability sector that people are waiting long periods for items of equipment and that PADP was continually underfunded? This in spite of increased allocations of funding.
- 56. Can the minister confirm whether the creation of the Enable NSW advisory council is an attempt to seek governance form DADHC that has been missing? I ask this question with relation to this MOU as quoted in the PwC review:

The MOU makes clear that this funding was provided to NSW Health under the Disability Services Act (NSW) 1993 and that both departments are required to ensure that the use of the funds confirms with the Act. The MOU provides for ADD (Now called DADHC) to have a responsibility to review the PADP guidelines to ensure that the guidelines comply with the Services Act. Should ADD determine following a review that the funding of PADP is not compliant with the Services Act, NSW Health 'must ensure that (any) non-compliance is rectified as soon as possible' (Clause 6.4). Under the MOU, the role of ADD is to provide notice in writing in order to require NSW Health to rectify any non-compliance and to withdraw the funding."

- 57. Has DADHC helped with raising funding and governance issues; if so to what degree and in what capacity?
- 58. What is the status of any review of the First Responders program (SES + NSW Ambulance Service) and what does the review say and what is the Government's response?
- 59. What is the breakdown of staff numbers at the new mental health facility in Lismore, including total number of staff, number of staff in the aged section and number of staff in the adolescent section?

In relation to people living in the township of Harrington in the Port Macquarie electorate:

- 60. Are you aware that Harrington, a community with both a growing population and an aged population, is extremely concerned about its lack of an ambulance station (relying on Taree ambulances) and no after-hours doctor?
- 61. Are you aware that that concern has been elevated by a recent incident in which a Harrington resident suffered a heart attack, the ambulance was called but when his condition was still deteriorating, the ambulance service was contacted and it was discovered that no ambulance had yet left Taree?
- 62. Will you acknowledge that a growing town like Harrington needs an ambulance station, or at least give consideration to facilitating a First Responders program for that locality?

In light of the former Treasurer's claim that the health ten year capital program is overcommitted to the tune of half-a-billion dollars and that projects in the wing cannot be accommodated within the existing capital budget:

- 63. When will the Port Macquarie Base Hospital Fourth Pod will be built?
- 64. How much money has been allocated to fix major flaws in the Bathurst hospital, when will the work be complete and at what total cost?
- 65. When will stage 3 of the Nepean Hospital redevelopment go ahead?
- 66. When will the long-promised Northern Beaches Hospital at Frenchs Forest, which is part of the recently release Northern Sydney Central Coast Clinical Services Plan, be complete?
- 67. When will the Lismore Hospital stage 3 redevelopment be delivered?
- 68. When will the construction of the long promised Central West Lachlan Valley project commence?
- 69. Will construction of the Tamworth Hospital redevelopment commence in this Parliamentary term?
- 70. When will work on the long promised redevelopment of Wagga Wagga Hospital l begin?
- 71. When will work on the promised new Bega Valley Hospital begin?

In relation to the CERNER FirstNet IT program:

- 72. Please list the hospitals that are currently using FirstNet, and those that are planned to have the system in place and when.
- 73. How much has already been allocated to install and implement FirstNet and what is the expected total cost for each Area Health Service?
- 74. On recent NSW Emergency Department Performance Figure reports there is a statement "Due to problems with the implementation of a new emergency information system (cerner firstnet), following data are excluded from triage performance and emergency admission performance calculations:" will this data ever become available? What was the nature of the problems?
- 75. How do you respond to complaints from clinicians that there was grossly inadequate clinical input into the requirements of this software from the start?
- 76. Are you aware of serious concerns about FirstNet raised by front-line emergency department doctors which include complaints that patients have been 'lost' because data has gone missing; the time it takes to enter data cuts into time that should be spent treating patients; that simple tasks like ordering a blood test that once took 2 minutes now take 15 minutes; that FirstNet is unable to produce meaningful clinical data to enable comparisons of effectiveness of treatment.
- 77. Are you aware that many senior clinicians are now so opposed to the FirstNet that there is talk of us simply refusing to use the system?
- 78. Given that the Victorian Auditor-General Des Pearson in April this year made a damning report into Victoria's roll out of FirstNet including significant time delays, budget blowouts and that the CERNER clinical system was not working at any of the hospital sites at which it had been installed and the significant discontent among NSW clinicians at hospitals where the FirstNet system has been implemented, why is NSW apparently committed to software that is simply not up to the job, and which appears not able to be rectified?

In relation to Program for Appliances for Disabled People (PADP):

- 79. There was an \$11 million 'one-off' top up from both the State and Federal Governments recently to address the waiting list backlog for equipment. Will this funding become part of the recurrent funding for PADP in future years?
- 80. Why are the reforms that are currently planned for PADP in response to the Price Waterhouse Coopers review going to take till the end of 2010 to implement, when the review came out in 2006?
- 81. As part of the changes to PADP, will you be scrapping the \$100 co-payment?
- 82. How much does it cost to administer the co-payment and how much do you actually raise by charging the co-payment?

- 83. Is it acceptable that people with a disability can be waiting 3 years for equipment?
- 84. There are 262 applications to the PADP for equipment that have been waiting more than a year. Is this acceptable? What are you doing about it?
- 85. One of the most common complaints about the PADP are delays which mean original equipment recommendations are no longer appropriate, particularly in the case of growing children. How will you streamline the application process to eliminate problems like this?

In relation to overdue accounts:

- 86. As at today's date (October 13th) what is the total value of accounts over 45 days old owed by each of the eight Area Health Services and the Children's Hospital at Westmead; and how many overdue accounts are there in each area?
- 87. Please list the hospitals that are behind in paying doctor's salaries or fees for services they have provided in treating patients in those hospitals?
- 88. How many doctors have had to chase up payment of their salaries/fees?
- 89. How many other hospital staff have had delays in payment of their salaries or fees? Please list the hospitals and the categories of staff.
- 90. In 2002 the Auditor General found "AHSs have a track record of late payment of creditors. The problem was widespread across a large number of AHSs, both rural and metropolitan." Three years later in 2005 the Auditor General found "NSW Health still does not always pay its suppliers promptly because not all Areas have the necessary funds. A lot of Area resources are used to manage suppliers' complaints about this problem." NSW Health said the problem would be eliminated "when it implements the shared corporate services with a central payment system".

Given NSW Health has been acutely aware of this problem for 6 years and there were promises it would be eliminated why are businesses still waiting months and in some cases years for debts to be paid?

In relation to volunteers in hospitals:

- 91. How much money do you expect to generate for Sydney West Area Health Service by leasing public hospital floor space to retailers at the expense of volunteers?
- 92. Will you guarantee that volunteers such as the pink ladies and hospital auxilary will not lose their fundraising stalls at hospitals in SWAHS?
- 93. What percentage of the commercial retailers revenue will go to the hospital?

- 94. Will this revenue go toward paying for equipment identified as needed by hospital staff or will it go to general revenue?
- 95. Given that volunteers raise considerable amounts of money for the hospitals, for example the Mount Druitt Hospital volunteers have raised \$1 million for the purchase of essential equipment, how will already cash strapped hospitals buy vital equipment which was traditionally purchased by the volunteers?
- 96. Are there similar plans at all Area Health Services to lease public hospital floor space to retailers at the expense of volunteers?
- 97. How many Enrolled Nurses are employed by NSW Health?
- 98. Why have changes been made which mean that Enrolled Nurses can no longer undertake the TAFE component of their training whilst employed as nurses?
- 99. Have you been advised that changes to the Trainee Enrolled Nurse program which will now require participants to do an expensive one-year TAFE preliminary component BEFORE starting their employment and therefore without earning, will limit the ability of many people from taking up this nursing option?
- 100. What impact will the loss of Enrolled Nurses have on hospitals struggling with too few nurses?

In relation to aged care residential facilities operated by the NSW Government:

- 101. How much money was spent on the review of the 11 NSW Government run aged care residential facilities completed in May 2006 which was never released?
- 102. Is the reason why the Department of Health is conducting yet another review because recommendations in the first didn't suit government plans?
- 103. If this is not the case will you now release the report of the initial review given this was the commitment made to residents of Wollondilly who have been fighting for years to retain the Queen Victoria Memorial Hospital at Picton?
- 104. How much was allocated last financial year to CHC Australia for the provision of emergency medical helicopter retrieval services?
- 105. How does this compare to the last annual allocation to CareFlight and Westpac LifeSaver for the provision of these services?
- 106. Are you satisfied that CHC has met all contractual obligations regarding reliability, safety and extended services given the considerable problems that have been highlighted over the past year?

- 107. How much funding has been allocated to implementation of programs for women and girls with mental illness?
- 108. Do you consider mental health has a gender dimension?
- 109. Considering Anorexia Nervosa it is the most fatal of all psychiatric illnesses, what policies, if any, has your office implemented to address the growing problem of eating disorders in teenage women?
- 110. What is the cost to the NSW Health System for the treatment of Anorexia Nervosa and other eating disorders?
- 111. How much is each Area Health Service currently over/under budget for the first quarter of the 2008/09 financial year?
- 112. What is the projected 2008/09 budget over run/underspend for each Area Health Service?
- 113. For each Area Health Service could you provide the 2008/09 Strategy Benefit Savings Plan, including a description of each saving strategy and the full year targets and projections for savings?
- 114. Have you received a copy of the correspondence Ambulance Officer Peter Cribbs sent to then Health Minister Reba Meagher on 1 September 2008?
- 115. What actions have you taken to investigate Mr Cribbs' allegations of nepotism and corrupt conduct within the NSW Ambulance Service?
- 116. When will you respond to Mr Cribbs' correspondence?

With reference to mortuaries in the state's health facilities:

- 117. When will an alarm system be installed at Nepean Hospital's mortuary to alert staff if the operating temperature of the mortuary has exceeded the pre-determined level?
- 118. Could you please provide a list of mortuaries in the state's health facilities that do not have an alarm system to alert staff if the operating temperature of the mortuary has exceeded the pre-determined level?
- 119. When the NSW Health 'mandatory' policy directive titled *Deceased Persons in Health Facility Mortuaries and Management of Health Facilities Mortuaries* refers to the Federal Department of Health and Ageing's *Guidelines for the Facilities and Operation of Hospital and Forensic Mortuaries* which states: "The operating temperatures of all cooled and freezing facilities should be continuously monitored. The facilities should be fitted with alarms which are activated when the temperature exceeds a predetermined level.
