# Questions from the Hon. Robert Borsak MLC

#### **MINISTRY - BUDGET AND STAFFING**

- 1. In Budget Paper 3 at page 2-39, the Policy and Finance Unit in the Ministry for Police and Emergency Services had a budget of \$4.5 million for 2011-12, but had it revised to \$10.7 million, and this year has a further increase in funding to \$10.9 million. Why the need for such an increase and how many extra staff work in the Unit now, compared to two years ago?
- 2. How many staff are there in the Policy and Finance Unit. How many of them have a background in policing and firearms, and in what disciplines do these staff hold tertiary qualifications?

#### ANSWER:

#### 1. I am advised:

The Policy and Finance service group revised figure has increased to \$10.729 million from the budget of \$4.538 million due to the internal transfer of Finance staff and one of the grant programs from the Counter Terrorism and Disaster Resilience service group. Additionally there has been a transfer of a grant program from another government agency to the Ministry for Police and Emergency Services.

## 2. I am advised:

There are 37 staff within the Policy and Finance Division of the Ministry for Police and Emergency Services, with qualifications commensurate with the range of different roles and functions carried out.

## **FIREARMS REGISTRY**

3. What studies were done which informed the previous Government's decision to locate the Firearms Registry at Murwillumbah, and what work has been done since, to determine if it is in the right place and readily accessible to its core users?

#### ANSWER:

The NSW Police Force has advised the location of the NSW Firearms Registry has not been recently considered by the NSW Police Force.

The relocation of the NSW Firearms Registry to Murwillumbah is a matter for the previous government. Any change to the location of a NSW Police Force unit would be a decision following consultation between the NSW Police Force and Government.

### FIREARMS REGISTRY

4. How many people are employed at the Firearms Registry, how many of them hold a firearms licence, and what has been the staff turnover in the Registry in each of the last three years?

#### **ANSWER:**

The NSW Police Force has advised me:

The Firearms Registry employs 89 staff. Whether employees of the Firearms Registry hold a firearms licence is a personal matter. Staff turnover at the Registry has been four in 2012, three in 2011 and five in 2010.

## **FIREARMS REGISTRY**

- 5. What percentage of Permits to Acquire are approved in a timely fashion so as the applicants wait no longer than the prescribed 28 days?
- 6. By postcode, how many applications for firearm licences are made from the Murwillumbah area, compared to Dubbo, Wagga, Griffith, Tamworth, Cessnock and Parkes?

## ANSWER:

5. The NSW Police Force has advised me:

97% of applications for Permits to Acquire were approved within a 28 day period from 1 January 2012 to 30 September 2012. The average approval time over this period was nine days.

6. The NSW Police Force has advised me:

Although information is held on the number of firearms licence holders, as not all applications for firearms licences are successful, the information requested by the Honourable Member is not readily available and its manual extraction would represent an unreasonable diversion of resources within the NSW Police Force, in particular the Firearms Registry.

## **MINISTRY - CABINET MINUTES**

7. I note the Policy and Finance Unit drew up 32 Cabinet minutes in 2011-12, and is forecasting 25 for this year. Are all cabinet minutes drawn up in consultation with the Minister, or does the Unit simply draw up what it thinks the Minister needs and presents it to him? Can you go through the process please?

#### ANSWER:

I am advised:

Cabinet Minutes are generally prepared to allow for the consideration of changes to, or the introduction of new Government policy. This requires direction from, and extensive consultation with, the Minister and the Minister's staff.

# FIREARMS LEGISLATION

8. In relation to the Firearms Amendment – Ammunition Control Bill, was a cost evaluation of the implementation of this Bill done before its introduction, and has one been done since. If so, what are the expected costs, and is this an additional impost on policing resources?

9. Was the increased red tape that will result from the Firearms Amendment (Ammunition Control) Act, considered under this review?

#### **ANSWER:**

8. I am advised:

Cost estimates have been prepared for internal planning and budgeting purposes. All costs will be met from within existing budget allocations.

9. I am advised:

The additional impost on licence holders and firearm dealers was considered when the amendments were proposed.

## **POLICE MEDIA UNIT**

- 10. How many staff are there in the Police media unit, and how does this compare to the media unit in Family and Community Services. How has this number varied over the last four years, and how many of these staff in the Police media unit work on the Eyewatch program on Facebook?
- 11. What is the budget cost of the Media Unit? How has it changed in the last four years, and how much of this change is attributed to Eyewatch?

10. The NSW Police Force has advised me the total number of people currently employed in the Police Media Unit is 27.

#### 11. The NSW Police Force has advised me:

The Police Media Unit budget for 2012-13 is \$2,916,229 (including police salaries). This funding supports a range of functions, including:

- Media management at major crime scenes and disasters
- Proactive communications and marketing projects targeting internal and external stakeholders
- Operational support to investigations through media liaison and multimedia production
- Public relations expertise including event management and website management
- Market research
- Film and TV liaison
- Corporate photography

#### **POLICE MEDIA UNIT**

12. Under our law, a person is presumed innocent until proven guilty. How then does the Commissioner justify inviting the media along to report on arrests or even serving of a warrant to search premises?

### ANSWER:

I am advised:

The NSW Police Force advises it does not invite media to attend arrests. On occasions the NSW Police Force Multimedia Unit will attend and film arrests – all Police Multimedia Unit video material is checked by legal experts to ensure the judicial process is not jeopardised.

Also on occasions police co-operate in the filming of reality-based television programs that may during filming record arrests. Police retain full rights to review and veto all content prior to it going to air.

Media is occasionally invited to film the seizure of exhibits to assist the public understanding of the matter and on these occasions it is ensured that the legal process is not jeopardised.

Where arrests occur in or near public places the presence of media is not able to be controlled by police in such circumstances.

## **FIREARMS DEALERS**

13. How many firearms have been confiscated from licensed firearm dealers in each of the last four years? How many charges were actually laid in regard to these firearms, and how many of these charges were successfully prosecuted in court?

#### **ANSWER:**

The NSW Police Force has advised me:

#### FIREARMS DEALERS

14. What steps does the Commissioner intend to take to make reparations for loss of income and damage to reputation in regard to widely publicised "raids" on licensed firearms dealers, where either no conviction is made, or the case is reduced to unintentional breaches of the mountains of red tape facing dealers?

#### ANSWER:

The NSW Police Force has advised me that if any individual considers that police have engaged in unjustified action, it is open for them to seek independent legal advice as to any possible avenues of redress.

## **RED TAPE REDUCTION - FIREARMS**

15. One of the achievements noted in the performance report for the Attorney General and Justice Cluster for 2011-12 is the finalisation of a review into reducing police red tape. When will the results of that review be made available, and what recommendations were included that would reduce the red tape attached to the ownership and use of firearms in New South Wales, the licensing and operation of commercial firearms businesses, or the licensing and operation of firing ranges in NSW?

#### ANSWER:

I am advised:

The NSW Police Force Red Tape Reduction Working Group was charged with finding opportunities to reduce red tape and paperwork for police officers to ensure that they would

spend more time policing and not behind desks doing paperwork. The working group did not canvass firearms regulations.

## FIREARMS - SAFE STORAGE INSPECTIONS

- 16. How many safekeeping inspections of licensed firearms owners have been conducted each year over the last five years?
- 17. How, and on what database, are these safekeeping inspections recorded?
- 19. Some firearms owners have reported that they have been inspected several times in the last few years, but that the inspecting officer on subsequent inspections has been unable to locate a record of any previous inspections. Why would police be unable to find a record of previous inspections? What procedures are in place to ensure that police resources are not wasted by repeat inspections of the same premises?

#### ANSWER:

16. The NSW Police Force has advised me:

The Firearms Registry has provided the following data.

17. and 19. The NSW Police Force has advised me:

Safe storage inspections are recorded on a NSW Firearms Registry database. Discrepancies with addresses may occur especially in rural areas, where address details may be limited, for example to a property name rather than a street address. In such circumstances, inspection details may not be automatically updated for such properties. Every endeavour is made to ensure the accuracy of safe storage address locations.

## **FIREARMS - SAFE STORAGE INSPECTIONS**

- 18. Do licensed firearms owners continue to be provided with a record of the date and result of the safekeeping inspection? If not, why not?
- 20. What procedure is followed to ensure that errors in the Firearms Registry identified during such inspections are relayed to the Firearms Registry so that the Registry records can be corrected?
- 21. How old are the extracts from the Firearms Registry used by officers from a LAC when they conduct a safekeeping inspection? How often does the Registry supply LACs with

updated extracts, and what arrangements are in place within LACs to ensure the security of these lists?

#### ANSWER:

18. The NSW Police Force has advised me a copy of the safe storage inspection certificate is available to a licence holder on request.

## 20. The NSW Police Force has advised me:

Any variations to data identified by police are disseminated to the Registry and Registry records are updated, usually no longer than 72 hours from the receipt of notification.

#### 21. The NSW Police Force has advised me:

The Firearms Registry is able to download a report listing locations and licence holders requiring an inspection as and when required, with data updated on a weekly basis.

Regarding the security of this data, I refer the Member to my response to a Question Without Notice titled Firearms Register, asked on 16 August 2012 by the Hon Robert Brown MLC, which was published in Hansard on 20 September 2012.

#### **POLICE USE OF TASERS**

- 1. Are Tasers currently permitted to be used by NSW Police as a "compliance technique"?
- 2. How many regional reviews of Taser use have been conducted?
- 3. How many uses of Tasers by officers were found in breach of guidelines as a result of such reviews?
- 4. What action, if any, was taken to address these breaches?

#### ANSWER:

1. Lam advised:

The NSW Police Force's Standard Operating Procedures on the use of Tasers are available at www.police.nsw.gov.au.

2. The NSW Police Force has advised me:

Each of the six Regional Taser Review Committees conducts reviews each month for all operational Taser deployments.

3 -4. The NSW Police Force has advised me:

The majority of detected breaches involved accidental discharge which occurred during the loading and unloading process. Operational Taser use is reviewed as per the Standard Operating Procedures on the use of Tasers, which are available at www.police.nsw.gov.au.

## **DRUG DOGS**

- 5. What data is collected about dog identifications and searches by police following indications?
- 6. Does the data currently being collected allow a full assessment of the efficacy of the sniffer dog program?
- 7. What is considered an acceptable level of instances where dogs indicate the presence of drugs but a search proves the person identified by the dog is not in the possession of any drugs (false positives)?

8. What data is collected to identify dogs or handlers who have particularly high "false positive" rates resulting in searches?

#### ANSWER:

I am advised:

- 5. Operations undertaken; number of searches conducted; number of illicit drug detections; and number of admissions of recent drug contact where no drugs were detected.
- 6. The drug dog program has several objectives beyond detections of drugs, including deterrence of illicit drug use and sale and high visibility policing of drug laws.
- 7-8. The characterisation 'false positives' is not accepted. Detection dogs detect both the current presence of and recent contact with drugs. See also answer to 6 above.

## POLICE OFFICER SUICIDE

- 9. What records are kept regarding the suicide or attempted suicide of active police officers?
- 10. What records are kept regarding the suicide or attempted suicide of former police officers?
- 11. What steps are being taken by the NSW Police Force to address suicide of officers?

## **ANSWER:**

9-11. I am advised:

The NSW Police Force's Self Harm Prevention Advisory Panel is responsible for monitoring suicides and attempted suicides by current and former police officers. The Panel includes the Assistant Commissioners for Human Resources, Education and Training, Professional Standards and Field Operations along with the Commander Workforce Safety.

The Panel is also responsible for researching and developing new programs and services for implementation within the NSW Police Force.

Measures currently in place include:

- Wellcheck, a psychological screening program to reduce the risk of harm before it escalates.
- Selection screening undertaken prior to transfer into high risk occupations.
- Employee Assistance Program, including support following traumatic events.

Following the introduction of reforms to the Police Death and Disability scheme, the Liberals and Nationals Government provided the NSW Police Force with \$15 million over three years to trial and evaluate new injury management initiatives and practices.

The NSW Police Force has implemented a Workforce Improvement Program to improve all aspects of injury prevention and management. Additional funding has seen an increase in injury management advisors and the creation of a dedicated Human Resources support team to intensively assist Commands to manage welfare issues.

#### HAZARDOUS MATERIALS IN POLICE PROPERTIES

- 12. Of the 460 police properties reported in 2011 as being affected by asbestos and other hazardous materials, how many still have not had work completed to remove hazardous materials?
- 13. What is the timeframe for completion of the remaining properties?
- 14. How many families are living in housing which contains asbestos or lead as identified in this report?
- 15. How many police are working in stations which contain asbestos or lead as identified in this report?

## **ANSWER:**

#### 12-15: I am advised:

The 2012-13 Budget provides \$16 million this financial year to the NSW Police Force to remediate and manage hazardous materials in its properties.

As previously announced by the Government, this investment is part of a broader allocation of \$61 million over four years to address concerns about materials such as asbestos and lead paint in both police stations and police residences.

This funding includes an investment in the ongoing monitoring of police properties to identify any emerging issues that may need remediation.

This program will ensure that any future problems with hazardous materials will be identified and dealt with quickly.

I am advised by the NSW Police Force that the risk based approach taken in determining remediation works is consistent with the NSW Government Asbestos Blueprint.

All original A1 and A2, which were considered the highest priority sites as set out in the Coffey report have been assessed. To date 45 sites have been remediated.

I am advised the majority of properties did not require remediation as the hazardous materials were in fact stable, in good condition and represented a low risk score.

## **POLICE WATER CANNON**

- 16. What are the ongoing maintenance costs for the police cannon?
- 17. What is the operating cost per hour for the water cannon?

- 18. On how many occasions was the water cannon used in:
- a. 2012 to date?

- 16. The NSW Police Force has advised me that the average yearly maintenance cost of the police water cannon is \$1,800.
- 17. The NSW Police Force has advised me that the operating cost of the police water cannon per hour is likely to be nominal, where salary costs are excluded.
- 18. The NSW Police Force has advised me that during the past three years the water cannon has accompanied Public Order and Riot Squad officers on a number of occasions in support of policing of public order incidents. However, there have been no incidents where the water cannon has been used.

#### **POLICE BOAT NEMESIS**

- 19. What are the ongoing maintenance costs for Nemesis?
- 20. What is the operating cost per hour for Nemesis?
- 21. On how many occasions was Nemesis used in:
- a. 2012 to date?
- b. 2011?
- c. 2010?

## **ANSWER:**

- 19. The NSW Police Force has advised me \$276,876 per annum.
- 20. The average cost for the 2011-12 financial year was \$230 per hour (excludes salaries).

21.

- a. 12.
- b. 22.
- c. 26.

I would remind the Member the Marine Area Command's responsibility extends from all coastal areas of New South Wales to 200 nautical miles out to sea and the Nemesis has a range of 1200 nautical miles and the ability to stay at sea for extended periods searching for lost people and vessels. This range can be more than doubled if the vessel is driven at 10 knots.

As recently as 16 October 2012 the Australian Maritime Safety Authority tasked Nemesis to the search and rescue of a yachtsman who was in need of immediate assistance in excess of 300 nautical miles from the NSW coast. Nemesis, crewed by members of the Marine Area Command, effected the rescue of the yachtsman at a point 320 nautical miles from the NSW coast.

## **FIREARMS ACT PART 6B**

22. Are there any current plans to make changes to Part 6B of the Firearms Act to improve public safety?

## ANSWER:

I am advised:

The Government has undertaken to canvas options for the possible reform of section 6B of the Firearms Act 1996 which will be considered by the Firearms Consultative Committee.

## **SECURITY INDUSTRY**

- 23. When investigating reports of firearms stolen from properties, do the Police investigating each incident check whether the provision of that secure environment in each case had been done by a contractor with a Master Security Industry licence?
- a. If not then why not?
- 24. Can a secure environment for firearms be installed by a contractor without a Master Security Industry licence?
- a. If so, under what provision of the Security Industry Act?
- b. If not, has any such non-licence holder been prosecuted?
- c. If not, has any Master Security Industry licence holder been investigated to see whether their workmanship in general meets the mandatory requirements of the Security Industry Act?

- 23. The NSW Police Force has advised me all reports of stolen firearms are investigated thoroughly.
- 24. The NSW Police Force has advised me:

- No. Class 1 and Class 2 licensees can only perform security activities while employed by a Master licence holder (if the licensee is self-employed, they must hold a Master licence in addition to their Class 1 and/or Class 2 licence).
- a. A Class 2 licence is required to install security equipment as defined by the security legislation. Offence provisions of 'carrying on unauthorised security activities' are found at section 7 of the Security Industry Act 1997.

b. No.

- c. There are no requirements within the security industry legislation relating to the workmanship of persons installing security equipment.
- 25. The NSW Police Force has advised me: No.

Police at Local Area Commands use Facebook to engage with the NSW community. The Facebook Eyewatch pages provide an opportunity for interactive and direct dialogue between police and local community members in regard to crime and suspected offenders as well as providing other important information to the community in a timely fashion. Importantly, police and Neighbourhood Watch groups are able to conduct online meetings via closed sessions on the LAC Facebook Eyewatch pages.

## POLICE USE OF FACEBOOK

30. Regarding moderation of the NSW Police Facebook page to remove "inappropriate posts" what does this cover?

## **ANSWER:**

The NSW Police Force has advised me:

The Corporate Communications Unit deletes comments from the Corporate Facebook page that may defame, discriminate, offend or impinge on privacy, as well as comments that are prejudicial, have the potential to jeopardise future judicial proceedings or create significant distress for victims. Comments that attack other Facebook users based on their point of view are also deleted; however, comments are not deleted simply because they are negative or in order to censor negative discussions.

## **EMERGENCY SERVICES**

31. Are there plans in NSW to provide access to a 000 service in NSW through emergency SMS for deaf people?

## **ANSWER:**

I am advised this is a matter for Senator the Hon Stephen Conroy, Federal Minister for Broadband, Communications and the Digital Economy.

# Questions from the Hon. Steve Whan, MLC.

#### MIDDLE EASTERN CRIME SQUAD

1. Has the Minister received any representations from the Hon John Ajaka MLC requesting that the Middle Eastern Crime Squad be disbanded or renamed to remove any reference to the term "Middle eastern"? If so please provide copies of his representations and your replies?

#### ANSWER:

I am advised all written representations made to me by the Hon John Ajaka MLC have been responded to appropriately.

As Minister I have no intention of seeking to have police rename the Middle Eastern Crime Squad.

## **POLICE USE OF TASERS**

2. Will you act to implement any recommendations on the use of tasers made by the NSW Coroner following the inquest into the death of Roberto Laudisio Curti? If not, why not?

#### ANSWER:

I am advised the coronial inquiry recommendations are yet to be finalised.

## **POLICE USE OF TASERS**

3. On 11 October the South Australian Commissioner of Police, Gary Burns, announced that South Australian police will not use a taser in any circumstances where an offender isn't armed. Will this policy be adopted in NSW and if no, why not?

## **ANSWER:**

I am advised:

The NSW Ombudsman has recently released a report titled 'How are Taser weapons used by the NSW Police Force'. The Ombudsman found that the NSW Police Force should be commended for the steps they have taken to ensure that Tasers are used appropriately.

The report makes 46 recommendations that aim to strengthen and improve Police policies, procedures and practices and to ensure public confidence in the use of Tasers is maintained. I am advised that Police are currently preparing a detailed response to these recommendations. The Police response will include careful consideration of the recommendations arising from the coronial inquiry into the death of Mr Roberto Laudisio Curti which are anticipated to be released on 14 November 2012.

## POLICE COMMISSIONER'S REMARKS

4. Minister, I refer to the exclusive interview given by the Commissioner to Andrew Clennell of the Daily Telegraph on 7 August 2012 on bail law reform. Do you think it is appropriate for the Commissioner of Police to refer to the Attorney General, the Hon Greg Smith MP, the first law officer of the Crown as a "good worker who knows the law"?

## **ANSWER:**

Public comments made by the Commissioner of Police are a matter for the Commissioner.

## **GREEN PAPER ON HERITAGE MATTERS**

5. Will you and or any of your agencies be making submissions in response to the Government's Planning Green Paper on heritage matters? If not, why not?

## ANSWER:

The release of the NSW Government Green Paper - a New Planning System for New South Wales - is one part of developing a new planning system and drafting new legislation to support that system. The Green Paper provided community and industry the opportunity to give feedback on planning policy. The Government has an established process for the development of legislation, which includes comment by government agencies at appropriate times.

## ANSWER:

The Liberals and Nationals Government announced the creation of a standalone Police Transport Command in May 2012.

The Command has been established with an authorised strength of 301 positions, with the Government committing to progressively increasing this to 610 positions by December 2014.

This will be achieved through a real increase to police numbers. Along with the additional 550 authorised strength positions the Government committed to prior to the last election, police numbers will rise to a record authorised strength of 16,665 by August 2015.

# **KINGS CROSS**

## **ANSWER:**

31. The NSW Police Force does not provide financial support for the introduction or operation of CCTV cameras.

Responsibility for the installation of CCTV cameras in public areas of Kings Cross is held by the City of Sydney Council. The City's Street Safety Cameras assist police to detect and investigate crime.

Following the recent announcement relating to improving safety in Kings Cross through the Joint Plan of Management, police are now located at the control centre in Sydney Town Hall on Friday and Saturday nights to direct and coordinate a timely police response to incidents of crime detected by the CCTV. The monitoring of CCTV remains the responsibility of the Council.

Live feeds from cameras are also able to be sent to Kings Cross Police Station when the need arises. Police continue to work with licenced premises and Councils to access CCTV footage as and when needed.

#### **NSW CRIME COMMISSION**

- 36. What process was conducted to appoint Mr Peter Hastings QC to the head of the NSW Crime Commission?
- 37. Was he appointed by media release of by departmental due process?
- 38. Did this decision of his appointment go before cabinet?

## ANSWER:

36-38. I am advised :

The position was advertised by the Public Service Commission. A selection panel conducted interviews and made a recommendation to Government. The panel consisted of Mr Graeme Head, Public Service Commissioner (convenor), Her Honour Justice Megan Latham of the Supreme Court and Mr Les Tree, Chief Executive Officer of the Ministry for Police and Emergency Services. Mr Hasting's nomination for appointment was put forward

by the Government and the formal process for confirming his appointment has now been completed. Mr Hastings commenced his role on 5 November 2012.

#### **RURAL CRIME**

39. In 2011, 1744 head of cattle and 28,389 sheep were reported stolen across NSW, costing an estimated \$3.8 million across the state. What is NSW Police doing to combat this epidemic?

40. What is NSW Police to help combat fuel theft from Rural Industries?

#### ANSWER:

39. and 40. I am advised:

The NSW Police Force currently employs 33 Rural Crime Investigators to provide dedicated policing and investigation of rural crimes, including stock theft. All Rural Crime Investigators have an understanding of primary industries as well as experience with practical stock handling and identification.

There are a range of initiatives in place to address all types of rural crime, including stock theft and fuel theft from Rural Industries. These include attendance at livestock saleyards to undertake compliance operations, regular inspections of abattoirs, saleyards, wool, hide and skin dealers and stock and station agent's offices, as well as providing assistance to primary producers to improve the security of their properties. The Rural Crime Facebook Eyewatch page, launched in October 2011, has achieved well over a million hits and offers rural communities the opportunity to interact with Rural Crime investigators.

## **EMERGENCY SERVICES LEVY REVIEW**

41. Are you aware of when the review into the RFS funding model restructure will we completed?

#### ANSWER:

I am advised the consultation period relating to the Review of the Emergency Services Funding System ended on 31 October 2012. Submissions will be considered and the review completed in due course.

## THE HUNTER

42. Why has the Government decided to cut \$1.7 billion out of the NSW education budget? Can you tell us what impact these cuts will have on schools in the Hunter?

## **ANSWER:**

## I am advised:

- Over the next four years the total required savings for Education and Communities is estimated to be \$1.7 billion. For further clarification, I would direct the Honourable Member to the fact sheet released called "Savings Measures to Meet our Budget."
- The regional structure currently in place will be replaced with a new structure.
- Changes of this nature, changes that affect people's positions are serious matters.
- The Department will be undertaking this work in accordance with the Government's Managing Excess Employees 2011 Policy and its associated procedures, such as the Agency Change Management Guidelines. The policy and guidelines set out key steps all departments must follow when undertaking a significant realignment of functions and staff.
- Since 14 September, there have been discussions with Regional Directors, School Education Directors and Principals' Associations about the new model to replace regions. A draft model will shortly be released for feedback from stakeholders.
- As for the impacts of the \$1.7 billion cuts on the Department, I refer you to the fact sheets released by the Department on 11 September, titled "Savings Measures to Meet our Budget".

#### THE HUNTER

43. Are you aware of how many schools in the Hunter have demountable classrooms?

#### **ANSWER:**

48. Earlier this year, four Hunter people died in less than a month waiting for ambulances to arrive because the vehicles were detained at John Hunter Hospital. It was reported on the front page Newcastle Herald on Friday, July 27.

a. Did the Government investigate these incidents?

b. As Minister for the Hunter, did you make it your business to take a special interest in these investigations?

#### ANSWER:

I am advised:

The Ambulance Service has reviewed each of the reported incidents.

The reviews found that in all instances the closest available ambulance was dispatched. Due to the nature of an emergency service, the Ambulance Service at times experiences surges in demand, which occurred on these occasions.

The Ambulance Service and the Hunter New England Local Health District are continually looking at better ways to manage emergency health services in the area.

The Minister for Health asked the Director General to see what else could be done to help get ambulances back on the road quicker. The Director General has advised that since that time:

- 24 hours a day seven days a week, a <u>Local Health District Executive will be responsible</u> for patient access - making sure that on the ground, local hospital and ambulance staff work closely together in the interests of better patient care.
- Meeting targets for the time it takes to transfer care from the Ambulance Service to
  public hospitals will be a priority for Districts with performance reviewed closely by the
  Ministry.

These matters are being considered in detail as part of the wider strategic review of Ambulance Services which is currently being finalised.

B: I consult with my Ministerial colleagues on many matters relating to the Hunter.

As outlined in the 2012-13 budget, the Government's 2011-12 program of voluntary redundancies remains on track to reach its target of 5,000 positions.

A labour expense cap has also been introduced as a new savings measure across the public sector with the target of a 1.2 per cent per annum reduction in labour costs growth.

Directors General will be given as much flexibility as possible to achieve the savings in the most appropriate way to meet the service requirements of their agencies. If it was solely achieved through headcount this would equate to up to 10,000 jobs over four years.

Nurses, police officers and teachers in schools have been guarantined from this measure.
