## QUESTION 1 SALES OF RACHEL FOSTER HOSPITAL

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Ms Jan Barham.

### QUESTION

- 1. What contributions were made to the Redfern Waterloo Authority for affordable housing from the sale of Rachel Foster Hospital?
  - a. What has happened to this contribution?

- A development application for the redevelopment of Rachel Forster Hospital was approved on 7 January 2013. An affordable housing contribution of \$26,161.38 was paid to UrbanGrowth NSW Development Corporation (a successor to the Redfern Waterloo Authority) on 5 August 2014, in accordance with the development approval for the site.
  - (b) This contribution was added to the affordable housing contributions fund administered by UrbanGrowth NSW Development Corporation. This fund was used to provide a financial contribution in the order of \$8,000,000 to City West Housing for the construction of The Platform affordable housing apartments (88 affordable housing units) at North Eveleigh.

## QUESTIONS 2 – 10 SPRING GULLY, BUNDEENA

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

### QUESTION

- 2. Was the Department advised of the Council resolution relating to this land adopted on 10 November 2014 which referred matters relating to zoning and permissible uses of the land to the Minister for Planning for consideration and resolution?
- 3. What consideration was given to issues raised by the OEH and RFS, as referred to by Council, into account when determining the final zoning and permissible uses for the land?
- 4. What assessment was arrived at regarding the OEH objection to Eco-Tourist Facilities as an additional permitted use for the land?
- 5. Did the Minister or his delegate receive representations concerning Sutherland Shire Council's (Council) resolution requesting that the land be placed on the land reservation acquisition map in the LEP?
  - a) If so, from who?
  - b) If so, did any members of Parliament make representations about this?
- 6. Did the Member for Heathcote make representations in support of Sutherland Shire Council's request for the land to be placed on the land reservation acquisition map and marked regional open space?
  - a) If so, what response was provided to the Member for Heathcote?
- 7. Was the Minister or his delegate contacted by the OEH or the Minister for the Environment regarding the possibility of this land being placed on the land reservation acquisition map in the LEP?
  - a) If so, did the Minister consult with the OEH or the Minister for the Environment regarding this request?
    - i. If not, why not?
- 8. Who is the relevant acquisition authority for land to be placed on the land reservation acquisition map of the SSLEP2015 and marked regional open space?

- 9. What advice did the Minister receive concerning Council's request for the land to be marked regional open space and placed on the land reservation acquisition map?
- 10. Why was this land not placed on the land reservation acquisition map?

### ANSWER

- 2. Yes
- 3. The Department considered the issues raised by the Office of Environment and Heritage and Rural Fire Service in its assessment and finalisation of the Sutherland Shire Local Environmental Plan 2015 with respect to the land.
- 4. After considering all the relevant information available to it the Department determined that the E2 Environmental Conservation zone with an additional permitted use for an eco-tourist facility the appropriate zoning for the land.
- 5. There was no request.
  - a) N/A
  - b) N/A
- 6. There was no request.
  - a) N/A
- 7. No
- a) N/A
- 8. The corporation constituted under section 8 of the Act, being the Minister administering the *Environmental Planning and Assessment Act 1979*.
- 9. Council did not request the land be marked regional open space and placed on the land acquisition map.

Council's resolution of 10 November 2014 referred the zoning and permitted uses on the former Scout land, Bundeena and the adjacent portion of Sussex Street for consideration and resolution.

10. The land had not been identified for acquisition by a public authority.

## QUESTIONS 11 – 15 LUNA PARK

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

### **QUESTION**

- 11. What steps has the Minister taken to require Luna Park Sydney Pty Limited (LPS) to perform its 2004 promise to landscape land adjacent to Harry's Park in Milsons Point and turn it over for public use?
- 12. What future actions are planned in relation to this land?
- 13. What were the public use conditions of the 99 year Crown Lease that Luna Park Sydney Pty Limited signed over Clifftop land?
- 14. What public use provisions were present in the 2004 Deed relating to Harry's Park?
- 15. What enforcement has occurred by the department regarding clauses in these contracts regarding public use of land?

#### **ANSWER**

11. - 15.

Matters relating to Luna Park Sydney Pty Limited and Harry's Park are a matter for the Sydney Harbour Foreshore Authority and the Minister for Finance, Services and Property.

## QUESTIONS 16 - 19 SCENIC HILLS

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

#### QUESTION

- 16. Can the Minister advise what consideration has been given to ensure that heritage and cultural concerns are of central significance to the assessment of the proposed Varroville Cemetery at 166-176 St Andrews Rd, Varroville?
- 17. What complaints has the Minister received from the community regarding the Minister for Heritage and Minister for Primary Industries' assessment of the development?
- 18. Since the former Minister for Primary Industries (which included Crown Cemeteries) the Hon Katrina Hodgkinson gave the NSW Government's support to the cemetery proposal on this land, which now appears in the Supporting Notes for this proposal on the Department of Planning's website, will the Minister explain why the community should have any confidence what-so-ever that this proposal will be judged on its merits?
- 19. Will the Minister for Planning and Infrastructure agree to review the final approval of the Gateway Process for the cemetery proposal and seek independent heritage advice?

#### **ANSWER**

16. The Gateway determination issued by the Department of Planning and Environment on 19 June 2015 was conditioned to require further detailed heritage investigation of the cultural landscape prior to public exhibition of the planning proposal, which will include consideration of the area adjacent to Varroville House and the views from the Campbelltown area.

The Gateway determination also requires preparation of a conservation management plan in consultation with the Heritage Division of the Office of Environment and Heritage. The conservation management plan will map and define significant fabric, landscape features, views and vistas of Varroville House.

- 17. A resident wrote to the then Minister of Heritage in November 2014, asking to reconsider the decision to refuse an Interim Heritage Order for the landscape and outbuildings surrounding Varroville House. A copy of this letter was forwarded to the then Minister of Planning.
  - The resident also wrote to the then Minister for Primary Industries in October 2014 regarding the Minister's support of the proposal. A copy of this letter was forwarded to the then Planning Minister.
- 18. The Sydney West Joint Regional Planning Panel has been appointed as the relevant planning authority for this proposal. The Panel is an independent expert body that will provide a merit-based review of the planning proposal, and all submissions received prior to making a recommendation to the Minister for Planning (or his delegate). The Minister for Primary Industries has no role in determining the outcome of the planning proposal.
- 19. The Gateway process was completed on 19 June 2015. Independent advice on the planning proposal will be provided by the Sydney West Joint Regional Planning Panel as the proposal progresses in accordance with the Gateway Determination. Any final decision on the planning proposal will be informed by the Heritage Division of the Office of Environment and Heritage.

## QUESTIONS 20 – 24 REGIONAL GROWTH AND INFRASTRUCTURE PLANS

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

### QUESTION

- 20. What requirement must be met before new Regional Growth and Infrastructure Plans are made?
- 21. How much money has been allocated to the rollout of new Regional Growth and Infrastructure Plans for 2015/16?
- 22. How is this money being spent on engaging members of the community in the regional planning process?
- 23. How will new Regional Growth and Infrastructure Plans deliver improved environment and social outcomes?
- 24. What is the relationship between new Regional Growth and Infrastructure Plans, and existing plans and strategies including, but not limited to, Regional Strategies, Regional Conservation Plans and Catchment Action Plans?

- 20. The following requirements must be met before new Regional Plans are made:
  - a. The Government endorses the draft document for public consultation;
  - b. Public consultation is undertaken on the draft documents for approximately eight weeks;
  - c. Due consideration is given to all submissions made during consultation and the document is finalised;
  - d. The Government considers a final version for approval;
  - e. Following Government approval, final documents are released publicly; and
  - f. The Minister for Planning publishes a Direction under section 117 of the Environmental Planning and Assessment Act 1979 to require all future environmental planning instruments be consistent with the Regional Plan.
- 21. In 2015/16, \$2.1 million has been allocated for new Regional Plans.

- 22. Part of the budget for Regional Plans is allocated for community engagement. Community engagement methods and associated budgets will be tailored to each specific region. General activities are likely to include:
  - Creating dedicated web pages that provide information, maps and opportunities for community comment via surveys and submissions
  - · Social media campaign e.g. facebook and twitter
  - Information campaign featuring media and print advertising
  - · Community engagement including:
    - Briefings and forums for councils, peak bodies and other key stakeholders
    - Community activities e.g. leveraging Council activities e.g. website, resident newsletters, social media, Mayoral columns; qualitative community workshops; local markets.
- 23. The new Regional Plans will deliver improved environmental and social outcomes by:
  - Being based on the principles of ecological sustainable development;
  - Identifying and protecting environmental assets of regional significance, including areas of high environmental value;
  - Focusing new housing and jobs growth in areas that are least constrained, particularly in areas that have high environmental value or are susceptible to environmental hazards, such as flooding or bushfire;
  - Seeking to increase housing supply and choice;
  - Understanding the implications of growth and change on regional infrastructure, and seeking ongoing coordination of infrastructure to service growth;
  - Recognising the value of regional cities and centres and reinforcing their functions in servicing the regions; and
  - Recognising the importance and value of regional settlements, including towns and villages.
- 24. Previous Regional Strategies, Regional Conservation Plans and Catchment Action Plans and Regional Biodiversity Strategies have been used as inputs to inform the preparation of the Regional Plans.

## QUESTION 25 PLANNING AND ENVIRONMENT

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

### **QUESTION**

25. How will the Department of Planning and Environment work with the Office of Environment and Heritage to protect the environment? Will the two departments be merged or will they remain distinct entities?

## **ANSWER**

25. The Department of Planning and Environment and the Office of Environment and Heritage are part of the same agency cluster to ensure close collaboration in environmental land use planning and promote sustainable patterns of development.

## QUESTIONS 26 - 27 ABORIGINAL HERITAGE

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

#### QUESTION

- 26. How many staff at the Department of Planning and Environment have expertise in Aboriginal heritage issues?
- 27. How much has the Department of Planning and Environment allocated in 2015-16 specifically to conserve and celebrate Aboriginal heritage?

- 26. Staff within the Department of Planning and Environment have expertise in a diverse range of fields as required by their role, including the assessment of Aboriginal heritage management plans. As part of the Planning and Environment Cluster, the Office of Environment and Heritage also contributes a diverse pool of expertise and staff in this field.
- 27. The Department focusses on Aboriginal Cultural Heritage through a variety of channels, including the Aboriginal Employment Strategy, the Aboriginal Inclusion Plan and the Upper Hunter Cultural Heritage Trust Fund, which are all funded by the Department of Planning and Environment's budget for 2015-16.

## QUESTIONS 28 - 29 INVESTIGATIONS AND PROSECUTIONS

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

## **QUESTION**

- 28. How many staff does the Department of Planning and Environment employ to investigate alleged breaches to project approval conditions? How many of these related to Aboriginal heritage?
- 29. What is the Department of Planning and Environment's budget for specifically enforcing the conditions?

### **ANSWER**

The Department's Compliance Unit undertakes monitoring and enforcement to ensure compliance with conditions of approval. The Department allocates staff to these activities as required and may engage external independent experts as part of this process, such as independent Aboriginal heritage specialists. The number of compliance officers within the Department was more than doubled in 2015, including the establishment of new offices in Wollongong and Queanbeyan in addition to the expansion of the existing Singleton and Metropolitan teams.

### QUESTION 30 DRAFT WIND PLANNING GUIDELINES

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr David Shoebridge.

### **QUESTION**

- 30. What is the current status of the NSW Planning Guidelines for Wind Farms?
  - a) Are the guidelines still in draft form?
    - i. If so, is the Baird government planning to formalise them?
      - 1. If so when,
  - b) The guidelines are listed on the Department of Planning and Environment's website as a "useful resource."
    - i. Are proposed wind farm projects, both current and future, required to abide by the guidelines even though they are in draft form?

#### **ANSWER**

30.

- a) The Government is conscious of the views of local communities in areas in which wind farms have been developed, and the sensitivities of locating wind farms. The development of a wind farm requires applicants, regulators, communities and other stakeholders to address a range of issues arising from environmental, economic, social, legal and technical factors that distinguish wind farms from other development. The NSW Government is currently considering the guidelines in light of feedback from industry and the community.
- b) The guidelines are used by proponents and regulators to guide the assessment process and provide a source of information for the community.

## QUESTIONS 31 - 36 BIODIVERSITY OFFSETS IN PLANNING

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Dr Mehreen Faruqi MLC.

### **QUESTION**

- 31. Is there any central database of offset sites in NSW?
  - a) If no, how does the NSW Government know if an offset site is being double counted as an offset for multiple projects?
  - b) If yes, who is responsible for this database?
  - c) If yes, is it publically available, if so where?
- 32. How many biodiversity offsets currently exist in New South Wales?
- 33. Does the Department of Planning monitor biodiversity offsite sites to ensure that planning approval conditions are being met?
- 34. How does the Government monitor if biodiversity offsets are being preserved in perpetuity?
- 35. How many projects were entered into under the Biodiversity Offsets Policy for Major Projects policy between 1 October, when this policy commenced, and 18 December 2014?
- 36. Please provide a list of all projects entered into under the Biodiversity Offsets Policy for Major Projects between 1 October 2014 and 1 September 2015, including details of the project, offset and proponent.

- 31. There is no risk of double counting as land tenure arrangements are checked to ensure there are no impediments or existing biodiversity offset obligations over the land that would prevent it being used as a biodiversity offset for a particular project.
- 32. Details of the offsets that have been approved for major projects across NSW can be obtained from the Department of Planning and Environment's website at www.majorprojects.planning.nsw.gov.au

- 33. The Department of Planning and Environment monitors the conditions of approval for all major projects, including the implementation of biodiversity offsets.
- 34. Proponents must provide long term protection to biodiversity offsets through an appropriate legal mechanism within a specified period (usually within 3 years). The Department of Planning and Environment monitors compliance with these obligations.
- 35-36 This data can be obtained by reviewing the Department of Planning and Environment's major projects register at www.majorprojects.planning.nsw.gov.au

## QUESTIONS 37 - 38 GROWTH DESIGN AND PROGRAMS

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr Shaoquett Moselmane [on behalf of the NSW Labor Opposition].

### **QUESTION**

- 37. In the Growth Design and Programs Service Group state that the number of FTE employees has fallen from 161 in 2013-14 to 133 in 2014-15, why? (Budget Paper #3, 8 8)
  - a) In 2015-16 the number of FTE employees is forecast to rise to 149, why?
- 38. The employee related expenses are forecast to decrease from \$24,371,000 in 2014-15 to \$23,692,000 in 2015-16. Given that the number of FTE employees is forecast to increase, why are employee related expenses decreasing?

- 37. Restructuring of the Department in 2014-15 resulted in the transfer of regional teams to the Planning Services division and the subsequent decrease in FTE employees within Growth, Design & Programs.
  - The forecast increase of FTE employees for 2015-16 includes additional staff to deliver components of *A Plan for Growing Sydney* (special allocation budget) and an associated increase in support staff across the division.
- 38. The forecast decrease in employee related expenses is attributed to a number of factors including expected savings from the SEB1 restructure and a reduction in the average per head labour cost.

## QUESTIONS 39 - 40 POLICY AND STRATEGY

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr Shaoquett Moselmane [on behalf of the NSW Labour Opposition].

### QUESTION

- 39. The number of FTE employees is to rise from a revised figure of 148 in 2014-15 to forecast figure of 173, why? (Budget Paper #3, 8 9)
- The employee related expenses are forecast to decline from 20, 670, 000 in 2014-15 to 20, 567, 000 in 2015-16. Given that the number of FTE employees is increasing, why are employee related expenses decreasing?

- The change in FTE employee numbers reflects staff increases to deliver reforms in 2015-16.
- The drop in the employee related expenses is due to a number of factors, including a reduced number of senior executive employees in the organisation.

## QUESTION 41 DETERMINATIONS IN DECLINE

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr Shaoquett Moselmane [on behalf of the NSW Labour Opposition].

## **QUESTION**

41. Determination of development and infrastructure applications within 4 months has fallen from an actual figure of 95 in 2013-14 to a revised figure of 80 in 2014-15. Given that the number of development and infrastructure applications determined remains constant at 320 why has the number of development and infrastructure applications determined within 4 months been in decline? (Budget Paper #3, 8 – 10)

- 41. The actual figure for applications determined within four months in 2014-2015 is 87% of applications. This exceeds the 2021 target of 85%. The Department also assessed 41 more applications in 2014-15 than in 2013-14.
  - Seven of the 2014-15 applications that did not meet the four month period were referred to the Planning Assessment Commission for review with public hearing, before an assessment could be completed. None of these applications were able to meet the four month period due to the reviews.

## QUESTION 42 PERSONNEL SERVICES HDC

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr Shaoquett Moselmane [on behalf of the NSW Labour Opposition].

### **QUESTION**

42. The number of employees at the Hunter Development Corporation is forecast to increase from 15 FTE employees in 2014-15 to 19 in 2015-16, why? (Budget Paper #3, 8 – 11)

## **ANSWER**

42. The forecast incorporates allowances to fill positions currently vacant subject to operational requirements.

## QUESTION 43 PERSONNEL SERVICES CCRDC

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr Shaoquett Moselmane [on behalf of the NSW Labour Opposition].

### QUESTION

- 42. Given the number of FTE employees remains constant at the Central Coast Regional Development Corporation and the number of FTE employees is set to increase at the Hunter Development Corporation, why are the employee related expenses set to decrease from \$29, 436, 000 in 2014-15 to \$4, 621, 000 in 2015-16?
  - a) Does the forecast figures for employee related expenses take into account the recent resignation of the Hunter Development Corporations Chairman Paul Broad?
  - b) If the forecast figures do not take the resignation of Paul Broad into account, can you provide a revised forecast for employee related expenses in 2015-16?

- 43. The reduction primarily relates to the Sydney Harbour Foreshore Authority transferring to the Department of Finance, Services and Innovation.
  - a) No.
  - b) As a new Chair will be required to be appointed, the budget impact is forecast to be minimal.

## QUESTIONS 44 - 47 CLUSTER GRANT FUNDING

On 2 September, 2015 during the Budget Estimates Hearing, the following supplementary question on notice was asked by Mr Shaoquett Moselmane [on behalf of the NSW Labour Opposition].

### **QUESTION**

- 44. The forecast revenue from Sales of goods and services is set to decline from \$70, 015, 000 in 2014-15 to \$47, 311, 000 in 2015-16, why? (Budget Paper #3, 8 13)
- 45. The value of Non Current Assets listed as Intangible assets is set to increase from \$26, 963, 00 in 2014-15 to \$42, 998, 000 in 2015-16, why? (Budget Paper #3, 8 14)
- 46. Can the Department provide an itemised list of the Non Current Assets listed as Intangible Assets?
- 47. Can the Department release the assessments which have been used to revalue the Non Current Assets listed as Intangible Assets?

- 44. The reduction in sales of goods and services revenue is primarily due to the Machinery of Government change and the transfer of personnel services of Sydney Harbour Foreshore Authority (SHFA) from the Department of Planning and Environment cluster to the Department of Finance, Services and Innovation cluster with effect from 1 July 2015.
- 45. This is due to the continuous development capitalisation of the ePlanning project in 2015-16 financial year.
- 46. The itemised list of Non-current Intangible assets is provided below Answer to Question 47.

47. The Department did not carry out a revaluation of the intangible assets. The Department performed an annual internal impairment assessment of intangible assets. In the opinion of the Department, there was no indication of any impairment loss during 2014-15 financial year.

Revitalising Newcastle is a six week community engagement program (10 August- 18 September 2015) designed to ensure the participation of a wide range of people from across Newcastle and the Lower Hunter region. Activities include:

- Eight Pop-Up Engagement events held at shopping centres and markets across the Lower Hunter region
- Three Community Forums (workshops)
- A Future Leaders Forum with 12-25 year olds

- Targeted engagement with local businesses, including business door knocks, a business survey, and a Business Breakfast event
- Targeted engagement with members of the community who do not traditionally get involved in community engagement on city-making issues. These include people from Aboriginal and Torres Strait Islander (ATSI) backgrounds, culturally and linguistically diverse (CALD) backgrounds, young people, young families and people with a disability
- Briefings with community and stakeholder groups, including briefings on request
- A statistically-valid telephone survey
- An online survey
- A parallel online survey administered by Newcastle City Council's community reference panel, Newcastle Voice
- Online engagement via an interactive website and social media platforms
- Print information including newsletters, noticeboards, postcards and print advertising of engagement opportunities
- The opportunity to make submissions via online, email, fax, post or in person.

To ensure an open, transparent and best practice engagement process, the program is overseen by an Independent Advisor, who is a member of the International Association of Public Participation (IAP2).

The engagement program is still underway. The projected cost for the program is approximately \$450,000. Significant cost reductions have been achieved by UrbanGrowth NSW by working in collaboration with partner organisations including Newcastle City Council, Transport for NSW and Hunter Development Corporation. Each of these organisations has provided in-kind support in the form of staff attendance at engagement events and promotion of engagement opportunities through their communication channels.

- 63. The total cost of the eight Pop-Up Engagement events held at shopping centres and markets across the Lower Hunter region was approximately \$6,000 exc GST. This cost encompasses personnel, venue hire fees and purchase of a marquee and associated materials. UrbanGrowth staff have also been in attendance at these events. As staff costs are included in corporate overheads, these have not been incorporated into the figure provided.
- 64. The Revitalising Newcastle Future Leaders Forum was attended by a diverse group of young people aged between 12-25. UrbanGrowth NSW's policy is to treat individual's privacy in accordance with the Privacy and Personal Information Protection Act 1998 (NSW).
- 65. The Revitalising Newcastle Business and Industry Breakfast was attended by a diverse range of people of varying business interests. UrbanGrowth NSW's policy is to treat individual's privacy in accordance with the Privacy and Personal Information Protection Act 1998 (NSW).
- 66. The three Revitalising Newcastle Community Forums (August 29, 30, September 12) were attended by a diverse group of people of varying ages and interests. UrbanGrowth NSW's policy is to treat individual's privacy in accordance with the Privacy and Personal Information Protection Act 1998 (NSW).

### **ANSWER**

67-68 UGNSW moved into leased government premises in Elizabeth Street in January 2014 which had an existing fit-out and loose furniture. The majority of staff that operate in the CBD offices were recruited for the CBD-based major Urban Transformation projects and have only worked in the CBD office.

Less than 20 staff have been relocated from Parramatta to CBD to date and have simply taken their belongings with them.

69 UrbanGrowth NSW continues to have a strong presence in Parramatta.

The CBD office has been established to reflect UrbanGrowth NSW's mandate to transition out of greenfields development in Sydney's West and South-West and to focus on city transformation. This role requires regular and frequent engagement

with key stakeholders in the CBD, including with Ministers' Offices and Government Departments and Agencies.

Further, many of the Urban Transformation Projects are based in inner Sydney, including The Bays Precinct, Central to Eveleigh and Green Square, and key stakeholders for these projects, including the City of Sydney and Leichhardt Councils, are also located in or near the CBD.

With this new mandate, UrbanGrowth NSW will maintain both a CBD and a Parramatta Office.

Property and accommodation expenses are disclosed in UrbanGrowth NSW's Annual Report.

The Department's recommended amendments to the *Parramatta Local Environmental Plan 2011* maintain the existing floor space control for the Female Factory precinct and slightly reduce the existing height control, ensuring the proposed rezoning would not allow for any greater impacts to those permitted under the current controls.

### **ANSWER**

In the 2015-16 Budget, the Government has committed to deliver savings by implementing further efficiency and savings measures as well as policies to eliminate duplication in government operations and reduce procurement costs. Savings measures are detailed in the Budget Papers.

Voluntary redundancies are a component for agencies to achieve their efficiency dividends. The number of voluntary redundancies achieved by May 2015 was almost double the Government's original target of 5,000 positions by June 2015, as announced in the 2011/12 Budget. The Labour Expense Cap introduced in the 2012/13 Budget also continues to give Secretaries as much flexibility as possible to achieve these savings in the most appropriate ways to meet the service requirements of their agencies. Nurses, police officers and teachers in schools have been quarantined from this measure.
