Nine staff have already relocated, eight to regional locations and several others are about to move. More employees may decide to transfer in due course.

The NSW Government recognises that some people will not and cannot move, and recruitment will occur locally to ensure continuity of service to stakeholders. I am pleased that recruitment action for 19 positions has either commenced or completed, including for several permanent positions that were previously temporary.

The regionalisation process will be a boost for Regional NSW by providing many social and economic benefits to local communities including both direct and indirect employment opportunities.

Timeframes for decentralisation projects vary, depending on the scale of the project and factors including construction timetables. The 18 month timeframe is most appropriate for this project. It provides the right balance between allowing all staff plenty of time to prepare for their decision while minimising the disruption that major change inevitably causes.

The Sinclair Knight Merz report was prepared 13 years before this decision, well before the Government's Decade of Decentralisation policy was conceived. I'm advised the scenarios detailed in the plan would not have had a bearing on the decision.

  - c. Is the decision to relocate to Port Stephens at odds with the NSW Coastal Planning Guideline: Adapting to Sea Level Rise and the NSW Sea Level Rise Policy Statement?

#### **ANSWER**

Cronulla Fisheries Research Centre has never been the Headquarters of Fisheries in NSW. Climate variability is predicted to not only affect sea level but temperatures and storm frequency. All these changes will affect different locations in different ways. Please also note that Port Stephens is only one of four regional locations chosen for the relocation.

Rising sea levels are not expected to impede access to the Port Stephens Fisheries Institute on the basis that protecting small, potentially vulnerable sections of the relatively short access road would be inexpensive and may not be needed during the effective life of the facility. All major buildings at Port Stephens have been constructed taking potential rises in sea level into account.

I am satisfied this is not a major constraint to the decision.

Furthermore, while the Unions have been parading behind its "concern for service delivery for our fisheries stakeholders", I'm advised that its work bans and campaign against the decentralisation of Cronulla have negatively impacted on the Department's capacity to undertake the decentralisation project and maintain service delivery at Cronulla.

#### **ANSWER**

As repeatedly stated, the rationale for the decision is decentralisation. The benefits of decentralisation have not been included in the Cost Benefit Analysis (CBA) but clearly were the primary driver.

All permanent and eligible temporary staff were offered the opportunity to transfer as part of the relocation project. If the staff employed in the 10 positions indicated in the CBA, decide to transfer, they will have meaningful jobs with comparable duties but obviously they will not be servicing the Cronulla site as Cronulla be closed. Consequently there are savings as a result of the relocation.

Several of the staff in those positions have already secured alternative positions and the decisions of the remaining officers will be known soon.

Your department's policy framework proposed that prior to a relocation decision relocation proposals should consider an analysis of a range of alternative locations considered, reasons for short listing locations and be accompanied with a feasibility analysis that covers, at a minimum: benefits; costs; impacts (including impacts on local communities); funding / budget implications; staff impacts and legal and administrative requirements.
  - a. Why did you fail to undertake this analysis prior to the final decision when by your own evidence you had some six months between first discussing this decision and the announcement?

#### **ANSWER**

(Please note that the May briefing [previously supplied to the Committee] was not submitted to the Minister.)

A broad range of location options were considered as part of the discussions, prior to the announcement.

In addition to access to health services, transport services and education, the three main locations (Coffs Harbour, Port Stephens and Nowra) were chosen for the following reasons:

- Coffs Harbour is located in the north of the State in a region with a large proportion of commercial fishers. It is also a key DPI centre and the location of the office of the Director of Commercial Fisheries. DPI also has an alliance with Southern Cross University and has a number of research and other staff co-located at the University's National Marine Science Centre.
- 2. The Port Stephens Fisheries Institute is internationally recognised in terms of the world class quality of our scientists and our Aquaculture and Aquatic Ecosystems research projects.
- 3. Nowra is located on the South Coast of NSW where recreational fishing is a popular pastime and where a large number of recreational fishing havens are located.
