  - a. If not, in the context of education and health spending cuts, how can the Premier justify spending additional public funds on a political party?

- a. Was the decision to establish an inquiry into the administration funding of minor political parties taken after consultation with representatives of the Shooters and Fishers Party or the Christian Democratic Party? If so, with which party and on what date did this consultation take place?
- b. Did you or any member of your office discuss the establishment of this inquiry with any representative of the Shooters and Fishers Party or Christian Democratic Party? If so, with which party and on what date did this discussion take place?
