Questions from Dr Kaye

1. Does the government intend to proceed with legislation that would allow the compulsory acquisition of one or more strata units to enable developers to demolish a block of home units and build a larger block on the site?

Employee Related Expenses

- 2. During the Budget period of 2009/10 and 2010/11 were any redundancy payments made to staff in the Office of Fair Trading?
- 3. If so, can you detail the individual payments made, by year and the reason why the redundancy was offered?

Service Measures

- 4. It is noted that Service Measures reported in the Budget Papers show a significant drop in unit percentages from highs of 93%, 99% and 96% down to 90% across the board which coincide with a reduction in staff in 2009-10. Can you explain this reduction in performance?
- 5. Is the measurement of 90% now reflected across all measurements an arbitrary figure?

Rental Bond Board

- 6. Can you explain and detail the Administrative fees associated with Bond monies under management for the Rental Bond Board which are estimated at \$25.710 million for 2010-11?
- 7. Are consultants or non-government organisations employed to manage the Bond monies on behalf of the Rental Bond Board?
- 8. Are public servants the major administrators of Bond monies management, and if so, is this reflected in the Administrative fees and at what percentage of overall costs?

Home Warranty Insurance - Managed builder program

- 9. How much money, to date, have the managed builders (i.e. the supervisors) been paid under the managed builder program?
- 10. Does this money come from the OFT budget, from the SICorp budget or from the homeowner?
- 11. How many builders have been referred to the managed builder program by SICorp or by a broker/retailer of the insurance product?
- 12. How many builders have signed up under the program?
- 13. What is the OFT budget for the program?
- 14. What is the OFT budget for managing its proportion of home warranty insurance?
- 15. What is the SICorp and Treasury budget for managing its proportion of home warranty insurance?
- 16. How many staff at OFT work on home warranty insurance?
- 17. How many staff at OFT work on the managed builder program?
- 18. How many staff work on HWI at SICorp?
- 19. What is the budget for staff working on HWI at the OFT?

- 20. How much money has been allocated within the OFT/SICorp budget to provide for potential additional liability under the HWI scheme as a result of the exercise of any discretion for builders to gain HWI although they do not meet the SICorp eligibility criteria?
- 21. How many claims have been lodged by home-owners relying on the fourth trigger (ie default on money order awarded against the builder by the CTTT) introduced from 1 April 2009?
- 22. What is the total value of these claims?
- 23. How many claims have been paid by HWI insurers under this trigger?
- 24. Has this trigger resulted in additional costs to OFT or the CTTT? If so, please provide amounts.

OFT Staff Issues

- 27. As a consequence of the Federal Government Home Insulation Program, how many property fires have been attributed to faulty insulation practices in NSW?
- 28. As the leading consumer advocate for NSW, what action did you take to protect NSW consumers from this disastrous and dangerous program?

Ministerial Announcements

- 29. In a Media Release titled "Keneally Govt Boosts Financial Counselling Services" dated 2 August 2010 reference was made to the No Interest Loans Scheme (NILS) advising that funding had increased from \$840,000 to \$1.78 million annually. Can you explain why Budget Estimate Papers 2010-11 Service, Technology and Administration, Service Group Statement for the Rental Bond Board, Budget Initiatives (at Page 12-26) clearly identify the scheme funding at \$1.6 million and not \$1.78 million?
- 30. The Media Release also claimed the preservation of \$10 million in trust to provide ongoing free financial counselling– where has the \$10 million come from?
