Coal fired power stations in NSW generate more than 80 percent of the state's electricity. In 2012-13 around 33 percent of the primary energy consumed in NSW is from coal. Therefore, the coal industry currently provides the majority of our energy supply.

## 64. What budget allocations have been made to support the implementation of this policy?

The Energy Efficiency Action Plan, released in August 2013, provided a finance facility for government energy efficiency projects with a \$95 million net lending limit; and an allocation of \$3.3 million for energy efficiency specialists to assist agencies identify and implement energy efficiency projects.

## 65. Will the annual statement required to be published by government agencies to demonstrate compliance with the policy be made publically available?(a) If so when are the first compliance reports expected to be published?

Yes. The first reports are expected after July 2015.

### 66. Will any government agencies receive additional funding to install solar panels to assist in the implementation of part E3?

The measure E3 refers to the minimum standards for new electrical appliances and equipment.

With respect to measure E5, which requires agencies to identify solar leasing opportunities, the intent is that privately owned and financed solar panels would be installed on government agency buildings. The owner would sell the electricity generated to the NSW Government at a lower price than conventional energy. There is no need for government funding.

## 67. Why have NSW Local Health Districts been exempted from the target to purchase 6% GreenPower under section E7?

Area Health Services are exempt from the requirement so it does not impact on the costs of frontline services. NSW Health may however voluntarily choose to purchase GreenPower.

The EPA has not received any expressions of interest or applications following commencement of the Protection of the Environment Operations (General) Amendment (Native Forest Bio-material) Regulation 2013 on 7 March 2014.

## 69. Please detail the process undertaken, including government agencies involved, to approve developments relating to the burning of native forest vegetation for electricity generation in NSW.

Developments proposing to burn native forest biomaterials for electricity generation follow the same development approval process as other electricity generation proposals.

Accordingly, the relevant Government agencies are the Department of Planning and Environment, and the Environment Protection Authority.

#### 70. Have any studies been commissioned or conducted into the greenhouse gas emissions produced as a result of harvesting and burning native forest vegetation for electricity generation?

#### (a) If not why not?

Greenhouse gas management is a Commonwealth Government responsibility. Accordingly, neither the Environment Protection Authority nor the Office of Environment and Heritage has commissioned or conducted studies into the greenhouse gas emissions produced as a result of harvesting and burning native forest vegetation.

## 71. Have any studies been commissioned or conducted into the air pollution including particulate matter produced as a result of harvesting and burning native forest vegetation for electricity generation?

#### (a) If not why not?

No such studies have been commissioned. All EPA-licensed Electricity Generators are required to comply with environment protection licence conditions, the Protection of the Environment Operations (Clean Air) Regulation 2010 and the provisions of the Protection of the Environment Operations Act 1997. These instruments aim to prevent or minimise air pollution, regardless of the activity or the fuel being used. The annual returns for licence holders contain the results of pollutant monitoring required under the licence conditions, as well as any non-compliances with licence conditions.

#### **CENTRAL COAST**

72. Given the drinking water supply of the over 300,000 residents in the Central Coast is at risk from the changes to the Kulnura/Mangrove Mountain Water Sharing Plan which will prioritise water trading over water conservation, the potential for CSG drilling in the catchment, Rocla's Calga sandstone quarry extension which will damage the aquifer, the Wallarah2 coal mine and its potential impacts on the Wyong River and the identification of large sections of the Mangrove Mountain district as suitable for other extractive industries such as sandstone quarries which will further damage the aquifers, why haven't similar protection measures like that adopted for Sydney, such as the ban on CSG mining, been promoted by this government and adopted on the Central Coast?

The NSW Government is committed to the protection of land and water resources in NSW.

NSW has in place the most comprehensive and transparent regulatory controls for the coal and coal seam gas industries in the country in order to protect our vital land and water resources, the environment and the health of our communities.

All water taken for either petroleum or mineral production must be fully licensed and accounted for by the NSW Office of Water.

Water Sharing Plans, created under the provisions of the *Water Management Act 2000*, establish rules for the equitable sharing of water between the environmental needs of the river or aquifer and water users, and also between different types of water use such as town supply, rural domestic supply, stock watering, industry and irrigation.

Proposed changes to the water sharing plan are still under consideration, and a draft plan will be publicly exhibited prior to the finalisation of any changes. No additional groundwater will be made available for extraction as a result of any changes.

The NSW Aquifer Interference Policy, released in September 2012, ensures the impacts of petroleum and mining developments on groundwater resources are now subject to greater scrutiny and control. This policy outlines the process through which the Office of Water assesses projects to determine any potential impacts on aquifers, and requires that operators properly address any risks to groundwater resources and undertake adequate monitoring.

Groundwater level and quality is regularly monitored across the State by the Office of Water using a network of 3,500 State-owned monitoring bores, with real-time data made available on the internet. The Office of Water is also currently enhancing its deep monitoring sites and constructing new bores in groundwater sources that are being actively explored for Coal Seam Gas and mining opportunities in NSW.

## 73. When will the incident report prepared by the EPA into the Chester Hill recycling and waste fire that burnt for two weeks in March this year be made available publicly?

The EPA has commenced a confidential criminal investigation into this incident, including the circumstances that caused the smoulder in the stockpile of building and demolition waste at Chester Hill. As this investigation is ongoing, the EPA is not in a position to release any internal documents relating to that matter at this time.

## 74. Can you confirm the management of the smouldering actually caused the fire to spread throughout the facility?

Smouldering waste stockpiles are notoriously difficult to extinguish. The EPA obtained expert advice and assistance from Fire and Rescue NSW to extinguish the smouldering stockpile, including the use of thermal imagery. The advice from Fire and Rescue NSW was to systematically dismantle and extinguish the smouldering waste. This advice was followed.

.

## 75. Are there any plans to introduce laws to overcome the liquidation loophole that companies use in the courts and that prevents the EPA from revoking their licence?a) If yes, what is the timeline for introducing these laws?

In response to this incident, the NSW Government has introduced legalisation to Parliament bringing forward a number of changes to the law to allow the EPA to take swifter action to suspend or revoke an operator's licence.

The Protection of the Environment Legislation Amendment Bill 2014 provides that:

- the EPA will no longer need to give notice of its intention to suspend or revoke a licence; and
- if the licensee appeals the EPA's decision to suspend or revoke its licence, the suspension or revocation must remain in force while the appeal is being heard.

These changes are important because the requirement to issue a notice of intent to suspend or revoke a licence means the actual suspension or revocation is delayed. In the meantime, the licence holder can continue to operate and/or change its corporate structure. Similarly, where a suspension or revocation of a licence is stayed by a Court pending the outcome of an appeal by the licensee against the suspension or revocation decision by the EPA, the licensee can continue to operate.

As with the case of the fire that smouldered for weeks at the Chester Hill waste facility, the changes being brought forward by the EPA would reduce the risk of environmental damage during the period of the notice or appeal, and reduce the unacceptable risk to the community.

It is also important to understand that the EPA's decision to revoke or suspend a licence is only taken in the most serious of cases, such as when a company goes into liquidation or shows continual disregard for its environmental obligations.

The NSW Government has also significantly increase the penalty notice amounts for:

- the 10 most serious environmental offences under the *Protection of the Environment Operations Act 1997* to \$15,000 for a corporation and \$7,500 for an individual where these are issued by the EPA or other government agencies and to \$8,000 and \$4,000 respectively when issued by local government; and
- 19 other serious environmental offences to \$8,000 and \$4,000 when issued by the EPA or other government agencies and \$4,000 and \$2,000 when issued by local government.

The NSW Government is committed to delivering a more strategic, sustainable and integrated approach to managing our coastal environment. The Government's Stage Two Coastal Reform agenda is focused on three key areas: establishing a simpler and more integrated legal and policy framework, improving support to councils and communities, and identifying cost effective options for financing coastal management.

The Office of Environment and Heritage is currently working with relevant government agencies and the NSW Coastal Expert Panel on developing the coastal reforms. The Expert Panel is made up of Emeritus Professor Bruce Thom, Professor Darryl Low Choy, Mr Angus Gordon, Associate Professor Ron Cox, Councillor Kevin Schreiber and Ms Kristin Stubbins. The Panel has considerable expertise in engineering, coastal geomorphology, land use planning and local government.

As part of the reforms, options for an independent coastal advisory body are being considered. This involves examining the roles and functions of existing bodies such as the NSW Coastal Panel, which provides advice to the Minister for the Environment on coastal matters. Membership will be considered once the roles and functions are established.

### 88. What provisions are in place to protect wildlife from injury or death during logging operations when those creatures are not listed as threatened species?

The Integrated Forestry Operations Approvals under which the Forestry Corporation of NSW operate include specific conditions to protect threatened species and their habitat. The Approvals also include general conditions which cover landscape-based exclusions zones such as riparian protection zone, high conservation old growth exclusion zones and rainforest exclusions. These protect a range of habitats for wildlife.

- 89. Are any animal welfare protocols in place to protect wildlife injured or displaced during logging operations?
  - (a) If no, are any animal welfare protocols under consideration to protect wildlife injured or displaced during logging operations?

The Forestry Corporation of NSW has an informal protocol for reporting and caring for injured wildlife, including reporting injured wildlife to the local WIRES or to an internal Forestry Corporation ecology team who then access a network of wildlife carers. The Forestry Corporation of NSW also includes specific wildlife rescue and carer details in their harvest plans on some occasions. Further questions about these matters should be referred to the Minister for Primary Industries.

- 90. Are logging contractors required to take any precautions to protect active wombat burrows from bulldozers or other logging machinery during logging operations.
  - (a) In the event that a wombat is buried alive by a bulldozer or other logging machinery, is the contractor required to take any action to rescue the wombat?

Logging contractors are required to protect threatened species in line with the conditions set out in the Integrated Forestry Operations Approvals.

The Forestry Corporation of NSW has an informal protocol for reporting and caring for injured wildlife, and can issue logging contractors site specific requirements. Further questions about these matters should be referred to the Minister for Primary Industries.

- 91. The NSW's kangaroo meat industry, especially export markets, are dependent on strict hygiene controls due to high risks toxoplasmosis amongst other things. Does NSW have a strict regime with a sufficiently resourced inspection team?
  - (a) How many inspectors are there in the Western Kangaroo Management Zones, for example the Bourke Kangaroo Management Zone?
  - (b) Are Kangaroo inspectors required to be qualified? If not, why not?

Commercial kangaroo harvesting in NSW is managed in accordance with the NSW Commercial Kangaroo Harvest: Management Plan 2012-2016. The primary goal of the management plan is to ensure that the commercial harvest of kangaroos is ecologically sustainable.

93. Do kangaroo monitoring surveys over-fly national parks and other non-harvest areas in the Central Tablelands and Far-Western Kangaroo Management Zones, with animals counted therein being used to calculate populations in harvested areas?

(a) Is it appropriate to use data from national parks to calculate harvesting data?

Due to the ability of kangaroos to move through the landscape, populations are estimated on a regional basis as estimates are less reliable over small areas. National Parks are not included in the Central Tablelands surveys.

Two public registers are maintained by the EPA on its website in relation to contaminated land. The EPA maintains a public record of all sites regulated under the *Contaminated Land Management Act* 1997 and a separate list of sites notified to the EPA.

The NSW Government recognises that packaging waste is a major issue for our environment and local communities. Australian Environment Ministers are reviewing existing container deposit schemes and better ways to manage Australia's packaging waste. As part of this review, the environmental and economic costs and benefits of many different options to increase recycling and reduce litter are being assessed. Prior to the end of the year, the NSW Government will make an informed decision based on the available evidence to arrive at a solution that is both environmentally effective and economically responsible.

Final expenditure in 2013/14 on land acquisition was \$5.41 million. In 2014/15, \$5.28 million has been allocated to purchase land for national parks and reserves.

NPWS rangers and field officers regularly monitor activities in national parks and address track creation through education of user groups and issuing of cautions and infringement notices where appropriate.

A Review of Environmental Factors (REF) has been completed for each pilot location. This included peer-reviewed evidence on the potential for weed species to germinate and spread from horse manure.

The framework for the monitoring program is publicly available, based on the REF produced. Economic benefit is not one of the outcomes monitored for this trial. Compliance with the voluntary code of practice for horse riding in parks is part of the monitoring framework. \$58,000 has been provided in 2014-15 for implementation of the monitoring framework.

Results from on-ground monitoring will be released on the OEH website. Park stakeholders will be provided with the opportunity to comment on the success of the trials.

The condition of the natural and cultural environments and the likely impact of the proposals are assessed through an environmental impact assessment and detailed Review of Environmental Factors.

Monitoring and evaluation are incorporated into the lease conditions as determined by the Review of Environmental Factors and Sustainability Assessment.

134. Minister, can you provide the details of any cost-benefit or similar analyses that have been done to compare the return on investment by the NSW Government from the cost of erecting, maintaining and marketing accommodation additional to the heritage accommodation within our national parks provides with the returns from allowing private accommodation providers to operate on properties close to National Parks?

No new accommodation buildings are being erected in national parks. All projects currently underway or being considered for NSW Government investment are for the adaptation of existing, primarily heritage, accommodation.

It contains some Projects with Objectives that suggest that the personal safety of visitors may be at risk; these Objectives include "Address negative perception"; "Modify undesirable visitor behaviour and support transition to achieve the River Red Gum visitation strategy" and "Boost the presence of NPWS in campgrounds and improve the visitor experience, confidence and safety".
  - (a) What expenditure has been allocated to ensure that visitor safety is improved?
  - (b) What economic benefits to the local communities have accrued as a result of increased tourist activity due to this action plan being implemented?

Investment to improve River Red Gum park and reserve visitor opportunities (including visitor safety) have totalled in excess of \$2 million since gazettal. Visitation to River Red Gum parks and reserves increased by 23 per cent between 2011-12 and 2012-13 and 37 per cent between 2012-13 and 2012-14 resulting in increased visitor expenditure in local and regional communities.

- 136. The four partners in the NSW Government's "Revitalising Newcastle" project are Transport NSW, Planning and Environment, Hunter Development Corporation and The City of Newcastle. In light of recent Independent Commission Against Corruption (ICAC) findings, have you or your agency/Department investigated any possible links between the City of Newcastle Councillors and the development sites and/or developers involved in the Newcastle Urban Renewal?
- 137. Are you or your agency/department aware of any submssions or representaions orally or in writing by email or letter made by Mr McCloy in his private capacity as a developer or as lord mayor, regarding developments in the Newcastle CBD? What is the date and content of such communications?
- 138. Are you or your agency aware of any submissions or representations orally or in writing via email or letter made by Councillor David Compton in his private capacity as a director of Compton Projects, which forms part of the winning consortium to develop the old Empire Hotel site? What is the date of such communications and what is the substance of such communications?
- 139. What role did the former Lord Mayor, Jeff McCloy, and former local MPs Tim Owen and Andrew Cornwell, play in advocating for these developments to Government including your agency/department and did they act in accordance with their legal and ethical obligations under current planning processes and transparency requirements?

## 140. Can you advise of the implications to heritage sites, particularly in the East End precinct of Newcastle City, due to the amendments to the Newcastle Urban Renewal State Environmental Planning Policy (SEPP)?

However, in April 2013, the Heritage Council of NSW reviewed the Newcastle Urban Renewal Strategy and formally provided comments to the (former) Department of Planning & Infrastructure.

# 144. Is the Minister aware that Newcastle is the second oldest site of European settlement on mainland Australia? How is that status recognized by the NSW Government, you, your agency/department in terms of heritage values?

Newcastle is among the earliest sites of European settlement after Sydney, Parramatta and Windsor.

Heritage values are recognised by the NSW Government through the State Heritage Register, Local Environmental Plans and historic shipwrecks. In addition heritage values are recognised under the Commonwealth National Heritage List and other non-statutory lists such as those compiled by the National Trust, Australian Institute of Architects and Engineers Australia.

There are 38 items in Newcastle which are listed on the State Heritage Register.

- 145. Does the Minister accept that best practice urban planning involves precinct planning, not just site planning, that also takes into consideration the sensitivity of Newcastle's unique built and environmental heritage?
- 146. How does the intrusion of high-rise apartment towers in Newcastle's old CBD enhance its heritage value and how does it not damage its iconic skyline?
- 147. Can the Minister confirm if the new height limit is on the same level as the roof of the nave, or main body of the Cathedral, compared with a draft proposal that was three-quarters of the way to the top of the cathedral's central parapet or tower?

Were you/your agency/the former Minister for Heritage, through the Minister for Planning, aware of a late amendment pushed through to the Newcastle Urban Revitalisation Strategy to relocate apartment towers from the West End to the heritage precinct? - 155. What parties were the proponents for this amendment and, in the interest of transparency, will the Minister table in the House all correspondence and records of meetings relating to those representations including those records which involve you, the former Minister for Heritage and your agency/department.
- 156. If the Minister will not table that correspondence and the records, how can the people of Newcastle have any confidence that the planning process has not once again been subverted, that heritage values have once again been trashed, and that the process of public consultation was a complete sham?
- 157. Can your agency / Department confirm that setbacks have been increased to a minimum of 10 to 12 metres?
- 158. Have building height controls been reviewed so that they respond appropriately to the heritage significance of heritage items, conservation areas and the local topography?

# 165. If they are not required to do heritage restoration work given that the whole sale has been justified by a commitment to restore the heritage of these properties, aren't you saying there is no justification for the sell-off of these properties?

The NSW Government is committed to maintaining and enhancing the heritage value of the State's significant places and items. The owners of any State Heritage Register listed item must meet their statutory obligations under the *Heritage Act 1977*. This includes the owner of any heritage listed property sold in Millers Point.

### 166. Are you aware of concerns raised by the National Trust regarding the impact of the Millers Point sales on our state's heritage? If so, do you agree with those concerns?

The Heritage Council of NSW will continue to have an important role in ensuring the heritage values of Millers Point precinct are maintained as required under the *Heritage Act 1977*. Sale of the properties does not change the requirements for future owners to meet their obligations under the Heritage Act. Additionally, Conservation Management Plans are being developed to guide future development and any alterations or additions in order to protect the significance of each property. As well as being listed on the State Heritage Register, all Millers Point properties are part of the Local Conservation Area under the Sydney Local Environment Plan (LEP), administered by the City of Sydney Council. Therefore, any proposed modifications to the properties need approval from the Heritage Council of NSW and the City of Sydney Council.

# 167. Do you think the social heritage connection that the community of people currently living in Millers Point has to the past, particularly their links to Sydney's days as a working port, is of heritage significance?

The Millers Point Conservation Area is listed on the State Heritage Register for its historical, aesthetic and social heritage significance.

The target of 5,000 positions by June 2015 (announced in the 2011/12 Budget) was already exceeded by a further 1,789 positions by December 2013. The Labour Expense Cap introduced in the 2012/13 Budget is also well on track with Secretaries given as much flexibility as possible to achieve these savings in the most appropriate way to meet the service requirements of their agencies. Nurses, police officers and teachers in schools have been quarantined from this measure.

There have been a number of restructures within the NSW Police Force since 2011. Highway Patrol and Commuter Crime officer numbers that were previously reported in Local Area Commands are now part of standalone Commands created under this Government. This Government has made a commitment to deliver both record police numbers and provide an open and transparent report on our progress in achieving that commitment.

The Commissioner for the NSW Police Force determines the allocation of officers based on operational requirements. Police numbers are at record highs in NSW, with authorised strength sitting at 16,396. As at 2 May, Brisbane Water and Tuggerah Lakes Local Area Commands were at 96 and 98 per cent operational capacity respectively.

  - all net proceeds will be invested in new productive infrastructure;
  - electricity network prices will be discounted by 1% off regulated prices until 2019;
  - the transaction will have no adverse impact on electricity reliability, with tight regulation by Government remaining;
  - the jobs of employees will be protected, and treated consistently with previous transactions;
  - the regional presence of the network businesses will be maintained; and
  - Essential Energy will remain in full public ownership.
- (c) In addition to answer B, Ausgrid has recently completed construction of a new depot at Ourimbah that includes an administration building, logistics satellite store and warehouse, a garage and workshop facility and pole storage yard. Staff from Ausgrid's Gosford and Noraville Depots will be based at this new facility. Ausgrid's offices at the Tuggerah Business Park are used by both Ausgrid staff and external tenants. A small number of staff from Ausgrid's offices at the Tuggerah Business Park have also relocated to Ourimbah. Ausgrid has no other plans to change the use of its Tuggerah Business Park Offices.

(a) Government Property NSW will manage the sale of the site through a public tender process once rezoning is completed. It is estimated that the rezoning will be finalised within 12 to 18 months.

GPNSW lodged the rezoning proposal with Gosford City Council on 11 August 2014. This is the first step in the process and further community consultation and detailed investigations will be undertaken in the coming months.

(b) The community has been kept updated on progress via the distribution of two newsletters in March and August 2014 which have been mailed to approximately 1500 residents in the surrounding communities. The newsletters informed the community of Government's intention to rezone and sell the Peat Island and Mooney Mooney lands, detailed the rezoning concept plan and outlined the rezoning process.

Regular updates will continue to be provided throughout key stages of the rezoning process by way of newsletters, newspaper notices and the Peat Island feedback portal.

### 278. What is the current position of the sale of the Munmorah Power Station site and the surrounding land?

The decommissioned Munmorah power station is co-sited with the new Colongra gas fired power station. The Colongra power station and adjacent land is being sold as part of the Delta Coast transaction process, which is currently underway.

The Munmorah power station site itself, along with some associated land, will be transferred to Government Property NSW. A development application for the demolition of the Munmorah power station is currently before Wyong Council.

As part of the sale process, the Government has ensured that public access and community facilities around Delta Electricity's sites will not be impacted by the sale.
