# SUPPLEMENTARY QUESTIONS ON NOTICE – 21 AUGUST 2014 WESTERN SYDNEY

# QUESTION 1:

Custom Coaches at Villawood have been in administration and receivership since May 2014 in large part because of your procurement policy, which no longer requires local content in its tenders and has removed price preferences for local manufacturers in state government contracts. The liquidators have been successful in selling the company and it's going to continue as a bus manufacturer. What will you do to protect the jobs of the one hundred or so workers who will be retained at the site?

# ANSWER 1:

This government has policies encouraging jobs growth, not protectionism.

- The government is planning for 313,000 additional new jobs in Greater Western Sydney by 2031. Importantly, this is over 50% of new jobs planned across Sydney in that time which reflects both the population growth and significance of the region.
- Announced under the Decade of Decentralisation strategy is the relocation of 3000 public sector jobs to Western Sydney.
- Announced job enhancing projects include major Health and education infrastructure
  development; transport infrastructure like WestConnex, North West Rail Link, South
  West Rail Link and Western Sydney Infrastructure Strategy; new urban renewal precincts
  (Parramatta Road, Parramatta North, Bella Vista, Kellyville and Showground), housing
  development in the NW and SW Growth Areas; and expansion of the Western Sydney
  Employment Area.
- Business support initiatives such as Smart Work Hubs (Penrith, Rouse Hill and Oran Park), Innovate NSW, Export Accelerator Program Supply Chain Accelerator Pilot Program, Industry-Research Collaboration, Supply Chain Accelerator Pilot Program, Small Biz Connect and the Jobs Action Plan also encourage jobs growth.
- NSW unemployment rate remains the second lowest in the nation, with over 165,000 jobs created since April 2011, while housing approvals are at the highest levels in over a decade. This is a clear sign that the NSW Government's commitment to invest in jobs, housing and infrastructure is paying off.

# **QUESTION 2:**

Is the government proposing to sell the right to toll the M5 West near Liverpool beyond 2026, when that toll is set to expire, to help fund new motorways in the inner and northern suburbs?

## ANSWER 2:

WestConnex Delivery Authority is considering a range of financing options for WestConnex. No final decision has been made by the NSW Government in relation to the M5 West toll.

### **QUESTION 3:**

As detailed by WSROC, the shape of the Sydney basin and prevailing wind directions mean that air quality in Western Sydney is worse on almost all measures than in most other parts of Sydney. What measures are in the budget to help overcome this problem?

## **ANSWER 3:**

The EPA will continue to undertake multiple programs to improve air quality in Western Sydney, including:

- Regulating emissions from licensed industry including compliance action and audits of air emissions
- Providing grants to local councils for wood smoke reduction initiatives during winter and
- Regulating low petrol volatility in summer and rolling out mandatory vapour recovery at service stations.

The Government has allocated \$2 million in operating funds and \$950,000 in capital funds for Government and industry funded monitoring networks across NSW. Of the 26 Government-funded stations, 10 are located in Western Sydney, including the new Camden station opened by the Government in December 2012.

There is \$3 million available for NSW air quality projects in 2014-15. This includes:

- \$270,000 to continue to update the NSW Air Emissions Inventory, a key source of information for air quality management. A web tool was completed in 2013/14 to provide the public with ease of access to the inventory information.
- \$280,000 funding for Wood Smoke Reduction Initiatives, building on the 2013/14 allocation of \$932,000. The grants enable councils to conduct smoky chimney surveys, undertake community education and provide rebates to replace old wood heaters with cleaner alternatives.
- Over \$600,000 to manage diesel emissions from non-road equipment (such as used in construction), diesel locomotives and shipping. For Sydney this includes a project working with the operators of diesel plant on major infrastructure construction sites to address poor emission performance. Standards in construction contracts of Government and related contractors is one key outcome sought.
- \$300,000 for an Air Pollutant Review of Priority EPA Regulated Facilities. Once
  prioritisation is complete, 40-50 of the highest priority facilities in NSW will be subject to a
  thorough review in 2014-15.
- \$200,000 to continue a study on Measurement of Coal Seam Gas Fugitive Emissions study, in order to develop appropriate monitoring methods and determine current ambient levels of fugitive methane emissions associated with coal seam gas extraction.
- \$80,000 to update the Approved Methods for Modelling and Approved Methods for Sampling Air Pollutants in NSW. These provide the statutory methods for modelling and sampling emissions of air pollutants from stationary industrial sources in NSW.
- Funding for air quality and health research and community air quality information, education and publications.

## **QUESTION 4:**

Will the Acting Director General of the Department of Premier and Cabinet provide the Committee with a written update on the monitoring of and inquiries into the ongoing activities of the registered lobbyist firm First State and their compliance with the requirement under the Lobbyist Code of Conduct to keep lobbying and politically activities completely separate, plus provide copies of all correspondence between the Department and First State and any of their consultants/staff including Mr Joe Tannous?

## ANSWER 4:

The Department continues to monitor and review compliance with the provisions of the Lobbyists Code of Conduct by lobbyists, including following up lobbyists with respect to confirmation of details forms, change of details forms and statutory declarations.

The Department has written to all registered political parties requesting details of the offices and positions concerned in the management of their party and the holders of these positions in order to review compliance with the provisions of the Lobbyists Code of Conduct prohibiting individuals who occupy or act in an office or position concerned in the management of a registered political party being included on the Lobbyists Register.

The Department is reviewing material provided by the Hon Luke Foley during the Budget Estimates hearing and will provide the Chair of the Committee with a written update once that review is complete.

# **QUESTION 5:**

Will the Acting Director General of the Department of Premier and Cabinet provide the Committee with a written report on any investigations into the activities of First State and the work that was undertaken by them for their client Auburn City Council and provide the Committee with copies of all correspondence between the Department and First State and any of their consultants/staff including Mr Joe Tannous?

# **ANSWER 5:**

See answer to question 4 above.

### **QUESTION 6-7:**

- 6. The Hunter region will only see \$590million of the \$1.6billion net proceeds of the Newcastle Port sell-off. That's only a third going into the local economy with the rest sent to pay for projects in Sydney. Why is the Hunter being deprived of the full proceeds of the sale of its world class port? And why is \$340 million of this money being put into the replacement of one functioning rail line with another 100m away?
- 7. \$50million of the Hunter Infrastructure and Investment Fund allocation in this budget to the city has been reserved in 2014-15 for what is described only as "Newcastle urban renewal initiatives". What are these "initiatives"? Why is the government being so vague about the details? And will the Newcastle community actually get a say in how this money is spent?

### ANSWER 6-7:

Disappointingly the NSW Labor Opposition did not support the lease of Newcastle Port.

Under Labor's plan, the Hunter region would not have received any funding.

# **QUESTION 8-11:**

- 8. Is the Premier aware that Urban Growth has had funds to remove the asbestos, lead and repair all the windows in Challoner Cottage?
- 9. Is the Premier aware the Urban Growth was instructed to do this work but have not started yet?
- 10. Does the Premier know how much funding is being held by Urban Growth for the work to be done on Challoner Cottage?
- 11. Are they close to an agreement for Challoner Cottage to be placed on the Crown List of property with Renwick Association to hold the Crown Lease? If not, what is the delay and when will the final decision be made?

### ANSWER 8-11:

UrbanGrowth NSW has project funding for maintenance and repairs of Challoner Cottage. Approximately \$150,000 is being held for works.

The works are proposed to coincide with restoration works, the outcome of which is pending a decision on the transfer of Challoner Cottage to Crown Lands. UrbanGrowth NSW continues to maintain the property to meet the *Minimum Standards of Maintenance and Repair* consistent with Challoner Cottages State heritage listing.

Family and Community Services has formally requested that a Crown Reserve Trust be established over Challoner, including the proposal for the Renwick Association as trustee for the property, and the Department of Trade and Investment is currently considering that request.

## **QUESTION 12-13:**

- 12. On the 15<sup>th</sup> of June this year the Newcastle Herald revealed ("Junction Public School finally funded to replace buildings lost in 1989 earthquake") that the NSW Government had committed to replacing demountable classrooms at the Junction Public School. The Member for Newcastle, Tim Owen, claimed that between \$2.5million and \$3million had been set aside in this year's budget to build the new classrooms. Although: "there will not be an individual line item spelling it out as such". Without a dedicated budget line item, do parents and teachers at the Junction Public School have anything but Mr Owen's word to go on that this funding exists and work will actually commence?
- 13. Is there any, in writing, in the budget commitment to actually build these new classrooms? And if so, why did it take this long to replace them? The needs of the students at the The Junction Public School haven't changed over the last three years, these buildings were needed just as much back then as they are now. Indeed, Mr Owen even campaigned on the issue at the last state election. Why has it taken so long for this Government to Act?

### **ANSWER 12-13:**

Funding has been allocated for new permanent accommodation at The Junction Public School in 2014/15.

## **QUESTION 14:**

Also why is this government failing to provide adequate classrooms to other public schools in the Hunter? In the Maitland Mercury, on July 6 this year ("Rutherford school calls for permanent rooms") it was revealed that Rutherford Public School is bursting at the seams with the computer room and library being used as permanent classrooms. The school's ten demountables are not enough to cope with the School's 780 students. When will Rutherford's demountables be replaced with additional more permanent classrooms?

## **ANSWER 14:**

An educational needs strategy incorporating Rutherford Public School is being prepared for the Maitland Growth Corridor to address any future increase in demand.

It also requires the disclosure of political donations of \$1000 or more made by major political donors.

## ANSWER 65-71:

- 65-67. Agencies and departments undertake internal reviews of its structure to ensure that its functions and priorities align with the changing needs of Government. This work has involved reviewing structures in various parts of the agency to achieve greater alignment with the Government's reform agenda and recommendations of the Commission of Audit.
- 68-71. The Government's program of voluntary redundancies remains on track. The target of 5,000 positions by June 2015 (announced in the 2011/12 Budget) was already exceeded by a further 1,789 positions by December 2013. The Labour Expense Cap introduced in the 2012/13 Budget is also well on track with Secretaries given as much flexibility as possible to achieve these savings in the most appropriate way to meet the service requirements of their agencies. Nurses, police officers and teachers in schools have been quarantined from this measure.

The level of Aboriginal employment as at 30 June 2014 is estimated at 2.9%. This is still subject to final quality checks, prior to the November release of the Workforce Profile 2014.
- 86. The 30 June 2014 estimate of Aboriginal employment in the sector is 2.9%. This compares to the Workforce Profile 2013 report which estimated the level of Aboriginal employment in the sector at 2.7%.
