Q. 3. What is the percentage of hybrids in the car fleet associated with the Department of Justice?

There is no agency titled Department of Justice. The policy of the Department of Corrective Services is to maintain a minimum of 1% of the passenger fleet as hybrids. The current figure is 1.4%.

Q. 4. Is there a mechanism within the agency to reward staff who choose not to exercise an entitlement to a fleet vehicle as a part of their package but use public transport instead?

ANSWER:

No. The Department facilitates the purchase of annual rail passes for employees.

Q. 5. What car does the Commissioner drive?

ANSWER:

The Commissioner's motor vehicle forms a part of his remuneration package.

No change has been made to the position of Probation and Parole Officer.

Q. 8. If so, what have these changes involved?

ANSWER:

Not applicable.

Q. 9. Were any new parole officer positions created?

ANSWER:

I am advised-

74.4 new Probation and Parole Officer positions (equivalent full-time positions) have been created in the past three years.

Q. 10. If so, what are the conditions of these contracts and how do they differ from the existing contracts of parole officers?

ANSWER:

I am advised-

The conditions of employment that apply to these positions are no different to any other Probation and Parole Officer positions within the Department.

As stated above in response to Q.6, some Probation and Parole Officers were recruited on the basis that they agree to undertake weekend and evening work.

The complete conditions of employment that apply to Probation and Parole Officers may be found on the Department of Premier and Cabinet web-site.

Q. 11. If any new positions were created with a different classification, were existing parole officers offered these new positions?

ANSWER:

I am advised-

New positions are not offered to any staff.

Vacant positions are advertised and filled on the basis of merit selection.

Q. 12. How have these changes impacted on overtime and the allotment of shifts?

ANSWER:

I am advised-

There has been no impact on overtime or the allocation of work.

- Q. 19. Is it standard practice to send staff members out across the State to report on the outcome of an inquiry rather than communicate in writing?
- Q. 20. Are you aware that staff members were told by Ms Crilley and Ms Colley that adverse findings were made against Mr O'Rourke in relation to bullying and harassment and that he was "counselled" by Assistant Commissioner Ian McLean and was also made the subject of a performance review?

Answer:

I am advised-

The Department has comprehensive policies that deal with allegations of bullying and harassment in the workplace. Allegations of misconduct are referred to the Professional Conduct and Management Committee which decides on the appropriate action to take. The Committee is oversighted by the ICAC. The action taken may include investigation, counselling, mediation, training or disciplinary action.

Positions in the Department are filled on the basis of merit as provided by the Public Sector Employment and Management Act.

Prison Cost

- Q. 21. Given that in New South Wales it costs more than the National Average to keep a prisoner in custody:
 - a. What are the reasons for this additional cost compared to other states?
 - b. Has the Minister undertaken comparisons between Government-owned and run correctional centres and privately run centres in terms of cost and output, if so what have the results of your investigation shown?
 - c. What action is the Government taking to reduce this cost to taxpayers?

ANSWER:

- a. Costs vary depending on a number of factors including profile of offenders, age of facilities, programs and services provided.
- b. The member is referred to the Commissioner's press releases related to the Way Forward.
- c. I am advised that this information is publicly available.
- Q. 22. Last year you used the Australasian Prison Ministers Conference to claim that the Howard Government was 'dragging the chain' on prison mobile phone jamming devices. It has now been nearly a year since the Rudd Government was elected, what has happened with the installation of mobile phone jamming devices since its election?
 - a. Where is the hold-up? Is it with you or with the Federal Government?
 - b. What actions have you taken to install mobile phone jamming devices in NSW prisons?

ANSWER:

I am advised:

- a. The deployment of jamming devices are prohibited under Australian law without exemption from the Australian Communications and Media Authority.
- b. The Corrective Services Administrators Council (comprising all Australian Corrective Services Departments) has re-convened its working party, which continues to meet with the Australian Communications and Media Authority (ACMA) and the Commonwealth Attorney General's Department to pursue further testing of emerging technology to jam mobile phones in correctional centres without interfering with lawful use of mobile phones in the surrounding environment.

Q. 24. What percentage of the Indigenous prisoner population take up these programs and services?

ANSWER:

I am advised that this information is in the transcript of proceedings of the Legislative Council Social Issues Committee Inquiry into Overcoming Indigenous Disadvantage in New South Wales and in the Department's Answers to Questions on Notice tabled in that Inquiry.

Q. 25. Are you aware that the highly respected CEO of the NSW Aboriginal Legal Service, Mr Trevor Christian, has stated to the Standing Committee for the Inquiry into Overcoming Indigenous Disadvantage in NSW, quote:

"There is no rehabilitation in prison at all, and I have been going there since 1968. You would like to think there is rehabilitation in there but there is none."

Is this a clear indication that the programs you have in place are not rehabilitating but just filling time?

ANSWER:

I am advised that the programs developed and implemented by the Department are evidence based and targeted towards the specific criminogenic needs of offenders. Programs are directed at those offenders who are at greatest risk of re-offending.

I am further advised that information concerning the Departments commitment to rehabilitation is publicly available, as stated above in answers to Q.23 and Q.24.

Q. 26. What is the recidivism rate for Indigenous prisoners across the state?

ANSWER:

I.

I am advised that in 2005-06 the rate of return to a full-time custodial sentence for Aboriginal offenders released on completion of a full-time custodial sentence was approximately 10% higher than that of the New South Wales average. The New South Wales average figure is publicly available.

Q. 27. Did the Commissioner appear before the inquiry into Overcoming Indigenous Disadvantage in NSW?

ANSWER:

The Commissioner was represented by Assistant Commissioner Luke Grant, who as Assistant Commissioner Offender Services and Programs, is directly responsible for Indigenous offender issues.

Q. 28. Given that the ABS' report into Corrective Services, June 2008, states that there were 2,072 Indigenous prisoners in NSW, which makes up nearly 21% of NSW's prison population, why did the Commissioner choose to ignore Indigenous disadvantage by not attending the Overcoming Indigenous Disadvantage in NSW inquiry?

ANSWER:

Recidivism and rehabilitation

Q. 29. BOCSAR's recent research bulletin 112 claimed:

"There is little chance of achieving this (the Government's stated goal of reducing recidivism by 10% by 2016) goal through programs that only reach a small proportion of offenders coming into contact with the criminal justice system."

What is your response to this statement?

ANSWER:

I am advised that my response to these comments is available on the Lawlink web-site.

Q. 30. Why does NSW have the highest recidivism rate of any State in Australia?

ANSWER:

The apparently high recidivism rate in New South Wales reflects a tougher approach to sentencing. The Government makes no apologies for the fact that offenders re-appearing before courts in New South Wales are more likely to get a custodial sentence than in other jurisdictions.

A review of trends in the use of full time imprisonment as a sentencing option published by the Judicial Commission of New South Wales in November 2007, confirms that for offenders sentenced in Australia in 2006-07, New South Wales has the highest imprisonment rate for offences of sexual assault, robbery, more serious robbery offences, break and enter and burglary offences.

Furthermore, recidivism figures are affected by the intensity of policing and the profile of offenders.

- Q. 31. A survey of Probation and Parole staff indicated there was a lack of access to suitable mental health, drug and alcohol services for offenders on supervised bonds, what measures are you undertaking to increase access to these services?
 - a. What is the total cost increase of funding of these programs?
 - b. Are there any new rehabilitation programs that you will be implementing?

ANSWER:

Provision of mental health and drug and alcohol services for all members of the New South Wales community, including offenders on supervised bonds, is the responsibility of New South Wales Health. Services are also provided by a range of non-government organisations, many of which are funded by New South Wales Health.

Q. 32. The Productivity Commission's Report on Government Services 2008 found that NSW had the highest rate of prisoners returning to prison within 2 years at 43.8%, do you have any forward estimates of this recidivism rate for the next year?

ANSWER:

No.

NSW Treasury has written to the Director General confirming that the printing error occurred after receipt of the final draft reviewed and signed off by me.
- 37. No. The Department's capital budget remains the same at \$50.869 million.

- 49. Has your Department complied with this directive since the introduction of the offset?
- 50. Are you aware of a letter from Ms Neville the Attorney General's Department which claims that "Effective from 1 July 2008 recipients of the Judges Pension scheme will be able to claim the 10% rebate"?
- 51. Do you agree that this letter shows a manifest error from your Department in that the rebate was available from 1 July 2007?
- 52. Will you reimburse retired judges who were denied the benefit and use of those extra incomes in 2007/2008 because of your Department's failings?

- 47. Yes. This offset is provided under section 301-100 of the *Income Tax Assessment Act 1997*.
- 48. Yes.
- 49. In November 2007 the Attorney General's Department received verbal advice from the Australian Taxation Office (ATO) and understood that the 10% rebate could only be claimed at the end of the financial year. Review of this offset arrangement has revealed this interpretation to be incorrect. The Department sought further advice from the ATO. From July 2008 the Department complied with the directive, and the judicial pensions database was amended to apply the 10% rebate for all retired judges.
- 50. Yes. The letter gave recipients of the Judges Pension Scheme an option to claim the 10% rebate either when submitting their tax return, or on a fortnightly basis administered through the Department's payroll. The letter requested that pensioners indicate their preferred option for claiming the 10% rebate for 2008/2009.
- 51. No. The letter was sent specifically to obtain information regarding a preferred option for the 10% rebate effective from the 2008/2009 financial year.

In respect of the 2007/2008 financial year, in April 2008 a separate letter was sent to all recipients of the Judges Pension Scheme providing information on the availability of the 10% rebate effective from 1 July 2007. The option available, as advised by the ATO, was to claim the rebate through tax returns.

52. No. Retired judges who were unable to access the 10% rebate on a fortnightly basis for the 2007/2008 financial year have been able to claim the rebate through the ATO.
