## Questions from the Hon Shaoquett Moselmane MLC [on behalf of the NSW Labor Opposition]

### Westconnex

1. What is the extra \$500 million allocated to the Westconnex project being spent on?
2. What is the construction cost for each of stages 1, 2 and 3 of the Westconnex?
3. What are the recurrent costs for each of stages 1, 2 and 3 of the Westconnex?
4. In present dollar terms, what are the benefits of each of stage 1, 2 and 3 of Westconnex?
5. What is the NPV for each of stages 1, 2 and 3 of the Westconnex?
6. How many homes are to be compulsorily acquired for each of stages 1, 2 and 3 of the Westconnex?
7. How many homes have already been acquired for each of stages 1, 2 and 3 of the Westconnex?
8. How many homes are to be voluntarily acquired for each of stages 1, 2 and 3 of the Westconnex?
9. Infrastructure NSW has Westconnex's benefit cost ratio of "over 1.5." What factors are included in Infrastructure NSW's project assessment?
