1. What submissions did the department make to the review of Bail undertaken by former Attorney General John Hatzistergos?

The department provided assistance in the form of research and information to the former Attorney General John Hatzistergos as he was undertaking the review of the Bail review.

2. What advice have you sought about the changes?

The reforms have been discussed with stakeholders represented on the Bail Monitoring Group.

3. What is the projected impact of the change to the bail laws to remand populations in NSW?

I am advised:

Inmate numbers, including those on remand have historically risen and fallen for a complex range of reasons. The Government will continue to closely monitor any changes in the remand population by way of the Bail Monitoring Group which is provided with data from the Bureau of Crime Statistics and Research.

Corrective Services continually maintains statistics on inmate population, including those on remand.

14. What is the average cost per day per juvenile inmate?

Corrective Services does not separate costs of male and female inmates.

Corrective Services does not separate costs of male and female inmates.

17. Has further consideration been given to trialling computers in cells to allow inmates to expand their educational prospects and connect with their families?

Yes

18. How is the Government planning to reduce the appalling high and inequitable proportion of Aboriginal and Torres Strait Islander juveniles incarcerated?

While the Government acknowledges the proportion of Aboriginal young people under supervision in the justice system is too high, the number of Aboriginal and Torres Strait islander young people in custody has dropped by 18% since 2010-11.

Research has shown the over-representation of Aboriginal young people in the juvenile justice system can be linked to a number of factors associated with homelessness, family violence and poverty. (BOSCAR 2006)

Juvenile Justice has developed a number of strategies to address this over-representation, including the development of an Aboriginal and Torres Strait Islander Cultural Respect Framework. The Framework is the Division's blueprint for creating cultural respect across services, programs and staff. A key feature is the development of cultural standards and practices for program development and service delivery.

19. What programs are already in place to address this?

Juvenile Justice delivers a number of Aboriginal focused programs which are culturally appropriate for Aboriginal young people. These programs include Our Journey to Respect, an intergenerational and violence program, and alcohol and other drugs program Dthina Yuwali. The Intensive Supervision Program works with parents and siblings of young offenders to help break the cycle of crime.

20. What future steps are planned?

The Aboriginal and Torres Strait Islander Strategic Plan sets the direction of efforts in Juvenile Justice to reduce re-offending. Initiatives in the plan inter alia are:

- recruitment and retention of Aboriginal staff and providing non-Indigenous staff with appropriate cultural knowledge to work effectively with Aboriginal young people and
- programs and interventions to reduce the risk, severity and frequency of re-offending of Aboriginal young men and women.

21. Do you and your Department still support the NSW Aboriginal Justice Plan beyond Justice 2004-2014?

The Aboriginal Justice Plan (2004-2014) was introduced under the former NSW Labor Government.

The plan is due to expire on 31 December this year and the Department will examine its effectiveness and develop options for its replacement because reducing the over-representation of Aboriginal people in the justice system is a priority.

- 22. What is the current funding for 2014-15 for local court diversion programs, including Drug and Alcohol MERIT, Circle Sentencing, CREDIT, and Forum Sentencing?
 - (a) What was the funding for the same programs for 2013-14?

The Department's 2014-15 budget is publically available and appropriate amounts thereof will be applied to court diversion programs.

This information is publically available.

26. Will you rule out privatizing or outsourcing any of the Sheriff's offices' current functions?

The Sheriff's Office uses some contract resources to assist with court security. The Sheriff's Office's is in discussions with the State Debt Recovery Office (SDRO) about potentially transferring the Sheriff's Office debt enforcement activities to the SDRO.

Options necessary to provide efficient and effective services for the people of NSW are constantly under review.

27. What is your response to consorting laws being used against those with intellectual disabilities who are clearly not gang members?

Laws are used where considered appropriate by NSW Police.

I am advised that the NSW Police Force has incorporated guidance on the appropriate use of discretion in relation to consorting warnings into training and Standard Operating Procedures.

28. Has the Auscript, or any other transcription/sound monitor company donated to you or the liberal party?

All donations are dealt with under the Election Funding, Expenditure and Disclosures Act 1981.

29. What has been the cost off changes to the name of your Department in 2014? (a) What has been the cost of changing web sites?

The Department has ensured that all previous stock of department resources were exhausted to ensure there was no waste or additional costs associated with the change in name. Logos on templates and websites have been updated using internal staff. Staff have been directed to exhaust the existing stock of preprinted materials including any letterhead, business cards, brochures and forms before ordering any new supplies with the new logos.

I am advised that the NSW Bar Association held a general meeting on 17 September 2013 to vote on the motion to allow barristers to incorporate. The motion was unsuccessful.

85. Have any wings or portions of prisons been reopened since 1/7/13 and how many prisoners are held there?

Yes – numbers vary.

86. There's quite a waiting list for the treatment program in prison for sexual offenders called CUBIT. How long is the waiting list now?

The eligibility/waiting list is dependent on factors such as the inmate having served an appropriate part of the non-parole sentence and is therefore not an indication of current eligibility.

87. How widespread is CUBIT?

(a) Does it operate in prisons in regional areas in NSW?

CUBIT is currently provided at Cessnock Correctional Centre and the Metropolitan Special Programs Centre.

- 88. Does the Mothers and Children Program continue to operate in NSW prisons?
 - (a) How many prisoners participated in the program in the last financial vear?
 - (b) How many are projected to participate in the coming financial year?

Yes.

(a and b) 29 women and 45 children participated and it is anticipated there will be an increase in the number of occasional residence applications and community referrals for women expecting non-parole periods of between two and four years.

89. Why is it that women have less access to education, rehabilitation and employment training programs while imprisoned than do men?

Female inmates have access to education, rehabilitation and employment programs. Given the small numbers of women at some centres, and the limited programs specifically developed and demonstrated to be effective with women, some rehabilitation is provided on an individual basis rather than in a group format.

In August 2014 the Intensive Drug and Alcohol Treatment Program commenced at Dillwynia Correctional Centre. This program aims to provide treatment for up to 50

female inmates when fully operational (in combination with the male program around 300 inmates in total will participate in the program when fully operational).

Women have the same opportunities as men to participate in basic education courses delivered by Adult Education and Vocational Training Institute staff. Inmates with the highest assessed needs in Literacy and Numeracy are targeted for these courses.

90. Why is it that women in prison can earn a higher wage by working in a prison industry than if they do a full-time educational course?

An inmate who is employed full-time and chooses to be involved in education programs can access full wage opportunities.

- 91.Last year your Government privatised the Community offenders Support Program (COSP) and said the private sector would run such services.
 - (a) Which private bodies have now been engaged to run such services and programs?
 - (b) How much is paid to those private operators?
 - (c) How many released prisoners have been assisted under these new arrangements?
 - (d) How many released prisoners have found accommodation as a result of these services?

(a-e) CSNSW has retained one COSP (Malabar), under CSNSW operation and will have one COSP (Campbelltown), to be tendered to the non-government and private sector for operation. The tender process is yet to be finalised. Through the NEXUS information session, inmates with three to six months left to their earliest expected release date are provided with information to assist with their reintegration into the community. There may be a number of reasons why an inmate is not granted parole. Data on whether this is related to availability of suitable accommodation is not available.

92. Granted the current incredibly low recidivism rates of ex-prisoners on the Community Restorative Centre (CRC) program, why did you cut their funding?

The NSW Government has launched new funding packages in order to support offenders upon their release, making communities safer in the process. The \$17 million package over three years will assist in the reintegration of offenders into the community and better focus on those parolees at higher risk.

93. Won't the reduction in CRC's funding mean greater recidivism, more people returning to prison and greater costs to the corrections system?

96. Prisoners frequently have complex issues: mental illness, cognitive impairment, homelessness, alcohol and other drug related use. How can you expect anything meaningful to be done about that in 12 weeks?

Corrective Services recognises that offenders with complex needs may require extended support (beyond 12 weeks) and this period can be extended.
