QUESTIONS ON NOTICE – PUBLIC HEARING 5 JUNE 2014 – IMPACT OF GAMBLING ON INDIVIDUALS AND FAMILIES

In the Hearing on 5 June 2014, the following question was taken on notice. The response to this question is provided below:

"The Hon. Charlie LYNN: You deal with community policing in your area. Do they have any idea of the extent of illegal gambling?

Ms Bray: They may. That would be another department of the Fairfield Council, the enforcement department around use of buildings. They work closely with the police, but we are in the social planning department. We could take that on notice and see whether there is some information. I am aware that they have closed down one or two, but I have not heard that there are a lot of investigations or closures in that area. We can come back to you."

Response

Advice from the enforcement section of Fairfield City Council is that no Penalty Infringement Notices have been issued by Council in relation to illegal gambling. Illegal gambling is a criminal matter and enforcement is a matter for the NSW Police Force, not local government. Information relating to illegal gambling can be gained from Fairfield or Cabramatta Local Area Commands.
