

# INQUIRY INTO COMMUNITY SENTENCING OPTIONS

#### ISSUE

#### **QUESTION 1**

Do you know the proportion of your client base that is in gaol compared with those with community-based sentences?

#### **ANSWER**

As part of the ongoing close liaison between the Statewide Behaviour Intervention Service (BIS) of the Department of Ageing, Disability and Home Care and the Department of Corrective Services, BIS has received in the last 8 months, 182 requests for support or advice in relation to clients in contact with the criminal justice system.

This figure relates only to the portion of clients who have been referred to BIS for specialist support.

Out of these 182 persons:

81 are serving custodial sentences (except two who are on remand);

Out of the remaining 101 persons:

35 persons are currently on community based orders (including bonds, s32, etc).

Furthermore, 27 persons (from the 101) have current matters before the courts. Note also that, in the past eight months, 31 persons have been diverted from custodial sentences through the use of court reports and treatment plans (ie. no client who has been provided supports from the BIS's forensic team through court proceedings, has received a custodial sentence).

# **QUESTION 2**

How many people (with a disability) are missing out on accommodation and support and how many people who are on orders and come to you miss out?

# **ANSWER**

The Department has identified 1,103 persons with a disability across its seven Regions waiting for accommodation support.

- a) Of those 1,103 persons on the waiting list, ten (10) are on a community based order or sentence, including one person on a Bond;
- b) There are an additional 26 persons who are eligible for supported accommodation involved with the criminal justice system but are not on an order or sentence;
- c) Of the total number of persons waiting for accommodation, 12 persons identified as Aboriginal. The majority of them, but not all, are involved with the criminal justice system (either in jail, or on a community based order or sentence).

There are an additional 25 persons whose Aboriginal status is unknown.
