I refer to your letter dated 8 March 2012 regarding my appearance before the Standing Committee on Social Issues.

I return to you the transcript of Hansard. I have made a number of minor amendments as requested. I also attach a list of court at which CCTV facilities are available throughout the State together with a list of courts that do not have the benefit of those facilities. As the Committee may appreciate courts which do not sit full time are unlikely to have such facilities installed because of the cost/benefit consequences.

A list of those courts with AVL facilities is also provided for your information. Advice from the Department of Corrective Services establishes that during 2011 AVL facilities where used on 64,161 occasions.

Your letter also asks for any additional information I might wish to provide to the Committee. My additional response related to a question by The Honourable Helen Westward regarding establishment of special domestic violence courts in addition to what I said to the Standing Committee. I would add that I wish to draw the Committee's attention to the wisdom of Mr Justice Heydon set out in paragraph 122 of the High Court's decision in *Kirk v Industrial Relations Commission; Kirk Group Holdings Pty Limited v WorkCover Authority of New South Wales (Inspector Childs)* [2010] 239 CLR 531 [122].
