Re: INQUIRY INTO OPPORTUNITIES TO CONSOLIDATE TRIBUNALS IN NSW

I am attaching hereto relevant material in support of my submission to the above inquiry. This material has been compiled as a result of my dealing with the Consumer Trader and Tenancy Tribunal over the last four years. Exhaustive efforts have been made to address and correct a very substantial injustice suffered by my son, at the hands of the CTTT.

These documents include:-

1. Letter to the Premier of NSW
2. Alleged areas of maladministration in the CTTT
3. False claims by the Applicants to the CTTT
4. Reference to CTTT Amendment Bill 2008 and Upper House Inquiry.

The foregoing does not include all the material that is available; such material can be made available upon request.

This matter has been made un-necessarily complex due to Tribunal Member's inability to grasp and examine the original complaint. It is basically very simple; i.e. the Applicant claimed that the contractor had used some inappropriate material, necessitating the complete redoing of the entire project. This ludicrous claim was not, on the one hand, required to be proven and on the other hand, the Respondent was not allowed to have his rebuttal report considered.

The former Minister for Fair Trading referred the matter to the Director General. The Director General convened a meeting. At this meeting, it was reaffirmed that all material used was entirely appropriate, if not superior. The Director General then proposed referring the matter to the Professional Practice and Review Committee.

The Committee took almost a year to reach a decision. The decision was simply a hypocritical attempt to provide a "white wash" for the Tribunal. It did not involve contact with the Respondent or myself, as his representative. I have since learnt that the Committee is "stacked" with Tribunal Members.

This matter has been brought to the attention of:-

1. The Premier (past and present)
2. The Attorney General (past and present)
3. The Director General (past and present)
4. The Minister for Fair Trading (past and present)
5. The Chairperson of the CTTT (past and present)
6. Various Local Members (past and present)

In the light of no positive response from any party, I can only cynically assume they are all part of a criminal conspiracy to pervert the course of justice and contribute to the denial of basic human rights. I trust this opinion will not prevent me from contributing in some positive way to this inquiry.
