"These blokes must be crazy!". Or so I thought when they asked me to be very careful in loading their strange looking instruments onto the Pack- Horses. When asking what these things were for, I was told that they were for measuring the quantity and depth of water in rivers and streams. Well !, I thought that everybody knew the easiest way of doing that was to ride one's horse into the water, and if it came up above the saddle flaps, one's horse and you would soon be swimming.

The year was 1947. Surveyors and Engineers from the Water commission were packed in on horseback from the Khancoban side and other places. They were the Forerunners in the construction of the Snowy Mountains Scheme, and it was from them that I learnt of this great and ambitious plan to stem waters which ran wasted into the Sea. The Revenue gaining By-product of this design was to be in the way of generating Hydro-Electric Power, whilst waters stored and turned inland to our somewhat parched inland would enhance our rural areas. Thus, making a very secure Food Bowl for our Australian Population at large.

With the experience, education, revenue, and engineering skills gained from this initial project in the Snowy Mountains would come the even greater project of water conservation all the way around our Australian Continent. It would be self-funding, and would provide employment for very many years to come, and as with much of Australia's infrastructure it would be proudly owned by the Australian people. Such was the ambition of visionaries with true ability, who's loyalty to Australia and their fellow countrymen were obviously paramount. Fortunately, at that time we had a Federal Labour Government in power who were of that same persuasion. The Labour Government was strongly opposed by the Menzies led Liberal Opposition in regard to this Project.

It should never be stolen away from those who paid for it and for whom it was constructed.

Over the past 20 or 30 years there have been many billions of Dollars of publicly owned assets stolen from the Australian people, and sold off at almost give away prices. We elect representatives into Parliament with the intent that they will Manage those assets to the best of their ability. For a manager to sell off assets which do not belong to them, does constitute THEFT for which they should be charged and sentenced. For a manager who cannot handle other people's assets, and it is obvious that they have no ability to do so, from this they should be quickly removed.
