the accident was the first truma and then we were tormented by allianz up to 4 years by naw so the targer is to week us to the point that we setel for the convenient of allianz or cumit suiside so allianz wont pay nothing

naw after 4 years allianz is responsible to the fact that I lost my wife i lost my children i lost my physical health i lost my mental health i lost my home —I am homless whoo lives in a garage ,living in night mares .drink in order to sleep and awake in order to drink ,things that I never knew before.

iv been left with out any means to see my psycatrist in order to take medications or see my gp in order to have further operations on my sholder.

Yes accidents do hapends and that's why we pay insurance—but in this case Allianz is directly responsible to the distruction of my family after the accident-alliance could save my family but chose to keep records profeets by avoidings doctors orders, by neglecting both injured parents wile there is no one to tace care of the baybys - and this is a crime—I cal for the allianz ceo to stand on trail.

Aliians made this year a billions of dollars record profeet on the expence of me on the expence of my wife, on the expence of my children on the expence of my home

From the ather side ther is the motor accident authority of nsw which was founded in order to reduce compensations by the 1999 act – so far among the 100% poor victims of car accidents whoo were assessed by this authority –only 2% were found aligible for compensation –how can an authority with such atatu avaluate us and the impact is bad

This is to certify that aged 40 yrs, was involved in an MVA on 8-10-2002. It is alleged that the patient hit him from behind and pushed his car into a parked truck.

He is suffering from Depression and Post Traumatic Stress Disorder. He is present under the care of , is on the Antidepressant Avanza and has had suicidal thoughts in the immediate past.

He and his wife were injured. In the accident he injured his left shoulder and foot. After his injury he had two operations on his left foot in

He has been left with a limp in the left leg. He was recently assessed by

who has advised him to wear special shoes.

He has left shoulder has been assessed by in Queensland and he has recently had two steroid injections into his left Shoulder. He still has pain every day in his left shoulder. who assessed his back, has recommended rehabilitation at a Sports Centre. So far this has not been approved.

He has attempted to find work on the Gold Coast and has been assessed by the Commonwealth Rehabilitation Service whom have advised him that he is unsuitable for any employment.

These traumas have created considerable stress on his marriage and driven the marriage to breakdown and he and his wife are now going through divorce proceedings.

As a result of this accident he feels mentally and physically damaged, and has led to the loss of his carer-wife, children and home.
