Dear Select Committee

Please find below, an email I sent to Ms Hodgkinson's office on learning about the closure of the Cronulla Fisheries Centre, together with her response.

I really would like the Committee to find what evidence she bases her argument about the centre having "limited access and constrained modernisation and expansion capacity"....?? Thank you for your recent correspondence in relation to the recent announcement by the NSW Government to decentralise services and facilities currently located at the Cronulla Fisheries Research Centre.

Over the next 12 to 18 months the NSW Government will decentralise the Cronulla Fisheries Research Centre to a number of locations along the NSW coastline - such as Port Stephens, Coffs Harbour and Nowra.

One of the many reasons why the Cronulla Fisheries Research Centre will be relocated is because the Cronulla site has limited access and constrained modernisation and expansion capacity.

Decentralisation of the Centre will also ensure there is greater interaction between fishers, scientists and fisheries managers. Excellent facilities are already in place at NSW Fisheries locations along the coast, including world-class research facilities and high-quality water at the Port Stephens centre.

As part of the NSW Government's 'Decade of Decentralisation' policy announced prior to the March election, we are determined to ensure regional NSW plays a bigger part than ever before in the future of this State. This initiative will be undertaken in a manner which meets the needs of all fishing stakeholders while also providing the socio-economic benefits to these regional centres.

The NSW Government intends to maintain the current level of services and research currently provided by the Cronulla Fisheries Research Centre. Indeed, the functions and services undertaken at the Cronulla site will be replicated at the regional locations.

Consistent with our commitment to ensure the current level of services enjoyed by fishers and the industry provided in the future, I am pleased to inform you that a number of options are available for employees who wish to relocate and entitlements are available under the Crown Employees Transferred Employees Compensation Award 2009. As management of the Cronulla Fisheries Research Centre work through the relocation project, regular communication will take place to keep employees informed.

The NSW Government has no plans to develop or sell the site and we encourage the local community to establish a working group to consider all options for the future use of the site, taking into account its historical and cultural significance.

Thank you again for taking the time to share your concerns with me. The NSW Government is determined to ensure that the relocation of the Cronulla Fisheries Research Centre is undertaken with the highest regard to the needs of its employees, their families and all fishing stakeholders.
