OUR DRUG DETECTING POLICIES HAVE IMPROVED BUT WE DO NEED SOMEONE LIKE DAVID LANDA TO OVERSEE OUR INDUSTRY AND OUR GREYHOUND RACING BOARD (NOT SOMEONE EMPLOYED BY THEM) BUT SOMEONE WHO HAS HIS OWN AUTHORITY TO ACT ON ANYTHING BOUGHT TO HIM BY PARTICIPANTS. I MENTION DAVID LANDA BECAUSE WHEN HE WAS APPOINTED AS OUR INTEGRITY OFFICER HE COULD HAVE BEEN AN ASSET TO OUR INDUSTRY IF INTEGRITY OFFICER HE COULD HAVE BEEN AN ASSET TO OUR INDUSTRY IF HE HAD'VE BEEN ALLOWED TO DO HIS JOB, BUT WAS HELD BACK BY GRNSW AND LEFT THE JOB IN DISGUST, THAT IS WHY WE SAY WE NEED SOMEONE NOT EMPLOYED OR APPOINTED BY GRNSW BUT SOMEONE WHO IS ALLOWED TO INVESTIGATE GRNSW THEMSELVES AND ALL MATTERS RELATING TO GREYHOUND RACING.

WE ARE NOT THE WEALTHY THOROUGHBRED OWNERS & TRAINERS WHO CAN PAY 100'S OF THOUSANDS FOR A HORSE. WE'RE MOSTLY WORKING PEOPLE WHO HAVE THE GREYHOUNDS FOR A HOBBY AND ONLY WANT A FAIR GO.
