Dear Madam,

I write re. proposed ETHIC CLASSES as a substitute for RELIGIOUS INSTRUCTION CLASSES in State Schools.

Australia Law was established from the traditions of English Law. (Gov.Philip/Macquarie etc) RELIGIOUS INSTRUCTION was recognised as an essential element in the WELL BEING of the Citizen in particular and the society as 'a whole'.

THE CHURCH played an important and significant role in the establishment of morals/ethics in maintaining a harmonious society in which peoples of different race, creed, and education could peacefully co-exist. Those who chose to step out of line deliberately or inadvertently were re-directed into the 'wise path'.

THE CHURCH & RELIGIOUS INSTRUCTION played a vital role in the promotion of this harmonious existence. THE CHURCH also gave service to HOSPITALS, ORPHANAGES, WELFARE etc. Their work was well respected and Government support readily given.

We now have more Gaols, Crime, Shootings, Suicides, Drunkeness, Drugs, Depression, and the need for more and more police, Women's Refuges, Youth Councillors/Workers --- a scary society.

Ethics classes may well be better than nothing – BUT – Nothing will replace the value of RELIGIOUS INSTRUCTION in our Homes, Schools, Churches. If everyone went back to church — Crime, Depression, Suicide, etc – I claim would halve over-night. Ethics without the power to adhere to them – will fail.
