I write to you in regard to Marriage, Marriage is a word that defines & identifies the type of couple. Let it remain so.

Marriage the unique relationship between a man and a woman. Married couples may in time produce offspring, and consequently form the Natural Family and the children are able to identify and know their mother and father.

Removing disadvantage against samesex couples is exactly what the Federal Parliament achieved in 2008. Over 80 pieces of legislation were amended with bipartisan support, which removed disadvantage on practical matters like superannuation and next-of-kin status.

Where samesex marriage has been legalized freedom of speech and freedom of religion have been suppressed. Because the revision of marriage is done in the name of equality, disagreeing with the states new definition is seen as perpetuating inequality against a minority group.
