Inquiry into Community Based Sentencing Options for Rural and Remote Areas and Special Need/Disadvantaged Populations

The following comments are made for consideration by the Inquiry:

- community based sentencing options are considered to be "lighter" forms of punishment than imprisonment.
- for community based sentencing or other punishment options to be effective, there are three key factors; these factors are having definitive rules/criteria in relation to same, the consistent application of the sentencing and the "system" of having the capacity or resources to apply the "rules".
- applying various options to different areas/location can create other issues. In this respect, offenders can relocate to more comfortable areas etc.
- regardless of the above, the pursual of community based sentencing options should be pursued as it is likely to produce more achievable results/outcomes and can be managed on a more cost effective basis.
