I HAVE BEEN TOLD SHE IS IN THE "GREY" AREA AND NOT A PRIORITY. SHE CANNOT GET THE SCHOOL SPECIAL TRANSPORT AS IT IS A TERTIARY COURSE AND NOT AT THE HIGH SCHOOL. I WAS TOLD I WOULD HAVE TO GET HER THERE LIKE EVERYONE ELSE. WELL EVERYONE ELSE AT 18YO FOR THE MOST PART IS DRIVING THEMSELVES AROUND. THERE IS NO PUBLIC TRANSPORT AT ALL TO KURRI KURRI TAFE AND THIS IS THE ONLY TAFE THAT OFFERS THE COURSE IN FLORISTRY. IT IS AMAZING THAT SHE HAS A PLAN FOR HER FUTURE AND WANTS TO SEE IT THROUGH. ASHLIEGH HAS BEEN DOING WORK EXPERIENCE IN THIS FEILD ONE DAY A WEEK FOR 5 MONTHS AND PLANS TO HAVE HER OWN SHOP ONE DAY, WHY SHOULD SHE BE DENIED ACCESS BECAUSE SHE IS SUPPOSED NOT OLD ENOUGH OR FRAIL ENOUGH. SHE IS STILL DISABLED. I WOULD DRIVE HER MYSELF IF I WAS NOT WORKING FULL TIME AND ON SHIFT WORK.
