# SUPPLEMENTARY SUBMISSION TO THE NSW PARLIAMENTARY INQUIRY INTO PRISON PRIVATISATION. 20/3/09

Community Against Privatisation (CAP) is a non political community group based in Cessnock whose aims are to bring to the attention of the public the issues surrounding the privatisation of Prisons in NSW.

We propose to give verbal evidence of the following;

- The builying and harassment we believe is being inflicted on the families of prison officers in Cessnock.
- Our belief that Cessnock Gaol has become an unsafe workplace as a result of the Department of Corrective Services disregard for its own policies regarding bullying and harassment.
- Cessnock has the highest unemployment rate and lowest household income of all Local Government areas in the Lower Hunter. 83 job losses have already been announced from the Bonds factory, we have lost jobs from the Health Service Laundry Division at Allandale and Kurri Hospital is under threat. The loss of further jobs as a result of prison privatization will do more harm in Cessnock than in other urban areas of NSW.

In addition to the above information regarding harassment, we further believe that the action in the past week of removing 107 prisoners late at night;

- transferring the prisoners without notice caused stress and alarm and one prisoner was hospitalized with a suspected heart attack.
- by transferring the prisoners when there was a single nurse on duty at 4am in Windsor and there was some confusion whether all medical records were transferred with them (Department policy requires all medical records to be transferred with prisoners at time of transfer) placed the prisoners and staff at risk.
- without giving the prisoners the dignity of 24 hours notice to notify their families (also required by the Departments own policies)

without transferring their personal possessions (also against Department policy)

.....means that the NSW Department of Corrective Services are prepared to use prisoners and staff as footballs in a game of politics.

CAP no longer has any confidence in the Department of Corrective Services' ability to manage prisons in NSW, or to competently inform the Parliament and public of NSW of how prisons are being managed in NSW.

As there is very little information on the public record regarding private prisons and their safety CAP have no confidence in the ability of the Department to make appropriate and mature judgments regarding their introduction and expansion in NSW.
