Thankyou for the opportunity of making a submission to this inquiry.

In brief I believe that political donations inevitably create a sense of obligation to the donor by the recipient.

I wish to briefly out line for the Inquiry my experience as a Councillor in Cessnock;

- In Cessnock the ALP Councillors use of the 'State Electoral Committee' to make a donation of \$25,000 to their campaign effectively masked the identity of the original donors of that \$25,000 to their 2004 Local Government campaign.
- Probably by mistake, but happily for the public, the Secretary of the Cessnock SEC listed the donors of the \$25,000 in a third party return to the SEO.
- By chance I was able to view that documentation at the SEO and subsequently ask
 questions in Council as to why the ALP Councillors were not declaring non-pecuniary
 conflicts of interest when voting on certain matters.
- The Cessnock ALP Councillors have refused to acknowledge they know anything about the donations or that they have any responsibility to make declarations regarding these donations.
- I referred this to the Geneal Manager as breach of the Local Government Code of Conduct. After 5 months of doing nothing the Cessnock General Manager refused to take any action via the Code (even though the Code says perceived conflicts must be treated as importantly as real conflicts).

- I have referred the issue to the Ombudsman who has in turn referred the matter to the Department of Local Government in November 2007.
- The Department of Local Government has not contacted me.

I have to conclude;

- a) that the NSW laws regarding declarations of campaign donations are not effective in ensuring the identity of donors is declared, and
- b) that the current Code of Conduct for Councillors in NSW is not being enforced or observed and Councillors are regularly voting on matters without making a transparent declaration regarding campaign donations received, and
- c) that the NSW Government has no real motivation to ensure campaign donations are declared in a way which ensures they are public knowledge BEFORE an election and BEFORE Councillors vote on certain matters.
- d) Reform of the campaign donations system will not be effective while ever the donations can be masked by or channeled through another entity such as a SEC or any other body. If campaign donations are to remain legal they should only be acceptable from the primary donor.
- e) If donations are to remain legal then the Name, telephone number, physical address and occupation/s of the donor need to be publicly available. In Cessnock individuals with PO Box addresses in Melbourne and Sydney made donations. This simply arouses suspicion as to who these people are and what is their interest in Cessnock.

I have attached further material below to illustrate the above conclusion.

ISSUE: Cessnock Councillors voting to rezone land for high fee charging private school associated with ABC Learning (the land was previously meant for community use) without declaring donations from people associated with the property development company (HEZ P/L). The land is so severely undermined that consultants warned that public safety in the schoolyard needed to be considered.

- Please find attached a copy of the Cessnock ALP Councillors primary electoral return which shows a lump sum donation of \$25,000 for the SEC in a total of approx. \$27,000.
- My understanding is that the NSW Electoral laws allow a donation from an SEC without disclosing the original donors. This is clearly flawed system. The Third Party return from Cessnock SEC Secretary Karen Jurd was probably, in my opinion, a mistake. My understanding is the great majority of donations from SECs do not detail who made donations to the SEC in the first place.
- The third Party Declaration was only available to me because I visited the SEO office and asked to see the file. That is not something the average resident of Cessnock would have time or knowledge to do.
- As can be seen the names on the third Party Return include Richard Ash and Max Mahwinney.
- Richard Ash is described in a Westpac Media Release as *Westpac Institutional Bank Joint Head of Property* and gave his address on the declaration as 255 Elizabeth St Sydney, the address of the property section of Westpac. Westpac is described as an equity partner in the HEZ by the HEZ P/L webpage.
- Max Mawhinney is described on the Valad ASX statement regarding their investment in HEZ as being *Executive Director at Valad*.
- Both of these individuals have confirmed their donations to the Sydney Morning Herald.

The above is a concrete example of people associated with property development making donations to an ALP State Electoral Committee for the purpose of donating to the Councillors election campaign. If it weren't for a 'mistake' by the SEC Secretary this information would still not be known to the public with the result being secrecy and a lack of transparency regarding campaign donations to local Councillors.

Land rezoned, but developers' gift was not declared

NONE of the Labor councillors on Cessnock City Council who voted in favour of rezoning land for a private school associated with ABC Learning Centres declared donations from two men linked to the development.

Last month the councils eight Labor councillors, including the mayor, voted in favour of rezoning community land to allow for a private school to be built in nearby Kurri Kurri.

independent Colleges Australia, cressed by ABC Learning, wants to build a kindergarten, primary and secondary school in the Hunter Economic Zone, a 3200-hectare business estate.

Donations of \$2000 each were made to the Cessnock ALP council election campaign in 2004 by executives of the economic zone's manager and Westpac Institutional Bank, an investor in the estate.

During a council debate on June 21, the Greens councillor, Jumes Byan, asked the Labor mayor, John Clarence, whether he would declare \$4000 donated to the council's Labor candidates as a non-pecuniaryinterest donation.

Cr Clarence said he and his

fellow ALP council members were not aware that they had received those donations. When asked a week later, Cr Clarence told the Herald he still knew nothing about the donations

Asked whether he would declare a non-pecuniary interest if he was to become aware he received one, Cr Clarence said it was "a matter for the individual".

The donations appear on a third-party declaration lodged with the State Electoral Office by the ALP-aligned council secretary and election candidate, Karen Jurd, in November 2004.

A Westpac Institutional Bank executive, Richard Ash, donated \$2000 to the Labor councillors, as did Max Mawhinney, when he was the executive director of the Valad Property Group, the manager of the economic zone.

Cr Ryan said no ALP councillor had declared a nonpecuniary interest in the proposal. He said that even though the council's eight Labor councillors, including the mayor, would not receive a direct financial benefit from the development, they should declare a non-financial interest.

"I am concerned that during the meeting the ALP councilloss may not have declared all the donations, which could be perceived by the public as having a connection with the [development] company," he said.

"Our code of conduct is clear that perceptions of conflict of interest are as important as actual conflict of interest."

Mr Mawhinney said he had resigned as executive director at the Valad Property Group last September but remained a parttime consultant and a director of some of its development funds.

"My reasons for donating money to the Labor Party had nothing to do with HaZ. It was for personal reasons," he said. "Valad didn't take an interest in the project until well after the donation was made."

Mr Ash said his donation was made for personal reasons and had nothing to do with the bank.

Cr Alison Davey, an independent, declared a non-pecuniary interest of \$250 for her election campaign. Cr Ian Olsen, another independent, declared a similar amount, saying the funds were donated by the economic zone.

The Local Government Minister, Kerry Hickey, who is also the MP for Cessnock, said it was up to individual councillors to declare a pecuniary or non-pecuniary interest, in line with guidelines issued this month.
